

# **MINUTES OF THE CRANBURY TOWNSHIP BOARD OF HEALTH MEETING**

**March 7, 2022**

## **TIME AND PLACE OF MEETING**

The regular meeting of the Board of Health of the Township of Cranbury was held on March 7, 2022 at 7:00 pm by remote access videoconferencing in response to COVID-19 and the updated Open Public Meeting Act guidelines.

With a quorum present, Dr. Laura Zurfluh called the meeting to order at 7:00 p.m., and Jean Golisano acted as Recording Secretary of the meeting and announced the meeting was being recorded.

Ms. Kathy Easton, Chair of the Shade Tree Commission, will present "The Benefits of Trees" at the April 20<sup>th</sup> session.

Cranbury Township's 325<sup>th</sup> Anniversary – To celebrate the Township's 325<sup>th</sup> Anniversary, the Wellness Campaign Team is planning a presentation on the History of Farming in Cranbury. Mr. McDermott offered to contact Mr. Monty Hagerty, a long-time resident and farmer, to participate in the presentation.

September Rabies Clinic – Ms. Golisano asked for a date for the September Rabies Clinic. Members agreed on September 17<sup>th</sup> or 24<sup>th</sup>. Ms. Golisano will check on availability of Fire House and Mr. Jerry Thorne before submitting the date to Ms. Bujalski for coordination with the County.
