#### **HEALTH OFFICER'S REPORT:** Health Official Natalie Bujalski reported the following for July:

- The Hampton Inn in Cranbury was a reinspection and they were rated satisfactory
- Disregard the Icon at Riverwalk it's located in Plainsboro. Will send the corrected report
- The Recreational Bathing Facility that was unsatisfactory is Staybridge Suites (will remain unopen for 2022)
- Love Your Dog Daycare was inspected and rated conditionally satisfactory
- 6 Ryan Road Abatement check has since been corrected (cut overgrown vegetation and grass)
- 11 Griggs Road Abated (high grass and trash)

Health Official Natalie Bujalski stated that they needed a bonding and grounding certificate and an annual electrical inspection. certificate (expired) is not up to date. They cannot open without electrical approval.

Chair - Laura Zurfluh asked Health Official Natalie Bujalski about Love Your Dog rating.

Health Official Natalie Bujalski stated that they were on a conditionally satisfactory due to the owner needing to replace furniture for proper cleaning.

Health Official Natalie Bujalski reported the following for August:

- Cranbury Senior Center, First Presbyterian Church and First Presbyterian Nursery were all rated satisfactory
- The Four Seasons at Historic Cranbury main pool and spa were rated conditionally satisfactory
- 11 Griggs Road high grass complaint has been abated
- 37 North Main Street had high grass and vegetation sent them a notice of violation and followed up with them. They cut the front but there's still overgrown vegetation on the sides – second violation was sent
- Cranbury Inn currently doing renovations did a walk through with them. Their plans were approved and sent to the appropriate parties
