

**MINUTES OF THE
CRANBURY TOWNSHIP
BOARD OF HEALTH MEETING**

March 6, 2023

TIME AND PLACE OF MEETING

The regular meeting of the Board of Health of the Township of Cranbury was held on March 6, 2023 at 7:00PM in the Town Hall, 23-A North Main Street, Cranbury, New Jersey.

CALL TO ORDER

With a quorum present, Dr. Laura Zurfluh called the meeting to order at 7:00PM. Mary Anne Brown acted as Recording Secretary and announced the meeting was being recorded.
