**TIME AND PLACE OF MEETING**

A special meeting of the Cranbury Township Shade Tree Commission was held in Town Hall, 23A North Main Street, Cranbury, NJ on January 24, 2019 at 9:30 a.m.

Street Trees Species Discussion – Ms. Johnson presented a comprehensive list of species which was discussed and distilled down to a final list of five species for Four Seasons street tree plantings, and a second list of trees to keep or add to the Recommended Species Exhibit Lists.

Vegetative Management Response Act (S2505/A2558) – Supporting material from the NJ Shade Tree Federation and Princeton's mayor and Princeton's Shade Tree Commission in opposition to the bill was reviewed. It was suggested that members of Cranbury's STC contact Senator Greenstein's office to register comments. Ms. Easton will write to the Mayor and STC liaison, Michael Ferrante, to encourage them to resolve to send a letter to Sen. Greenstein opposing the bill before the next Senate session.
