Mr. Ferrante reported on Boy Scout Troop 52 having over half of its scouts as "Life Scouts", which is the step before Eagle Scout.

Mr. Ferrante advised that he attended the Municipal Alliance meeting, Board of Health and Shade Tree Commission. He read a paragraph from a letter drafted from the Township Committee to Senator Linda Greenstein regarding the opposition of "Vegetation Management Response Act".

Mr. Ferrante reminded the public that at the February 11th Township Committee he will be presenting on "De-mystifying Municipal Government". He requested time at that meeting for additional questions from the residents, if necessary. Mayor Taylor agreed to allot ten minutes for the presentation questions and any residents with additional questions to stay after the meeting for time to receive answers.

He also met with the Communications Subcommittee on January 25th. Suggestions for future were opening township Twitter account, an insert newsletter to be sent twice a year and a future in sustainable electronic presence.

Mr. Johnson attended the School Board meeting, Personnel subcommittee meeting and Development Review Committee. He added that Cranbury representative to the school board, Evelyn Spann, was appointed to the Princeton school committee. She is the first Cranbury representative on the Princeton committee.

Mayor Taylor reported that he attended the Historic Preservation Committee, Environmental Commission, Recreation Board and Municipal Alliance meetings.

On January 26th the Chief of Police and the Mayor attended the first "Coffee with Mayor and Chief of Police" which was well received.

He discussed upcoming meetings for the Master Plan subcommittee and the township budget. He added that he would be meeting with the Cranbury Press on January 30th to discuss how to rejuvenate resident interest in printed articles.

Mayor Taylor reported that the township received 311 OPRA's (Open Public Records Act) in 2018 and 33 for year to date in 2019. He explained the process on receipt and how many are not charged a fee due to the use of electronic medium. He presented one recent OPRA along with the large amount of time and supplies that were utilized and no fee could be charged. It is a big issue for the township.

--Departments Heads –

Michael Kervan, Chief, Fire Department, gave the 2018 call report along with 2019 year to date for both the Fire Department and the First Aid Squad. He discussed the arrival time for calls is still under the State average.

Bonnie Larson, Chairperson Cable Commission – Advised that there will be negotiations with Comcast this year. A survey was prepared for residents to complete that would be used in the

**TOWNSHIP OF CRANBURY
ORDINANCE NO. 01-19-04
CALENDAR YEAR 2019
AN ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO
ESTABLISH A CAP BANK
(N.J.S.A. 40A: 4-45.14)**

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the governing body of the Township of Cranbury in the County of Middlesex finds it advisable and necessary to increase its CY 2019 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the governing body hereby determines that a 1% increase in the budget for said year, amounting to \$73,922.69 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the governing body hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the governing body of the Township of Cranbury, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2019 budget year, the final appropriations of the Township of Cranbury shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$258,729.43, and that the CY 2019 municipal budget for the Township of Cranbury be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

RESOLUTION AWARDDING FARM SERVICES AGREEMENT
FOR THE FROSZTEGA AGRICULTURAL LOT**

WHEREAS, the Township of Cranbury in the County of Middlesex, State of New Jersey accepted the dedication of a ± 31.25-acre parcel designated as Block 25, Lot 60.01 on the Cranbury Township Tax Map and known as the “Frosztega Farm” (“the Property”); and

WHEREAS, the Township seeks to procure services that will enable the Township to maintain the farmed portions of this property as productive agricultural land; and

WHEREAS, Michael Protinick of Protinick Farms has farmed the property in the past and the Township seeks to retain his farming services; and

WHEREAS, the Township seeks to compensate Mr. Protinick for his services in kind by allowing him to retain any profit realized from the sale of his crops, the value of which will not exceed \$36,000.00 per year; and

WHEREAS, because this contract amount does not exceed the bid threshold, this contract award is exempt from public bidding pursuant to N.J.S.A. 40A:11-3a. and 40A:11-6.1a; and

WHEREAS, the Township has not solicited other quotes for the provision of these services because it was not practicable to do so;

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Cranbury, in the County of Middlesex, as follows:

1. The Mayor and Clerk are hereby authorized and directed to execute an agreement with Michael Protinick of Protinick Farms for the provision of farming services to the Township at Block 25, Lot 60.01 on the Cranbury Township Tax Map and known as the “Frosztega Farm” the form and substance of which shall have previously been approved by the Township Attorney.

Public Comment -

Mayor Taylor opened the meeting to public comment.

Deanne Napurano asked the committee to follow through regarding the Master Plan process to begin it earlier than 2020, especially the light industrial zone area of the plan. She expressed the willingness of many members in the community to participate and assist in the process.

Connie Bauder requested information on the status of drainage improvement and paving of Petty Road. She expressed the immediate need for repairs to the shoulder of the road. She also requested that Plainsboro Township be notified to not detour traffic onto Petty Road from Dey Road. It creates a traffic problem with the added vehicles causing ruts in the roadway to get worse. Ms. Marabello to contact the Chief of Plainsboro to discuss future detour plans to not include Petty Road. She also suggested that a professional company come in to fill the potholes until a better permanent solution can be made. Lastly, she added that the township needs to create an ordinance for sump pumps and not allowing them to discharge into the roadways. She believes this practice is significantly affecting the decline of Petty Road. She asked to be updated on the plans for paving in the future and asked that it be reflected in the budget.

Shasha Weinstein requested a traffic study of Shady Brook Lane to decrease the speed from 45 mph to 25 mph. She stated that many residents in the area want a traffic study in conjunction with Plainsboro Township to have the speed limit lowered. Ms. Marabello advised that it is a County road. Mr. Ferrante and Mr. Scott stated this road will be placed on the Traffic Subcommittee agenda for upcoming meeting and that she will be updated on the progress.

Janice Mondoker discussed the truck parking along roadways and asked for a solution. Due to the area in question being private property, it was suggested to have the owner block the area with cones, chains, etc. to stop the parking on their private property. He appreciates the continued discussion on the topic and is happy the Master Plan is being revisited.

Claudette Guy asked if the new officers were now scheduled to patrol. She was advised that they are on staggering shifts. The Traffic Bureau will be in effect during the work week with regular patrol on the weekends.

Nick Moroldo discussed difference between Fulfillment Centers vs. warehouses. He asked if they were being discussed separately. Mayor Taylor advised the description will be discussed during Master Plan review.

Mayor Taylor closed the meeting to public comment.

Mayor Taylor requested a motion to adjourn. On motion by Mr. Johnson, seconded by Mr. Ferrante and unanimously carried, the meeting adjourned at 8:35 p.m.
