WHEREAS, the Township has determined that it will be necessary to obtain an appraisal and survey of the subject easement areas in order to offer a fair market value for the easements; and

WHEREAS, the Township is authorized to retain professionals to provide appraisal and surveying services without public advertising for bids pursuant to the Local Public Contracts Law, *N.J.S.A. 40A:11-1 et. seq.* because the aforesaid services are professional in nature; and

WHEREAS, the Local Public Contracts Law requires a resolution authorizing the award of contract for the services without competitive bidding to be publicly advertised; and

WHEREAS, the professional services agreements attached hereto appropriately set forth the obligation of the parties with respect to such services;

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Cranbury as follows:

- 1. The Township Committee authorizes the Mayor and Clerk to execute an agreement with Martin Appraisal to provide an appraisal regarding the fair market value of the aforementioned easements; said agreement to run through December 31, 2016.
