Mr. Cook stated he has been in the Town since 1966 and acknowledged Mr. Moskowitz played a large part in protecting Cranbury from development similar to what was happening in Plainsboro. He thanked Mr. Moskowitz for helping to create Cranbury as an oasis in the County as well as in the State of New Jersey.

Mr. Mulligan stated he has heard Mr. Moskowitz's name many time over years and stated he, as well as others in the room, are responsible for maintaining Cranbury as it is today.

Mr. Taylor stated he is raising a fourth generation to live in Cranbury, and thankfully because of the efforts of Mr. Moskowitz and the Planning Board, his children will see a Town similar to one that his grandparents lived in.

Mr. Johnson stated he served on both the Zoning Board and the Planning Board. He stated Mr. Moskowitz's efforts have had such a far-reaching positive effect on the development of the Town.

Mayor Goetz asked if the public wanted to add any comments. Mr. Tom Harvey stated he was on the Planning Board before Mr. Moskowitz came, and he had very strong opinions on planners and planning. However, Mr. Moskowitz brought a level of sophistication, intelligence and creativity to planning 25 years ago, a critical time when towns were changing. It was a time of

Community Development Block Grant

Mayor Goetz officially opened the Public Hearing on the Community Development Block Grant at 7:30 p.m. Ms. Cunningham announced, for the record, that this meeting was advertised in the Cranbury Press, posted in the Senior Room at Town Hall, posted on the Township's website, posted on the bulletin board, and was posted at the Senior Housing.

Mayor Goetz stated this is a Public Hearing on approximately \$22,737 of 2014 Community Development Block Grant funds to be used to assist in the development of or rehabilitation of low-to-moderate income housing in the Township of Cranbury.

Mr. Mark Berkowsky, President of Cranbury Housing Associates, gave a presentation on the Grant. He stated the Township Committee appointed Cranbury Housing Associates as the administrator of affordable housing again this year. He stated CHA has been the administrator for affordable housing for over 20 years. Mr. Berkowsky stated for the last few years the CDBG funds have been used for the establishment of the next project to be built, the Route 130-D site. Most of those funds were applied towards engineering services. He stated this year CHA thought they would apply the funds to rehab some of the older units, including new HVAC systems. Mr. Berkowsky provided information on the work to be done on specific units and stated the information to be submitted should include the wording "replacing obsolete HVAC equipment with new energy efficient performing systems that are energy store qualified." He stated the replacement of the older units will save residents energy costs, reduce repair expenses. Mr. Berkowsky stated, if the Township Committee agrees, the information will be sent to the County for approval and the funding starts on July 1, 2014.

Mayor Goetz opened the Hearing for public comment, and hearing, none, closed the public comment portion and then closed the Public Hearing at 7:35 p.m.

Concerning the Bridge/Dam Project, Mr. Cook reported due to weather conditions a lot more water has been added to the Lake bed, which the contractor has had to deal with. He reported additional sheathing had to be added, which did cause some issues with vibrations. He stated the weather and water has slowed down the progress. Mr. Cook stated the anticipated completion date is August.

Mr. Mulligan reported quotes for the baseball field repairs are being received. He stated the quotes fall in the \$5,000 to \$8,000 range. He reported he has received many positive comments from the decisions made at the Budget Meeting on Saturday, including keeping the police force at the same level.

Mr. Johnson reported he attended a Zoning subcommittee meeting to address a number of planning and zoning procedural issues.
