## Reports and Communications

#### --Mayor

Mayor Goetz reported the Memorial Day Parade was great. She stated the "Downtown Beautification Project" is now complete, although there are some punch list items that still need to be addressed. Mayor Goetz reported another Downtown Grant has been received, and discussions will be underway to determine how the Phase III monies will be used.

Mayor Goetz and Ms. Marabello met with the consultant hired to look at the dredging of Brainerd Lake. Samplings were taken from the Lake, and the consultant's report was optimistic. Mayor Goetz stated the dredged materials will not be clean enough to be spread out on farmland or in parks. The consultant will come back with some recommendations and pricing for three (3) options: removing the material out of Cranbury, the material staying in Cranbury, or the price in five (5) or ten (10) years of not doing anything at all now. Mayor Goetz stated there is a possible site in Cranbury; however, the material will need to be "de-watered," which means the materials would first be spread out to dry.

Mayor Goetz reported a letter was received from a Monroe resident who is concerned about a serious pothole on Wycoffs Mill and Brickyard Roads. Ms. Marabello will follow up on the pothole.

#### --Township Committee

On the Brainerd Lake Dam and Bridge Project, Mr. Cook reported work has continued after the Change Order for the additional work (large cavity discovered under the spillway and Bridge) was approved by the County Freeholders. Mr. Cook stated the cavity was estimated to be 70 cubic yards; however, the cavity was actually 56 cubic yards and has been filled. Mr. Cook stated the spillway has been graded and stoned. Rebar and internal aspects of the spillway are being installed so the actual spillway and dam can be poured.

After finding this one cavity, Mayor Goetz asked how we know there are not others? Mr. Cook stated the area was inspected and additional probes were used to determine there were no other significant cavities.

Mr. Cook stated the Township is looking for a new vendor for the railing. The specifications for the railing are what have already been approved. He stated on Friday night there was a small fuel spill, and

he and Fire Chief Michael Kervan waited for the Middlesex Hazmat Team to arrive. A clean up company came and contained and cleaned up the spill. Mr. Cook reported the veneering of the east and west sides of the Dam will begin this Thursday.

Mr. Mulligan reported the Parks Commission and Recreation Board will work together to acknowledge the 50<sup>th</sup> Anniversary of Village Park during the July 5<sup>th</sup> fireworks. Mr. Mulligan asked that a Resolution be done to commemorate the Anniversary and that the Mayor and/or Township Committee members be present to acknowledge the event.

Mr. Mulligan inquired if the Department of Public Works was able to work on the flag pole. Ms. Marabello stated Public Works has been focusing on getting the Town ready for the Parade. Mr. Mulligan stated Public Works believes they can do the work themselves since no lead paint is involved. Ms. Cunningham, Clerk, was able to obtain an American flag from Congressman Rush Holt, which will be flown over the Capitol and then presented to Cranbury Township

Mr. Mulligan stated a North Main Street resident approached him about lowering the speed limit on North Main Street. Mr. Mulligan stated he is in favor of pursuing the lower speed limit. Mr. Taylor stated the lower speed limit was suggested years ago; however, cars come off Route 130 at 55 mph, and a gradual reduction of speed to 40 mph is necessary before the speed is further reduced to 25 mph. Mr. Taylor suggested asking Chief Rickey Varga before approaching the County.

On the "Safe Routes to School" Project, Mr. Mulligan stated there is a lot of bureaucracy involved with the paperwork, and asked Ms. Marabello to provide additional information. Ms. Marabello stated the Project will not happen this summer due to the additional requirements. Concerning the additional Township parking spaces in the Witt's parking lot, Ms. Marabello stated work has begun on the Island and parking should be available in two (2) weeks. Ms. Marabello stated Ms. Nancy Witt will contact her concerning the posting of signs and the actual opening date.

Mr. Mulligan provided an update on the Public Works budget, stating everything looks fine and there were no extreme repairs incurred.

Mr. Taylor stated he walked South Main Street with a representative from Van Cleef Engineering to look at the curbs damaged by the last County repaving project. Mr. Taylor stated he walked with Township Engineer, Bill Tanner, last year to look at the same curbs, and he asked Ms. Marabello if Mr. Tanner was paid last year, and did not to pay the firm again for the same inspection this year. Mr. Taylor stated the longer it takes the County to repair the roads, the less accountable they become. Ms. Marabello stated the County told Mr. Tanner they would come to repair some of the curbs when they are doing other work in the area. Mr. Cook stated Mr. Tanner is working with the County to get dates when they County plans to do projects in the Township. Mayor Goetz stated the Township needs a commitment from the County. She stated suggestions were made that the Beautification Grant be used for curb repairs; however, unfortunately the Grant specifies the funds be restricted to the commercial district.

Mr. Johnson reported he attended a Library Facilities meeting, where the focus of the meeting was on the specifics of the interior of the new Library. The outside of the building has not yet been designed; however, Mr. Johnson stated the architect understands the building facade will need to "fit" in the Township.

Photocopies of records: The charge will be the prescribed State charge for copies (Under the Open Public Records Access Statute). For any records maintained at the Township's off-site archival vendor, there will be a per carton charge to the requestor for said carton. This fee will be based on the prevailing fees charged to the Township by the off-site archival vendor at the time of the request. This fee schedule will be maintained by the Municipal Clerk's Main Office and shall be on file at all times.

## Chapter 113. PEDDLING AND SOLICITING FEES

#### § 113.5 Fees

- A. Registration fee. At the time the application is filed, a [fee of \$75] <u>\$75 money order</u> shall be paid to the Township Clerk to cover the cost of processing the application and investigating the facts stated therein.
- B. [Two money orders or certified checks must accompany the application form. One should be made out to New Jersey State Police, SBI, in the amount of \$18, and the other to Cranbury Township in the amount of \$57.] No registration or license fee shall be required from any charitable or religious organization exempt from the payment of taxes under the regulations of the Internal Revenue Service.

Ms. Marabello stated she had nothing to report.

--Assistant Administrator's Report

Ms. Cunningham reported Election apps are now on line, which give access to links for information on elections, printing out forms, and locations of polling sites. Ms. Cunningham stated next Tuesday, June 3<sup>rd</sup>, is Election Day. District 1 will vote in the Boy Scout Room and Districts 2 and 3 will vote in the Senior Center. The polls will be open from 6:00 a.m. to 8:00 p.m.

Mr. Taylor stated he wanted to congratulate Mayor Goetz on a wonderful speech on Memorial Day. Mayor Goetz stated it is a huge honor to give that speech.

#### **Public Comment**

The Mayor opened the meeting to public questions and comments. Mr. Gerry Ricciardi, Jersey Central Power & Light, stated he is a resource for the Township. He stated even though JCP&L services only 242 meters in Cranbury, the Township is still important to them. He stated JCP&L is doing infrastructure projects (not necessarily in the Township) that directly improve the benefits to the Township. Mr. Ricciardi stated JCP&L is building a new transmission line down Route 33 into the substation in Hightstown. He reported that new line will free up other lines to provide power to satisfy the ever-increasing demand for electricity. There was discussion about rights-of-way and the progress of their project. Mr. Ricciardi stated this project goes through three (3) counties: Monmouth, Middlesex, and Mercer. He told the Township Committee to contact him anytime there is an outage. He recommended the Township use their website as a source of information. JCP&L will continue to send updates whenever necessary. Mayor Goetz thanked Mr. Ricciardi for coming to the meeting.

Mr. James Fahey, Station Road, commended the Township Committee and all involved on the "Downtown Beautification Project." He stated the Project looks great and is a big improvement. He stated Cranbury is a "quality of life town." However, he is concerned about the old trees and the new trees growing into the wires in 10 to 15 years. Mayor Goetz stated the Subcommittee worked very closely with the Shade Tree Commission, and the trees selected are designed to grow under the wires. Mr. Fahey advocated removing the poles and wires. Mayor Goetz stated there was discussion about removing the poles; however the cost was prohibitive and the Grant is designated for sidewalks. There was additional discussion about the safety, cost savings and aesthetics of not having poles.

## Public Comment (Continued)

Mr. Mulligan stated he supports the idea of removing the poles; however the Township has to look at the bigger picture of finances for such items as open space, dredging of the Lake and affordable housing. Mr. Fahey agreed stating all of those items preserve the character of Cranbury, and removing the poles would not only preserve but also improve the Township.

Mr. Richard Kallan, Wynnewood Drive, stated 45 years ago when he moved to Wynnewood, it would have cost \$3,000 per house to put the wires underground. Mr. Kallan stated it is unrealistic financially for the Township to remove the poles.

Mayor Goetz stated the Township Committee is in agreement the Township would look better without poles and wires; however, nothing can be done without additional outside funding. The Committee agreed if funding becomes available, the Township will pursue it.

There being no further comments, the Mayor closed the public portion of the meeting.

#### Mayor's Notes

Mayor Goetz suggested another Special Meeting be scheduled since the discussion in tonight's Closed Session was not completed. It was decided the Special Meeting would be held on Monday, June 2<sup>nd</sup> at 7:00 p.m. in the Town Hall Meeting Room.

Mayor Goetz reported she and Chief Varga will be holding another "Coffee at Teddy's" on Saturday, May 31<sup>st</sup> from 7:00 to 9:00 a.m. She invited residents to come ask questions or discuss their concerns. The information will be posted on the Township's website and on Channel 3. Mayor Goetz stated since the Chief will not be available, she will alternate other Township officials to sit with her during the summer.

Mr. Mulligan referred back to the upcoming Special Meeting, and asked if any professionals needed to attend. It was suggested the Township Attorney attend; however, Mr. Cook stated it would be helpful having someone attend who has experience with these types of transactions.

Mr. Taylor stated he would like Ms. Marybeth Lonergan come in to update the Township Committee on COAH. Ms. Marabello stated Ms. Lonergan will discuss COAH as a Work Session item at the June 23<sup>rd</sup> meeting.

On a motion by Mr. Johnson, seconded by Mr. Taylor and unanimously carried, the meeting adjourned at 8:15 p.m.
