The regular meeting of the Township Committee of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: David Cook, Susan Goetz, Daniel Mulligan, Jay Taylor and Mayor Glenn Johnson. Also present were Denise Marabello, Township Administrator/Director of Finance and Kathleen Cunningham, Municipal Clerk/Assistant Administrator. Mayor Johnson led in the salute to the flag, and Ms. Cunningham gave the following Open Public Meetings Act statement:

On motion by Mr. Taylor, seconded by Ms. Goetz, and unanimously carried, the Regular Township Committee Minutes of November 12, 2013 were adopted.

Reports and Communications

--Mavor

Mayor Johnson reported since the last meeting he attended two (2) ribbon cutting ceremonies, met with a couple of members of the Fire Company, and attended a DRC meeting. He reported a resident contacted him alerting the Lake bottom was very muddy, making it easy for someone to get stuck. He stated a notice was posted on the website and cautioned residents not to go near the mud.

-- Township Committee

Mr. Mulligan stated he had nothing to report.

Mr. Cook reported on the progress of the Brainerd Lake/Bridge Project. He stated the trees have been removed and the "concrete beach" on the creek side has also been removed. He stated weekly meetings are held to report on the project status, and reported the contractor felt the 300-day schedule was appropriate. Mr. Cook stated the meetings will follow four (4) key points: project schedules; pile driving, which began today; vibration monitoring; scheduling for the sheathing, one (1) week for the creek side and two (2) weeks for the Lake side). Mr. Cook reported there are no change orders, i.e., no modifications or changes are necessary at this point which could ultimately affect the cost of the project. He stated the existing utility poles will be removed by the contractor and PSE&G will later install new ones. Mr. Cook stated the railing will be custom built and will be a replication of the current railing. Weekly updates on the project will be posted on the Township's website.

Mr. Cook reported there had been discussion about whether or not trees could be planted along the Lake. He reported some months ago the Township received an initial "yes" that trees could be planted, and stated that today approval to plant trees was received from Mr. Darren Schaeffer of the DEP. There are, however, restrictions on the type and height of tree and non-

invasive root system that will be permitted, and Mr. Cook stated a memo outlining the Township's tree selection will be presented to Mr. Schaeffer for sign-off.

Ms. Goetz reported the Environmental Commission has been working very hard on the Reinhardt property completing a mark out and clearing of a trail around the perimeter of the entire property. She reported the trail is one (1) mile long and will be a beautiful walking trail with many different ecosystems. Ms. Goetz reported additional clean-up and some crosscuts of trails will be done in the spring.

Concerning the Beautification Project, Ms. Goetz reported a meeting was held with the Fire Department about the proposed bump outs on Main Street. She stated Township Engineer, Bill Tanner, made some adjustments to the bump out design to accommodate the fire trucks. Ms. Goetz reported several meetings were held with Township farmers who voiced concern about bringing farm trucks down Main Street, and she stated she felt confident their concerns were also addressed. She stated the work on Main Street has not yet started as the minor details are resolved.

Ms. Goetz reported she and the Mayor attended the Lam Cloud ribbon cutting. Lam Cloud is located in the old Aetna building. Ms. Goetz reported there were over 300 people at the Open House, and it was very interesting to hear Lam Cloud cite all the reasons they chose Cranbury as the location for their business.

Ms. Goetz reported another meeting was held with the Fire Company to discuss incentives to attract and retain members. She reported she also attended the League of Municipalities Convention and attended a session on COAH; however, she stated there is nothing new on COAH.

Mr. Mulligan stated the Township should keep track of Lam Cloud and be business friendly towards them as it is a great business to have in Town. He stated once a data center opens in a location, other data centers are drawn to the area.

Mr. Taylor reported he, Township Administrator Denise Marabello, and Police Chief Rickey Varga met concerning Town Hall security. He reported Mr. Doug Diamond will prepare a proposal for review at budget time.

Mr. Taylor reported a local business, Charmed by Claire, is working with Home Front to provide Christmas gifts to less fortunate children. Mr. Mulligan reported Mr. Kevin McConnell is holding his annual "Toys for Tots" event on Wednesday evening. Unwrapped toys may be dropped off at Mr. McConnell's home on Stockton Drive.

Mr. Taylor reported the Woman's Club annual Tree Lighting will be held on Friday, December 6th at Memorial Park. Mr. Cook stated the Lion's Club Pancake Breakfast will be on Sunday morning, December 8th, at the Cranbury School.

Mayor Johnson asked if the public had any comments on agenda items.

Mr. Tom Connolly, Petty Road, inquired about the reduction of the Performance Guarantee for the Chinmaya Mission. Ms. Marabello explained the process, and stated the Township Engineer agreed certain items had been completed and the amount of the Performance Guarantee could be reduced. Hearing no additional comment, the Mayor closed the Public Comment portion of the meeting.

Mr. Taylor inquired about the budget transfer moving funds from the Fire Official, which are funds raised from permits, to the tax-based revenue. Ms. Marabello stated any monies put into the Fire Official's budget are more than covered by revenues. Any monies remaining in the budget may be transferred to other line items or moved to surplus. There being no further questions or comments, the Mayor asked for a motion to approve the Consent Agenda Resolutions.
