Report – Historic Preservation Commission

Mr. David Szabo, past Chair of HPC and current Chairperson Susan Ryan gave the Commission's yearly report for 2017. Mr. Szabo reported three (3) members of the HPC renewed their memberships for another term and reported the Commission has one (1) alternate position that is vacant.

For 2018, Ms. Ryan reported the Commission's goals include continuing their education requirements, which is necessary for Certified Local Government status, and also the Second Phase of the CLG Intensive Level Survey of the Historic District. This will complete the survey of the remaining 109 properties, mostly on the south end of the Township. Once the Survey is complete, Ms. Ryan stated HPC will look at possibly redefining the Historic District's boundaries. She stated they found some properties that should be included in the District and others that should not be included.

Mayor Johnson inquired if HPC is considering a hard border without a buffer zone. Ms. Szabo and Ms. Ryan confirmed that will be discussed. Mr. Taylor stated 40 years ago the Historical Society partnered with the Planning Board and Township Committee to form the Historic District. The Township Committee thanked Mr. Szabo and Ms. Ryan for volunteering and for their report.

--Work Session

a) Discussion on a Proposed "Civil Rights Commission"

Mayor Johnson stated in the last three weeks since the civil rights discussions began, he has responded to many e-mails and met with people concerning the Civil Rights Commission. After listening to the recording of the meeting he stated it was his opinion the group did not make the case that a Civil Rights Commission was necessary.

He touched upon several issues including jurisdiction of the school, reporting of hate and bias crimes, his feelings on the comments made about the blue line down Main Street and his difficulty in recruiting candidates to run for the Township Committee.

Mayor Johnson stated those residents advocating for a Commission should not be disappointed if a Civil Rights Commission is not formed, but should see it as an opportunity to conduct events to highlight different cultures or act as recruiters for volunteer activities. There does not need to be an official Commission. He suggested the group set up as a private organization and come back and report to the Township Committee.

Mr. Ferrante thanked the members of the community who raised the issue. Mr. Ferrante stated he has had many conversations about this issue and stated there are several options that can be done: do nothing; allow this Commission to act as an independent organization with no connection to the Township Committee; or be an independent organization with a formal liaison to the Township Committee

He suggested forming something called a "Human Relations Commission," which is part of the New Jersey Municipal Code. He reported 15 of the municipalities in Middlesex County have a Human Relations Commission. He stated the Commission could focus on activities that would bring the community together, including a New Neighbor Reception, which would introduce new residents to the organizations and activities in the Township. Mr. Ferrante stated he believed this organization could focus on inclusion, education and awareness through programming, and should not serve the role of adjudicating issues raised or serving in any official capacity of reporting crimes in any way. Mr. Ferrante stated he wanted to offer an option that may be more palatable than the harsh sounding Civil Rights Commission.

Mr. Mulligan stated he sees Cranbury as a model community that works together and includes everybody. He stated he is positive on Cranbury and he sees a lot of great things Cranbury does and can build on. Mr. Mulligan stated there have been no cases of discriminatory acts filed with the Police Department. He stated there are laws at the local, State and Federal level that protect everyone in this Town and stated if anything discriminatory is done at any level in Cranbury, there are avenues to get help.

Mr. Mulligan stated he is supportive of a group forming separately to work together for the good of Cranbury. He stated a private/public partnership can be formed; it has been done in

 other instances in the past, such as the Business Association and the Historical
 Preservation Society. Mr. Mulligan stressed the Township needs to continue the dialogue
 going and keep working together.
 - Mr. Scott stated he felt it is a stretch to say people's civil rights are being violated on a daily basis. Mr. Scott stated he supported the idea of a Human Relations Commission and stated he feels the Town needs to be more open and more welcoming.
 - Mr. Scott reported South Brunswick Township has a Human Relations Commission, and he read their Commission's mission statement. He stated that mission statement is four (4) bullet points and covers what Cranbury seems to want.
 - Mr. Taylor stated he supports if people feel the need to get together to form a group; however, he feels the group should be a private entity that can fund raise and control its own membership. He stated there is more freedom in a dialogue when a group is a private entity and not public. Mr. Taylor stated just because the group would be a private entity does not mean it could not come and give report to the Township Committee. Another option would also be having a liaison.
 - Mr. Mulligan agreed an outside organization would be more nimble and agile and would be able to accomplish things more quickly. There would not be the oversight and governance that comes as being part of municipal government.

--Public Comment on Work Session

Mayor Johnson opened the Work Session to the public. He asked that names and addresses be stated for the record and asked that comments be kept to three (3) minutes.

- Mr. Bud Jackson, Petty Road, stated he personally is not against the diversity commission and sees no problem with it. He stated he can understand the financial constraints.
- Mr. Dave Babcock, Stockton Drive, suggested perhaps having a non-binding referendum on the ballot to see if Cranbury residents actually want a Civil Rights Commission. He agreed with the idea of an informal committee on civil rights.
- Mr. Richard Kallan, Wynnewood Drive, stated he feels if a Civil Rights Commission is created, it tells the world, "Cranbury has a problem."
- Mr. Robert Zurfluh, Bunker Hill, spoke about his job and how he attends mandatory training, including cultural training. He stated he wondered if the demographics changing in the Township if cultural training would be helpful.
- Mr. Zurfluh requested, if a meeting is filmed by a Township Committee member, it be announced.

Public Comment on Work Session

Mr. Ed Sekelsky, Evans Drive and Chairperson of the Recreation Board, stated if people want a Commission, there should be one. He stated Cranbury is an affluent town and can afford to have a Civil Rights Commission.

Ms. Nancy Whitcraft, North Main Street, stated she does not understand why there is so much "push back" about the Commission. She stated the Commission should be about inclusion and welcoming all to Cranbury.

Public Comment on Work Session (Continued) Civil Rights Commission

Mr. Jeff Grundy, Bunker Hill, stated he believes the Commission, no matter the name, is a good idea. He stated he likes the idea of the edge being softened and strongly recommended the formation of a group where people could come together for discussion of issues and concerns.

Ms. Jessica Irons, Old Cranbury Road, urged the Township Committee to consider some kind of backing for a group such as a Civil Rights Commission.

Ms. Betty Conover, North Main Street, stated people have to step up and offer friendship. She stated if people need, they just need to reach out and ask for it.

Ms. Jessica Ware, South Main Street, stated she feels there have been a lot of positive voices encouraging the Township Committee to think positively about the Commission and she urged them to do so. She stated the Civil Rights Commission has specific wording about veterans, and she believes the Commission is very important for Cranbury.

Hearing no additional comments, Mayor Johnson closed the public portion of the Work Session, and requested a motion that the Township Committee authorize the Township's Attorney to put together an Ordinance that would establish a Civil Rights Commission for Cranbury. Mr. Omar Mobin-Uddin, Cranbury Neck Road, stated he is concerned about traffic safety on Cranbury Neck Road. He stated he just heard that additional officers were being added for traffic safety and encouraged the Township Committee to also consider other options, such as speed bumps.

Ms. Huang, Brainerd Drive, stated she was hit by a car and her dog was killed while crossing Main Street at Evans Drive. She stated the driver never stopped. She thanked everyone for stopping at her house offering their support. Ms. Huang stated it has been one (1) years since the accident and cars are still passing pedestrians in crosswalk. Ms. Huang asked the situation be addressed immediately and to please do whatever it takes, such as speed bumps, flashing crosswalk sign or security cameras to slow down the speed of people driving through Cranbury.

Mr. Keith Shaw, North Main Street, suggested having signs that indicate cars' speeds might be a good deterrent. Mr. Shaw urged the Township Committee to think out pedestrian safety in Cranbury. Mr. Mulligan thanked Mr. Shaw for his comments and suggested the Committee have a Work Session in the near future to address the issue.

Ms. Nancy Whitcraft, North Main Street, stated the speeding at Plainsboro Road and North Main Street is very bad. She stated she, her husband and child were almost also hit because there is only light at the intersection and the driver could not see them. Mr. Scott stated the infrastructure and lighting must be improved to make the intersections safer. He stated it is great to have a zero tax increase; however, safety issues will have to be addressed at budget time.

Mr. Jeff Grundy, Bunker Hill, stated he is very concerned about darkness at crosswalks at Gil & Bert's, Methodist Church and Evans Drive and near where Mayor Johnson lives. He stated Hopewell has very good and discreet lights (very visible but smaller than those in Princeton). He stated the lights in Hopewell were very intense and impossible to miss. Mr. Mulligan requested Mr. Grundy come back to the Work Session so the dialogue can be continued.

Ms. Robin Black, Parkview Drive, supported Mr. Ferrante's idea about a Human Relations Council and thought it was a great compromise to meet in the middle. She stated other municipalities have similar Commissions and feels the fact that it was turned down this evening is very unfortunate and will reflect very negatively in Cranbury.

Mr. Richard Kallan, Wynnewood Drive, requested the Township ask the State to have the grass cut at the Cranbury Traffic Circle.

Hearing no additional comments, Mayor Johnson closed the Public Comment portion of the meeting.
