Mayor Stout urged the public to be mindful of their neighbors and children during hot weather and to keep themselves hydrated. Mayor Stout thanked all Cranbury residents who had e-mailed their representatives in Trenton concerning the recent COAH proposed Third Round Rules. Mayor Stout reported he had attended "Volunteer Day" on Saturday, June 7, 2008 and commended the Fire Company, First Aid Squad and Lions Club for putting on a very informative and active event. Mayor Stout reported he would be part of a panel on Tuesday, June 10, 2008 with Lucy Voorhoeve, Executive Director of COAH, at the National Association of Industrial and Office Properties.

-- Members of Committee

Mr. Panconi reported he had held his monthly meeting for April and May on Sunday with members of the Fire Company. During the month of April, there had been 23 calls; nine (9) calls

from 6:00 a.m. – 6:00 p.m. and 14 calls between 6:00 p.m. and 6:00 a.m. and four (4) between 7:00 a.m. and 3:00 p.m. Of the 23 calls, 15 were false alarms. In May they had responded to seven (7) calls; four (4) calls between 6:00 a.m. – 6:00 p.m. and three (3) calls between 6:00 p.m. and 6:00 a.m. and during the hours of 7:00 a.m. – 3:00 p.m. there had been one (1) call. Of the seven calls (7) four (4) were false alarms.

Ms. Stave reported the Board of Health is considering an ordinance requiring the licensing of cats in the Township due to a concern of cats contracting rabies (the incidence is seven (7) times greater than that of a raccoon). The Board of Health reported they are looking into acquiring a defibrillator for Town Hall.

--Subcommittees

Ms. Smeltzer reported one of the most important items the Township is presently working on in reference to COAH is the jobs generated with the warehouses located throughout the Township. Clarke Caton & Hintz, the Township's COAH Consultants, are presently conducting a survey which should be ready in about four (4) to six (6) weeks. Upon its completion, it will be presented to the Township Committee for approval and then submitted to COAH. COAH will then let the Township know its analysis of the report. Ms. Smeltzer reported her, Ms. Stave and Township residents, John Ritter, Dietrich Wahlers, Karen Finigan and Nicholas Kafasis had attended an Assembly Appropriations Committee to lobby against Assembly Bill 500 by Assembly Speaker Joseph Roberts. Ms. Smeltzer commended the residents on the eloquent remarks made before the Committee and stated Cranbury could be proud. She indicated the Committee was now aware of municipalities such as Cranbury and the impact such legislation would have. Ms. Smeltzer reported eight (8) members of the Assembly Committee had voted to release the Bill with amendments and the full Assembly would most likely be voting on the Bill on June 16th. Ms. Smeltzer added the Township's web site will be updated with new information concerning the most recent COAH news no later than Wednesday.

Ms. Marcelli indicated Mr. Speers had recommended several changes and the Planning Board would be reviewing the ordinance at its June 19, 2008 meeting. Both Mayor Stout and Ms. Cunningham, Clerk, indicated they had not received any communication from the Planning Board. Mayor Stout announced the ordinance would be carried over until the next Township Committee meeting of June 23, 2008.

Ordinance Second Reading

Cranbury Township Ordinance 04-08-11

A motion to enter an Ordinance entitled, "Cranbury Township Ordinance 04-08-11, AN ORDINANCE OF THE TOWNSHIP OF CRANBURY, MIDDLESEX COUNTY, NEW JERSEY, AMENDING CHAPTER 150 OF THE CODE OF THE TOWNSHIP OF CRANBURY AND TO ADD A NEW R-ML-III-RESIDENTIAL MT. LAUREL III ZONE", was presented for second reading and final adoption. The Ordinance was published in the Cranbury Press, posted on the Township Bulletin Board and copies were available to the public. Ms. Smeltzer recommended to the Mayor that the ordinance be allowed to die, since Mr. Berkowsky, Cranbury Housing Associates, had indicated the plan has changed for the affordable housing site in question. The Mayor, however, indicated he would allow the public to comment on the ordinance as a large group was present. Following are remarks made by several residents concerning the ordinance:

Dave Mauger, 26 Griggs Road, stated he agreed with the Mayor's recent letter sent to Ms. Lucy Voorhoeve, Executive Director of COAH stating, "Cranbury would be facing a crisis of devastating proportions". Mr. Mauger added "way of life in a small town is too important to lose". Mr. Mauger stated there seemed to be a disparity with the type of affordable housing development that is allowed to be built inside of a development and the type that is allowed to be built outside of a development and a potential weakness in the strategy used in addressing the Township's affordable housing obligations. Mr. Mauger applauded Cranbury Housing Associates for the job they have done thus far with the affordable housing units and urged the Township to continue to have affordable houses that reflect the values of a small town. Mr. Wittman asked Mr. Mauger if Mr. Berkowsky had met with the residents in his neighborhood concerning the proposed Route 130-D site and if he had participated in any of the discussions. Mr. Mauger indicated he had attended the meetings. Mr. Wittman stated the Township has always made an effort to do the best thing and the most tasteful thing in building the affordable housing. Mr. Mauger stated his concern with the affordable housing proposed at the Route 130-D site is that the units would all be rentals and the building would be over 40 feet high. In addition, the concern of the residents in the neighborhood has been the possibility that in the future, Ryan Road would be opened up to traffic off of Route 130. Mr. Mauger stated the proposed specifications that were in the original site plan called for the highest density units (12 to 1, with the possible exception being the senior housing), the tallest building (40 feet high) and the largest development (44 units). Mr. Mauger stated the proposed units were not consistent with what had been done in the past for affordable housing units. Mr. Wittman explained the Township is a long way off from putting a shovel in the ground and Mr. Berkowsky has always worked over the years with the neighbors. In addition, the present ordinance has been pulled and will be revised. Mr. Mauger stated he and his neighbors just want to make sure that the Township gets done what needs to be done and everything is done the right way. Mayor Stout asked Mr. Berkowsky for clarification that the Township's affordable housing has now become all rentals in order to maximize the Township's COAH credits. Mr. Berkowsky confirmed that it has.

Mr. Brian Schilling, 2 Holmes Road, stated he is concerned with the way the COAH calculation is being done. He stated it is reassuring to know the Township is doing everything it can to get it changed. Mr. Schilling added he felt it is contradictory for Cranbury Township to be facing the obligations which have been mandated by the proposed Third Round Rules, let alone losing the prospect of losing Regional Contribution Agreements (RCAs), as Cranbury has been a model municipality regarding Affordable Housing. Mr. Schilling recommended waiting to see what the Township's full obligation will be before advancing with any new construction for affordable housing. Mr. Schilling stated he is concerned also with making Ryan Road an open access road and if the State may have the authority to mandate such. Mr. Schilling also made a

recommendation the Township considers submitting an application for a Planning Incentive Grant for open space. He indicated there is now a lot of grant money available through the State.

Mr. Francis Staples, 3 Griggs Road, thanked the Township Committee and Mr. Berkowsky for "keeping the dialogue open". Mr. Staples stated he was recently impressed with the Township's fiscal conservativeness on not purchasing the former PNC bank building. Mr. Staples requested when the ordinance comes up again, the Route 130-D site not be the location to put the affordable rental units (40+ families)--there is not enough land available at the site to have a park for the children. Mayor Stout responded it was not the intent of the Township to try to "squeeze" a lot of families at one site.

Mr. John Ritter, Plainsboro Road, suggested working with the State to allow a U-turn at Dey Road or to find a spot where people could make a U-turn before Dey Road. Ms. Marcelli responded the State does not encourage U-turns and that Dey Road had been dramatically improved about five (5) years ago by a private developer at no cost to the Township. Unfortunately, there is not enough land to have a turn-around at Dey Road. Ms. Marcelli offered to start a dialogue with the State D.O.T. to see what could be done.

Mr. Dan Mulligan, 32 Old Cranbury Road, stated he was pleased the Ordinance was put to rest and recommended the Township wait until COAH makes its final decision before taking any action. He raised his concern with the density issue. He also asked that the Township put more COAH updates on the Township's web site. Mayor Stout indicated the Township would put a hot link on the Township's web site so residents can be better informed. Mr. Panconi added that every day there are ongoing articles in both the Star Ledger and Home News regarding COAH legislation and issues.

Mayor Stout asked for a motion to adopt the Ordinance. Ms. Stave made a motion and no one seconded. For lack of a second, the Ordinance died.

Presentation by representatives of New Jersey American Water Company and their consultant, Gannet Fleming on a proposed water main project on Plainsboro Road:

Mr. Scott Connor, Engineering Manager, New Jersey American Water Company, presented to the Township Committee, a plan to install a new water main. Mr. Connor explained the new water main would start at Aspen Road in Plainsboro and continue to North Main Street in Cranbury. Mr. Connor stated currently Cranbury is served by a 20-inch main single transmission running down Dey Road and if it should require any repairs or need to be taken out of service, New Jersey American Water would lose its ability to maintain the proper water level to Cranbury residents. By allowing the new main to be installed the water company would have a redundant feed into Cranbury and the levels of service would not be compromised. The project would be constructed before the end of the year and will take approximately 8-12 weeks. The cost will be approximately \$2.5-million. New Jersey American Water has applied to D.E.P. for a permit. Mr. Wittman asked Ms. Marcelli, Township Engineer if there are plans to repave Plainsboro Road. Ms. Marcelli indicated when she spoke with New Jersey American Water she had indicated to them Plainsboro Road was in good shape, having been repaved within the past five (5) years. Ms. Marcelli requested that New Jersey American Water pave the section of the road where the trench will be dug and they have agreed. Mr. Wittman asked if temporary water service would need to be installed and Mr. Connor indicated there would be no impact on Cranbury's water service. Ms. Marcelli stated she had recommended that prior to the project starting, a "pre-con" meeting is held at Town Hall with the Police Department and Township Administrator also attending the meeting so everyone is onboard. Mr. Connor indicated letters would be sent out to all residents along Plainsboro Road in advance. Mayor Stout asked for a summary of the project for the Township's web site to alert residents. Mr. Berkowsky, Historical Society, asked about the old Water Tank and the possibility of New Jersey American Water Company reopening discussions concerning the tank. Mr. Connor indicated he had not been part of previous discussions, however, would be willing to have them started again.

Reports from Township Staff and Professionals

Ms. Marcelli, Township Engineer, reported she had held an informational meeting with the residents on Wynnewood and Woodview Drives to let them know that the roads will be resurfaced sometime in the Late Summer/Early Fall. The monies were obtained through a grant from the New Jersey Department of Transportation to fund the project.

Ms. Marcelli also reported she had met on May 30th with Joe DiDinato of the Middlesex County Engineer's Office and their consultant, Birdsall Engineering, regarding Old Trenton Road. The purpose of the meeting was to reconfirm that they have the re-alignment of the Millstone Park driveway on their plan and also to discuss the drainage improvements at the intersection of Old Cranbury and Old Trenton Roads. Ms. Marcelli reported the plan the County had was not the best approach to providing drainage and she indicated her Office is working with them to develop a better plan.

Ms. Marcelli reported she had been contacted by the consultant for the Liberty Way Bridge Project. The consultant was under the impression (from the County) the Township was holding up progress of the Bridge Project. She told the consultant that was not the case and will be meeting with them to go over what items are needed from the Township.

Ms. Marcelli reported at the last meeting she had been asked to bring back to the Township Committee information as to where the Township was with the "Sidewalk Project" to date. She explained, in 2004, her Office had gone out and evaluated sidewalks throughout the Township and then determined which sidewalks were in need of repair. All of the sidewalks had been rated and all residents within the area had been contacted and asked if they wanted to repair their sidewalk or otherwise the Township was going out to bid to have it done. Certain properties opted into the Program and others opted to do their own. To date a lot of those homeowners have never had them repaired. Mayor Stout indicated the Township Committee next year may want to revisit the project (to determine what had and had not been done) and then implement the Program again. Mayor Stout suggested passing out literature on Cranbury Day.

Mr. Panconi brought up the issue of the homeowners from Shadow Oaks and Old Trenton Road who have refused to trim bushes that are hanging over the sidewalk and making it virtually impossible to either ride a bike or walk on the sidewalk. He added numerous letters had been sent in the past from the Township to the homeowners. Some of the homeowners, but not all, had responded. In addition, the bushes have not been kept trimmed on a regular basis. Ms. Smeltzer offered to look into the issue and determine if additional letters are needed.

Ms. Cunningham, Clerk, reported she had received a communication from The Cranbury Business and Professional Association asking if the Township still wished to have a table on Cranbury Day, Saturday, September 6, 2008. All members of the Township Committee unanimously agreed to have a table.

Reports from Township Boards and Commissions
There were no reports.

Work Session

a. Monthly Report from Police Chief Edward Kahler

Police Chief Edward Kahler updated the Township Committee for the month of May. Chief Kahler reported the total summonses issued for the month of May were 392; of those 31 were for speeding and other violations-28. The Department's expenditures, from highest to lowest, were training, shift coverage and special details, i.e. the Memorial Day Parade. During the month of May the Police Department conducted its semi-annual firearms training and began the Department's radar-certification and alpha test. The Drug Free Fair and Memorial Day Parade accounted for the increase in expenditures for the month. The Traffic Bureau reported they had successfully completed the "Click It or Ticket Program" and it appears compliance with the seat belt law seems to be increasing. Sqt. Dillane had attended a work-zone safety training update which included new

requirements for signs at construction sites. Chief Kahler reported motor vehicle accidents had been up slightly from 2007. From January 1, 2007 to June 1, 2007 there

had been 118 accidents. For the same time period this year there have been 125 accidents. The Detective Bureau reported they had three (3) arrests in a local copper theft case. One arrest had been made in a bomb threat case. The Detective Bureau will be sponsoring a crime and theft seminar for the Cranbury business community. The Detective Bureau is investigating two (2) active burglaries and a number of thefts; the two are not connected. A total of fifteen arrests had been made in May; two (2) were for drug possession and two (2) arrests for Driving While Intoxicated. The Patrol Unit vehicles put on 13,921 miles during the month of May. In addition, the Police Department had been approached by one of the boy scouts who is doing a project to earn his Eagle Scout Award. He has requested to turn a storage room at the Police Station into a disaster shelter. The Police Department had provided him with a letter and blueprints to proceed. Mr. Wittman suggested the boy scout fill out the Township's "Volunteer Project Form". Ms. Waterbury, Township Attorney, stated the form and guidelines are posted on the Township's web site. Ms. Stave asked about the total summonses totaling 292 and asked what constituted the rest of the numbers other than the 28 already reported. Chief Kahler responded a lot of tickets had been issued for "Click It or Ticket" and some motor vehicle accidents. Ms. Stave asked for statistics on speeding and Mayor Stout requested the Chief provide the Township Committee with a graph, showing the trend in speeding violations since the inception of the "Cranbury Crawl". Mayor Stout reported when Chief Hansen was in command, one of the items the Township had asked him to look into was obtaining a portable vehicle for performing firearms training on site and asked Chief Kahler to look into it. Chief Kahler also reported the Bike Patrol had been active during the month of May.

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Mr. Robert Dillon, 32 Hightstown/Cranbury Station Road, spoke concerning a complaint he had filed with the Township concerning Mid-State Filigree which is near his home. Mr. Dillon reported in April, 2008 the company had been fined for removing trees in the set-back areas, in non-setback areas, filling and grading the lot and then covering most of the 16 acre worksite with stone. This had been supposedly done because the State D.E.P. had issued violations to them for discharging of contaminated water. Since then, Mr. Dillon indicated, he has noticed numerous major changes that have been made from the original site plan approved by the Township Planning Board in 1987 and added, the site plan was a result of a court case he was involved with about five (5) years ago. Mr. Dillon reported he had sent a list of recent violations, however, not all, to Jeffrey Graydon, Zoning Officer, the Mayor, Planning Board Chairman, Township Attorney, Planning Board Attorney, Zoning Board Attorney and Township Engineer. At the last informal discussion with Mid-State Filigree at a DRC meeting, the Planning Board Attorney and the Township Engineer viewed the application submitted by Mid-State Filigree as a minor site plan, based only on Mr. Graydon's summons. On or about June 3, 2008, Mr. Graydon called Mr. Dillon concerning the issues and indicated at that time he was not going to investigate any other possible changes that had been made at their site since the original site plan or any other zoning violations---even though a full complaint had been registered. Mr. Graydon indicated the Board had the right to change the minor site plan to a major site plan. When Mr. Dillon questioned the Township Engineer after the DRC meeting concerning the information he had sent her, she indicated she was not going to investigate or visit the site and her role is only to review the site plan and had indicated she would be approving the site plan because it was a minor site plan. Mr. Dillon expressed his concern that any other Board would not be reviewing the site in question once the minor site plan had been approved. Mr. Dillon stated he was respectfully requesting the Mayor and Zoning Board members monitor and inform the Administrative Officer, Township Engineer and Zoning Officer and any other individual employed by the Township of the issue to

avoid him taking any further legal action. He also requested a proper investigation of Mid-State Filigree take place so that the application can be changed to a major site plan, so that the Planning Board can regulate the application accordingly. Mr. Dillon expressed his frustration with Public Comment (Continued)

the Township and the lack of anyone following up with the complaint. Ms. Marcelli responded, stating when Mid-State Filigree came before the DRC they came to the meeting with a non-surveyed plan. Ms. Marcelli indicated she does not survey properties and has no enforcement powers until she has an application and can look at a survey plan that currently exists and compare it to the approved plan from 1987. She added, Mid-State Filigree is aware they have to make an application, and when they do so, she will then go out to the site with the Township Planner and perform an on-site inspection. The Zoning Officer did inform them that they had to come in and make application for a site plan and, if there is any public objection the application, it has to go before the Planning Board. Mayor Stout asked the Township Administrator to reach out to the Planning Board Attorney and Zoning Officer to determine what the status is. Mayor Stout indicated to Mr. Dillon someone would be getting back to him.

Mr. Dave Mauger, 26 Griggs Road, asked the threshold for the number of students Cranbury presently sends to Princeton High School. Mr. Mauger stated whatever the threshold number is could have a serious impact on Cranbury's affordable housing issues. Mr. Stannard responded the School Board would know the actual threshold number. Mr. Mauger stated the Township may want to look at other sites for affordable housing in addition to the Route 130-D site and also recommended the COAH subcommittee adopt town-wide maximums for density for its affordable housing. Mr. Mauger stated under the Fair Housing Act, registered sex offenders are not considered to be a protected class and recommended the Township put a provision in place, without opening the Township up to possible litigation, to prevent registered sex offenders, particularly Level 2 and 3 offenders from living in any of the affordable housing units. There being no further comments, the Mayor closed the public part of the meeting.

Mayor's Notes

On motion by Ms. Stave, seconded by Mr. Wittman and unanimously carried, the meeting adjourned at 9:35 p.m.
