#### Work Session

a). <u>Discussion of Plaques for Trees Planted in Heritage Park in Memory of Others &</u>
Guidelines Set Forth by the Parks Commission.

The Township Committee discussed the guidelines which were recently recommended by the Parks Commission to the Township Committee via an e-mail on September 14, 2008 for commemorative plaques/trees to be planted in Heritage Park. Ms. Stave led the discussion, explaining, to codify what the parameters of a memorializing plaque would be, the Parks Commission came up with the following specifications based on information it obtained from a local supplier: the size of the plaque shall be 6" x 10"; the plaque shall be gray granite (for example, median barre grass if purchased from Duryea) or bronze set flush in the ground; the maximum size for any letter is ¾"; the location of the plaque in the ground and the overall wording and design shall be submitted to the Parks Commission and approved before the plaque is installed; the family is responsible for ordering, arranging for the installation and paying for the plaque from a reputable local entity. In addition, the family will be responsible for the purchase of the tree. On motion by Mr. Stannard, seconded by Ms. Stave and unanimously carried, the recommendations for quidelines made by the Parks Commission were adopted.

### **Public Comment**

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Mr. David Mauger, 26 Griggs Road, stated over the past few years and the past few months, discussions concerning the affordable housing and the Route 130-D site have led some Township Officials to wonder what the neighborhood residents support. Mr. Mauger explained last week a petition was drafted that focuses on the common ground of neighbors and Township Officials. He stated over the weekend 48 neighbors from 26 households in Cranbury Estates signed the petition and more signatures are expected in the coming weeks. Mr. Mauger read the petition: "Regarding Cranbury Township's selection of the Route 130 "D" Site as a means to partially satisfy the Township's current third round affordable housing obligations, we, the undersigned residents, are amenable to the development of up to 29 units of affordable housing at the Route 130 "D" Site in accordance with the following specifications included in Cranbury Township's 2005 Fair Share Housing Element (A. K. A. Complete Third Round Plan):

\* "vehicular access will be restricted to Route 130 (except for emergency access to Ryan Road similar to that between Silvers Lane and Griggs Road)".

\* Site design will be considerate of adjacent neighborhoods "at densities and housing types consistent with the surrounding residential development".

We also request that the Route 130 "D" Site Plan include provisions for the following:

- \* Improved access from northbound Route 130
- Permanent open space bordering Ryan Road.

Thank you for your consideration." Mr. Mauger added, every request listed in the petition are positions that have been taken by Township Officials over the past few years as the Township has gone through the process. He explained the point of the petition is to reach a "common ground" as to what the residents would like and what the Township would be amenable to. Mayor Stout thanked Mr. Mauger and stated the design is not something that is active at this point; all the Township's energies are focused on putting the pieces together for the Plan as it relates to the 269 number and what the Township's growth will be. He added, with the open space bordering Ryan Road, another consideration should be the neighbors on Silvers Lane and asked if any resident on Silvers Lane had been party to the petition. Mr. Mauger explained it has not been circulated in the Cranbury Walk Development, however, he has been keeping in touch with one (1) resident on Silver's Lane. There being no further comments, the Mayor closed the public part of the meeting.
