Reports from Township staff and professionals

Ms. Waterbury, Township Attorney, reported she had received notice from the Third Circuit Court of Appeals regarding Cranbury Brook Farms (Poling) vs. Township of Cranbury indicating the case would be discussed on Wednesday, October 25, 2006. She explained she was not sure if the Court was going to render a decision on October 25<sup>th</sup> or just hear the case. Ms. Waterbury indicated as soon as she has more information she will let the Township Committee know.

Mr. Witt, Township Administrator, reported the Township Committee had received a letter from Mr. Robert Smithers, Petty Road, concerning an accident on Old Trenton Road recently and had alerted both the Township Engineer and Traffic Consultant, asking them to please review the issue and announced other traffic and safety issues would be discussed at the Township Committee meeting on November 13<sup>th</sup>. Mr. Witt also reported the Township had received a letter from The Cranbury School in reference to the issue with the radius for school buses on Shady Brook Lane. Mr. Witt stated he had already met with Carol Malouf, Cranbury School Administrator, to work out a solution and indicated this issue would also be discussed at the meeting on November 13<sup>th</sup> by the Township Engineer and Traffic Consultant. Mr. Stout stated, as a member of the Traffic subcommittee, Mr. Smither's letter was appreciated. Mr. Stout pointed out, in reference to the speed limit on Old Trenton Road, the road is a County Road and the Reports from Township staff and professionals (Continued)

Township for many years had tried unsuccessfully to have the speed limit reduced. Mr. Stout also stated the subcommittee would be reviewing Mr. Smither's suggestion concerning fencing as well as other safety issues and would be reporting on these issues during the Work Session discussion at the November 13<sup>th</sup> meeting.

Mayor Panconi announced Freeholder Polos had arrived and stated the Freeholder would be saying a few words concerning a \$480,000 grant Middlesex County would be giving to the Township for various senior services and recreational purposes throughout the Township.

Freeholder Polos spoke, stating the County had created a few years ago, the Open Space Preservation Fund. Freeholder Polos explained the initial Referendum Resolution had been voted on and passed by the voters within the County to allow for preservation of open space. He further explained, a few years ago an amendment was voted on and passed to allow some of those funds to be used for recreational purposes within the County. Freeholder Polos stated the County was providing the Township with \$480,000 to help with its recreational initiatives and its senior citizen program and complimented the Mayor and Township Committee for their stewardship.

Freeholder Polos also stated there would now be a full-time Shared Services Coordinator hired by the County to work with communities and school and fire districts which receive or provide shared services. Freeholder Polos complimented the Township on using shared services and stated he looked forward to working with the Township in the future.

#### Reports from Township Boards and Commissions There were no reports.

Work Session

- a. Monthly Update on Revaluation by Steve Benner, Tax Assessor (Steve Benner).
  - Steve Benner, Tax Assessor, gave his monthly update on the Township's Revaluation. Mr. Benner stated the Revaluation is on schedule. Mr. Benner reported there are yet some homes which have not been done and the appraisal firm is preparing a list for Mr. Benner. Mr. Benner reported on the 11<sup>th</sup> of October he had met with Mr. Glen Sherman, the Project Supervisor, to go over the "nuts and bolts" of how they are putting the Revaluation together. Mr. Sherman indicated they had done modeling on sales and projected assessments against that information. Mr. Benner reported he was now able to access the appraisal firm's records. Mr. Benner added he would be meeting again with them in mid-November. Mr. Benner also stated there would be interaction with the public in mid-November. Mr. Robert Smithers, Petty Road, asked how residents would be able to find out what their re-assessment was. Mr. Benner responded the homeowners would be notified via letter what their assessment would be and the letter would give the proper procedures to set up an appointment to come in and review how the assessment figures were determined. Mr. Smithers then asked when taxpayers would get an idea of how much they will owe in taxes. Mr. Benner responded to compute approximately the figure, one should take the overall budget figures and divide it into the potential ratable base, giving one the potential tax amount. Mr. Benner stressed residents should not use the existing tax rate to compute their new tax rate. Ms. Stave asked Mr. Benner to explain the appeal process for a resident who wishes to appeal their assessment. Mr. Benner stated after the informal hearing then the assessments will be certified in January and once the announcements are set for the assessments, the property owner will have 45 days or until January 1<sup>st</sup> to file their appeal with the County Board of Taxation. The property owner will then receive a notice from the County Board of Taxation to go to a hearing. The property owner will then go to the hearing, giving them information based on sales, not their neighbor's assessment. If the property owner is not happy with the

  - assessment the County Board of Taxation's decision, then they may appeal to the State of New Jersey. Mr. Benner also urged residents to not feel shy about contacting the appraisal company for a review of their assessment and if a resident has a problem with the appraisal company they should call Mr. Benner's office.

b. <u>Discussion of Keep Middlesex Moving, Inc., Municipal Transportation Demand Management</u> Grant (T.D.M.). (Tom Witt)(continued).

Tom Witt, Administrator, explained the Township had applied for a grant under Keep Middlesex Moving T.D.M. (Transportation Demand Management) for up to \$5,000 and it had been submitted on October 18<sup>th</sup>. The grant application addresses improvements to the sewer utility easement between 14-16 Wynnewood Drive in the Wynnewood Development to create a safer pedestrian/bicycle pathway which would lead into the center of the Village area. Mr. Witt explained further, if the grant is awarded, the Township plans to remove the existing curb, put in a depressed curb, handicapped sidewalk (5 feet wide) and repair the area around the pump station which has some grading issues. Mr. Witt added, the \$5,000 would cover all of the materials and labor to have the project done. Mr. Wittman asked if any outreach would be necessary to the residents in the development. Mr. Witt indicated he would be happy to send out a letter and then indicated he would stop out and see the residents this week to let them know.

Public Comment (For those items not on the Agenda)

The Mayor opened the meeting to public questions and comments on those items not on the agenda. There being no comments, the Mayor closed the public part of the meeting.
