WHEREAS, The Cranbury Historical & Preservation Society has petitioned to rename and rededicate the Cranbury History Center in honor of Elizabeth M. Wagner at an event on the grounds of the History Center on Sunday, November 11, 2018; and

WHEREAS, The Cranbury Historical & Preservation Society would like to have November 11, 2018 declared as Elizabeth M. Wagner Day in recognition of her many contributions to Cranbury Township; and

WHEREAS, Elizabeth M. Wagner ("Betty") moved to Cranbury Township with her husband Bill in 1971; and

WHEREAS, Betty joined the Cranbury Historical & Preservation Society shortly after moving to Cranbury and immediately became involved in its many activities promptly volunteering to establish a Society Library, organizing boxes of accumulated papers, documents, books, etc.; and

WHEREAS, she served as Society President for **10** years and served as a member of the Society's Preservation Committee; and

WHEREAS, Betty was also a member of the Cranbury Township Planning Board from 1981 to 1992.

WHEREAS, through Betty's tireless efforts many of Cranbury's historic sites were saved, including the Hess Farmstead, The Holland House and the Gristmiller's House; and

WHEREAS, Betty worked steadfastly to organize and lead efforts to stop proposed actions that threatened the preservation of Historic Cranbury including:

- Continually being vigilant to preserve the farmland vistas; and
- During the Mount Laurel II litigation, initiating "Friend of the Court" status for the Society, establishing the importance of preservation of Cranbury's historic resources; and
- Working to prevent the "Builder's Remedy" and reduce the number of new housing units to be built to a manageable size for Cranbury's growth and preservation; and
- Working to prevent a County dump site in Cranbury; and
- Working to prevent the construction of Highway 92 through Cranbury farmland.

WHEREAS, she played a major role in the efforts that placed Cranbury on the State and National Registers of Historic Places; and

WHEREAS, over the years Betty co-chaired and chaired the committees in charge of many of Cranbury's community celebrations: The U.S. Bicentennial, Middlesex County Tercentennial, the Cranbury Tercentennial and the Town Hall Dedication; and

WHEREAS, Betty received a Certificate of Merit from the League of Historic Societies in New Jersey, as well as a Certificate of Recognition from the Daughters of the American Revolution for her outstanding work on the Bicentennial and in 1993 was the recipient of the Local Historian's Award of

Distinction, a statewide honor given to individuals for their outstanding contributions to local or regional historical programs and, in addition, was recognized in 1997 by The New Jersey General Assembly for her outstanding achievements; and

WHEREAS, Betty served as Township Historian from 1985 until her retirement in 2010 and as a member of the Cranbury Township Cultural and Heritage Committee;

NOW, THEREFORE BE IT RESOLVED, that the Cranbury Township Committee recognizes Betty for her dedication and tireless efforts on behalf of historic preservation in Cranbury Township; and

Mayor Johnson opened the meeting to public comment.

Richard Kallan – Mr. Kallan requested information from a discussion held at a previous meeting regarding residents placing brush and debris curbside earlier than the allotted pick up time or placed out incorrectly. Ms. Marabello reported that Department of Public Works has issued between 15-20 warnings monthly, however, no summonses have been issued. Mr. Taylor advised he believed residents should be fined if it continued. Ms. Marabello advised that in order to enforce the codes fair and consistently, the township needs to discuss at budget time creating a Code Enforcement Official. Mr. Taylor suggested the Police Department could enforce as other towns do. Discussion ensued on having Department of Public Works note daily in various areas of town. Ms. Marabello said there are also other codes that need to be enforced as well and there may be a need to have one official dedicated to enforcing all codes. Ms. Marabello added that residents have various ways to find the codes; such as the township website. Mr. Taylor added that many times it is contracted landscapers that create the hazards and not necessarily the residents.

Deanne Napurano – Ms. Napurano read an excerpt from the Cranbury Master Plan Chapter 3 regarding the future development of Cranbury. She advised the Committee that they are in a unique position to improve things for the future of Cranbury and begin now not wait for 2020. Mayor Johnson advised that the process can begin sooner but unknown how long the process would take. Mr. Taylor advised that the process includes getting consensus from the residents and scheduling various work sessions for discussions. He also added that if a developer were to begin process now it would be approved with the Planning Board under the current Master Plan. Mr. Ferrante stated that the difference in warehouse use from 2010 needs to be addressed in the upcoming evaluation.

Betty Conover – Ms. Conover stated with bad weather approaching she was requesting that the township incorporate a protocol for advising residents of warming centers and other services during snow/storm emergencies. She suggested the fire truck be used with the loud speaker in cases where there is no power for residents to be advised on the website or cable channels or safe places to go. Ms. Marabello stated that Town Hall would be opened as a warming center now that a generator has been purchased and put in place, however, the township does not have the ability to run an emergency shelter for residents. Ms. Conover suggested the protocol be placed in the township newsletter for residents who are unable to be notified any other way.

Mayor Johnson closed the meeting to public comment.
