# TOWNSHIP COMMITTEE MEETING DECEMBER 20, 2004

The regular meeting of the Township Committee of the Township of Cranbury was held at 7:30 p.m. in the Town Hall Meeting Room. Answering present to the roll call were: Township Committee members: Becky Beauregard, Thomas Panconi, Jr., and Mayor Stannard. Ms. Stave arrived at 7:40 p.m. and Mr. Mayes was absent. Also present were: Township Committeeman-elect Stout, Trishka Waterbury, Esquire, Attorney, Cathleen Marcelli, Engineer, Frederick C. Carr, Administrator and Kathleen R. Cunningham, Clerk. Mayor Stannard led in the salute to the flag and Ms. Cunningham gave the following Open Public Meetings Act statement:

Reports and Communications from Committee

--Committee Minutes December 6, 2004 Mayor Stannard requested the minutes of December 6, 2004 be listed on the January 3, 2005 agenda.

--Sub Committee Reports -

Mr. Panconi reported he had attended a Joint Insurance Fund. Seminar on Tuesday, December 14, 2004 on Workers' Compensation for elected officials. Mr. Panconi recommended that weekly safety meeting be held as municipal employees have the highest rate of accidents. Mr. Carr indicated that there are quarterly safety meetings held by the Joint Insurance Fund, which he and Mr. Witt attend along with the Police Chief and Fire Chief and the Township has a very pro-active approach to safety. Mayor Stannard suggested that when the next meeting is scheduled, member of the Township Committee be invited. Mr. Carr indicated he would make sure the members are invited.

Ms. Waterbury updated the Township Committee with Wright South, indicating she, Mr. Carr and Ms. Marcelli had met earlier in the evening with Don Driggers, Esquire, representing Mr. Wright. The purpose of the meeting was to discuss the driveway easement, i.e. maintenance of the driveway and escrow funds which the Township is still holding (approximately \$180,000 from the original \$250,000). Ms. Waterbury indicated progress had been made and she would have further updates for the Township Committee the beginning of January.

Ms. Marcelli, Township Engineer, briefed the Township Committee on a letter which Mr. Kerzner had sent to the Township. Mr. Kerzner is requesting the Township Committee consider taking deed to a property,

which is irregularly shaped and splits between the Turnpike and Corporate Drive, which is a Township roadway. Mr. Kerzner is doing a re-financing of one of his roadways in his corporate park. Ms. Marcelli indicated she saw no reason why the Township could not acquire the deed. Ms. Marcelli wants to make sure, however, the Township does not require maintenance or any strange requirement that the Turnpike Authority may impose on the parcel. Ms. Marcelli and the Township Engineer spoke with Mr. Driggers requesting he have written into the Deed, Mr. Kerzner accepting all maintenance responsibilities, cut the grass, etc. and should there be any requirements from the Turnpike Authority, they would be Mr. Kerzner's responsibilities and not the Township's. Mayor Stannard made a recommendation that language should be inserted indicating should any environmental issues occur, it would be Mr. Kerzner's responsibility as well for cleanup. Ms. Waterbury indicated should the Township decide in the affirmative, she would prepare an ordinance for introduction sometime in January.

## Update on new Police Building:

Mark Berkowsky gave his monthly report on the progress being made with the new police station. He indicated the floor slab had been poured last Friday. Mr. Berkowsky also reported the cooperation has been great with the Township inspectors. No changes in costs. Completion date still remains the end of August and construction is on schedule.

Mr. Berkowsky asked about the format of the dedication plaque. Mr. Carr recommended Mr. Berkowsky and the architect, work up various styles of the proposed plaque and send them to the Committee members and the Committee would then discuss the decision at its last meeting in January. The Township Committee agreed.

Ms. Stave reported she had attended the Parks Board meeting. The Board recommend to the Township Committee the Wright South property be referred to as "The Village Green". The area where the barns are be called the "Barn Preserve" and wholeheartedly endorse the West Property as being called "The Cranbury Brook Preserve".

Ms. Stave also reported she had met with John Ritter, as the SubCommittee on the Township's website and they have thoroughly reviewed the Township's website against other websites for municipalities in the State of New Jersey. The SubCommittee has put together a list of things that would be ideal to have on the Cranbury website. The next step is to meet with the website designer and understand what the process is and what the computer infrastructure is and the costs as well as to meet with the various departments, members of staff and perhaps some of the Township professionals. The SubCommittee will then come back to the Township Committee in February with a full report of recommendations in time for review and approval within the budget process. Ms. Stave indicated that in the long run, this will be a very worthwhile project and save the staff a lot of time.

Ms. Beauregard reported on the barn SubCommittee. She indicated she has had discussions recently with Ms. Waterbury, Township Attorney and Michael Kaiser who is working with the Lions' Club on the restoration of the three barns. This project seems to be moving along and should be ready to start in 2005.

- (b) COAH Affordable Housing Development Fees (Trishka Waterbury)
