CALENDAR YEAR 2022 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK

WHEREAS, the Local Government Cap Law, N.J.S. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget up to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the governing body of the Township of Cranbury in the County of Middlesex finds it advisable and necessary to increase its CY 2022 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the governing body hereby determines that a 1.0% increase in the budget for said year, amounting to \$83,908.10 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS the governing body hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

Work Session - Discussion of Cedar Brook and Petty Road with Township Engineer: Mr.

• Raj Lakhanpal – Mr. Lakhanpal thanked the committee for their work. He stated the bridge is acceptable but the road itself is an issue. He asked for repair to the road as it is an ongoing problem in the area.

• Denise McQueeney – Ms. McQueeney requested an update on Cranbury Commons, Cranbury Circle and questioned more affordable housing in the township.

• Desiree Chen – Mrs. Chen agreed with Mr. Zimet and requested road signs to be placed on both sides of bridge vs at the end of the road as it stops the buses. Parents are unaware when the bridge is flooded and road is closed. She requested communication with the Board of Education and the buses that they may pass to pick up students. She reported on the frequency of the floods.

• Marian Boussard – Thanked all for the open public forum for the residents. Thanked Chief Owens for highlighting traffic issues of Station Road and the difficult situations in the area. She asked if the township can use the funds from the infrastructure bill to complete Liberty way. She added the need for neighboring communities to work together and plan for the future.

Mayor Rogers closed the public comment portion at 9:33 p.m.
