She also asked for clarification on the start and end time for the commercial vehicles to operate as she reported the noise pollution is "intense". She asked who in the township is responsible for overseeing the construction of the development.

Mayor Rogers closed the public comment portion at 8:28 p.m.

Mayor Rogers responded that Liberty Way is a collaboration with many entities, including the State and County. Mayor Rogers also stated that she had responded to Mrs. Greer via email regarding the moving of mailboxes. The noise ordinance is available on the township website for review. The residents were advised if noise pollution is a problem, they may report the Police Department's non-emergency number or make a complaint for the township engineer to address. The project is expected to last at least four (4) years and possibly longer.
