The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. On motion by Mr. Taylor, seconded by Mr. Johnson and unanimously carried, the Township Committee Minutes of March 27, 2017 were adopted.

--Mayor Cook reported next week the County will start milling North Main Street from the West driveway to Route 130 and then work will start on Cranbury Neck Road. He stated over the next few months there will also be paving work done on Route 130. Mayor Cook stated the contractor will begin remediation work on the Lake's edge in Village Park.

Mr. Taylor reported he spoke with the Zoning Officer, Mr. Jeff Graydon, who stated he agrees with the Township Committee that the signs at Teddy's and other businesses are not a violation against the Code. Mr. Graydon stated it is not in his job description to police what is inside of buildings. Mr. Taylor stated Mr. Graydon suggested the Historical Society compose a memo to the Township Administrator to have in the file for when the issue is revisited in the future. Mr. Taylor reported for the record that the Historical Society is not looking to penalize the Village businesses that have electric signs. Ms. Goetz inquired if the Code had to be reworded and Mr. Taylor stated Mr. Graydon is comfortable the wording of the Code is very clear.

Mr. Taylor stated he spoke with Mr. Graydon concerning a business that would like to open on Route 130. He stated the usage of the business is not clear, and Mr. Graydon suggested the owner go before the Zoning Board for a usage interpretation. Mr. Taylor stated Mr. Graydon is willing to work with the business owner and has had conversations with the the owner's attorney for clarification on the usage.

Mr. Taylor reported the Woman's Club inquired if the Committee would like them to maintain the barrels by Brainerd Lake. The Committee agreed the Woman's Club can continue to maintain the barrels in the future

without checking with the Committee. Ms. Goetz asked who would be maintaining the baskets on Main Street. Last year a resident donated the flowers for the baskets. Mr. Taylor stated he will reach out to Ms. Audrey Smith to see if the Woman's Club would be interested in being involved.

Mr. Taylor reported he, Mayor Cook and Ms. Marabello will be meeting on Thursday concerning a memo he drafted on traffic safety. He stated the memo prioritizes visibility for the police officers doing traffic patrol on certain roads. Mr. Mulligan supports Mr. Taylor's memo, stating it is not onerous on the police to make traffic safety a priority.

Mr. Mulligan inquired if Mr. Graydon notifies the Township when a zoning interpretation comes in. Ms. Marabello stated Mr. Graydon copies her, and Mr. Mulligan stated it is important the Township is involved so business owners can be given direction and a fair chance to open a business in Cranbury. Mr. Taylor asked if he could be copied on those e-mails since he is a liaison to the Business Association. Mayor Cook stated historically it is the Mayor that is copied and he will determine for relevant issues if Mr. Taylor should be copied.

Ms. Goetz reported she attended the HPC meeting last week and reported clarification is needed about the Master Plan and the Ordinance that sets the buffers around the Historic District. Ms. Goetz reported there is a question about the house near Heritage Park which is technically outside the Historic District but in the buffer zone.

Ms. Goetz stated she was also at the Business Association meeting last week and from conversations she had with developers, Cranbury Township is not difficult to work with. She reported the developers stated they know up front what is required, which saves them time and money during their projects. Mayor Cook stated there are various types of businesses, other than warehouses, that are trying to come into the Township, and the process needs to be easier than in the past. Mr. Mulligan stated it is more challenging for businesses coming into the Village, and it is important for the Township to help.

Mr. Johnson reported he attended a Development Review Committee Meeting. He stated several years ago Prologis was approved to construct three (3) buildings on their Station Road property. He reported they built one (1) building and have come back to request some changes to the original site plan. He stated Prologis wants to construct a second building (500,000 square feet), but not a third. Mr. Johnson stated he attended the Planning Board Meeting and the Amazon warehouse was discussed.

Ms. Cunningham reported Resolution # R-04-17-052 appointing Kristine Donovan to the Municipal Alliance with a term expiring on December 31, 2019 is being added to the Agenda. Ms. Cunningham stated she checked with the Township Attorney and he indicated the Ordinance needs to be pulled this evening and heard on Second Reading and Public Hearing on April 24, 2017 after the Ordinance is properly advertised. Mr. Taylor requested that within 90 days of this Ordinance being adopted a new section of Code detailing the duties of the Deputy Chief and how that position is hired be done. WHEREAS, Chapter 5 of the Code of the Township of Cranbury ("Code") sets forth the establishment of the Police Department and procedures for the promotion to rank above Patrol Officer; and

WHEREAS, changes have been made to procedures by the current Chief of Police during his tenure which have not been amended in the code; and

WHEREAS, the changes need to be codified;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, Middlesex County, New Jersey, as follows:

SECTION 1. The recitals contained in the foregoing preamble are incorporated herein as if fully restated.

Section 5-1 of the Code of the Township of Cranbury ("Code"), entitled "Establishment of Department," is hereby amended and shall read as follows (additions are underlined; deletions are in [brackets]:

§ 5-1 Establishment of Department.

There is hereby established and continued in and for the Township a Department of Police,

also known as the "Cranbury Police Department", consisting of a Chief of Police, <u>a Deputy Chief</u>, up to two Captains, up to two Lieutenants, up to six Sergeants and up to 20 patrol officers as shall be determined from time to time by the Township Committee. All sworn officers, i.e., the Chief, <u>Deputy Chief</u>, Lieutenants, Captain, Sergeants and patrol officers (probationary and permanent), may be referred to as "members".

§ 5-4 Probationary appointment of new members and candidates for promotion; qualifications; residency; duties; compensation; promotion to Sergeant, Lieutenant or Captain

F. No person shall be appointed or promoted to a command or supervisory position above patrol officer unless he or she shall have demonstrated an aptitude for such position. Notices of promotional opportunities to Sergeant, Lieutenant and Captain shall be posted and promulgated by the Chief of Police in accordance with procedures set forth in the Police Rules and Regulations. Successful candidates for these positions will be recommended to the Township Committee. [Successful candidates for these positions shall be assigned by the Chief to perform the duties of the new position for a trial period of up to six months, as determined by the Chief. There shall be no title or compensation change during the trial period. Before or at the end of the trial period the Chief will determine whether or not to recommend the candidate to the Township Committee for promotion.] If the Township Committee promotes the candidate, the promotion shall be subject to a twelve-month probationary status under which the officer shall be given the title and compensation of the office and during which the Chief may return the officer to the lesser rank without notice or hearing. [A promotion shall be made permanent by the Township Committee after successful completion of the probationary period.]

SECTION 2. Repealer. All ordinances and resolutions, or parts thereof, inconsistent with this Ordinance, are hereby repealed.

SECTION 3. Severability. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

SECTION 4. Effective Date. This Ordinance shall take effect immediately upon its passage and publication, as required by law.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CRANBURY, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance is hereby authorized to be undertaken by the Township of Cranbury, in the County of Middlesex, New Jersey (the "Township") as a general improvement. For the several improvements or purposes described in Section 3, there is hereby appropriated the sum of \$2,325,000, including the sum of 116,250 as the down payment required by the Local Bond Law. The down payment is available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the improvement or purpose not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$2,208,750 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. (a) The improvement hereby authorized and the purpose for financing of which the bonds are to be issued for the acquisition of the following real property situated in the Township of Cranbury known as "Ingerman" for affordable housing purposes.

- (b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose is stated in Section 2 hereof.
- (c) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that

the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvement or purpose described in Section 3 of this bond ordinance is not a current expense. It is an improvement or purpose that the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 40 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$2,208,750 and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$25,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose or improvement.

Section 7. Any grant moneys received for the purpose described in Section 3 hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 8. The chief financial officer of the Township is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of obligations of the Township and to execute such disclosure document on behalf of the Township. The chief financial officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Township pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of obligations of the Township and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Township fails to comply with its undertaking, the Township shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 9. The full faith and credit of the Township are hereby pledged to the punctual payment of the principal of and the interest on the obligations authorized by this bond ordinance. The obligations shall be direct, unlimited obligations of the Township, and the Township shall be obligated to levy ad valorem taxes upon all the taxable real property within the Township for the payment of the obligations and the interest thereon without limitation of rate or amount.

Section 10. This bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law.

--Administrator's Report

Ms. Marabello stated she had nothing to report this evening.

--Assistant Administrator

Ms. Cunningham stated she received a communication from Christine Thompson concerning the Township's participation in Cranbury Day on September 9th. Ms. Cunningham will respond the Township Committee will participate. There was discussion about getting a new banner for the Township Committee table.

Public Comment

Mayor Cook opened the meeting to public comment.

Mr. Richard Kallan, Wynnewood Drive, spoke on behalf of the Clock Winding Committee. He reported they met with representatives of Connecticut Time Keepers, who are located in Stratford, CT. He stated they concentrated on the clock movement, although he stated there are many other issues too. Mr. Kallan reported the clock mechanism is in very poor shape and barely working, which results in why the pendulum is moving so slowly. Mr. Kallan gave further report on the condition of the clock and stated it was recommended the clock be stopped so no further wear can take place. Mr. Kallan stated an estimate on an item-by-item basis was requested so a decision on repairs could be made within the Township's budget. Mr. Kallan has no idea what the cost of repairs will be. The Committee agreed it makes sense to stop the clock to prevent further damage. Mr. Kallan reported on the repairs needed in the cupola.

Mr. Kallan thanked the Township Committee for having the meeting tonight since Monday night was the first evening of Passover.

Mr. Mulligan inquired if the Township has any process where once or twice a year the Township buildings are inspected to possibly prevent further damage. Mr. Taylor offered take a vacation day and look through the buildings with Mr. Jerry Thorne, Public Works Manager and Mr. Greg Farrington, Construction Official.

Hearing no additional comments, Mayor Cook closed the public portion of the meeting.

Mayor Cook asked Ms. Cunningham about the insurance course and she stated she knew of two (2) people who took the course. She inquired if any other Township Committee members took the course or were interest in taking it.
