The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Reports and Communications -- Members of Committee

--Mr. Taylor

Mr. Taylor stated there are reports of a new highly-addictive drug called "Pink." Mr. Taylor stated he requested the Police Department to send out a Nixle report on the drug, which is more addictive and more dangerous than heroin. Mr. Taylor stated he also spoke with the Chair of the Municipal Alliance, Kevin Lowery, about the concern that some of the candidates running for Governor next year are in support of legalizing recreational marijuana. He stated due to the tax revenues the sale of marijuana would generate, it is very likely it would be legalized if those candidates were elected to office. Mr. Lowery has put together some ordinances restricting the use of marijuana that Mr. Taylor would like the Township Attorney to review.

Mr. Taylor thanked the Woman's Club and Fire Company for organizing the Christmas Tree Lighting on December 2nd. Mrs. K. will conduct the music, and Santa will be present. Mr. Taylor commended the Public Works Department for their hard work with leaf collection.

--Mr. Cook

Mr. Cook also thanked Public Works for the great job with keeping up with the leaf collection. Mr. Cook reported the Township has the permit for the Lake-edge remediation, which may be done partly in the winter with landscaping work to be completed in the spring.

Mr. Cook reported the fountain on the bridge is completed. The light has been installed and the dog bowl will be added. He thanked all the volunteers who worked on the fountain.

-- Mr. Johnson

Mr. Johnson reported he attended one (1) day of the League of Municipalities Convention and looked at road repair machinery.

--Ms. Goetz

Ms. Goetz reported she also attended the League one (1) day and did see some of the equipment. She stated she also spoke with a company that sets up an app for municipalities, which would post Township news, events, and local businesses' information.

Ms. Goetz reported 15 people volunteered to prepare the garland for the bridge. She stated the weather was beautiful and they decided two hang the garland that day. Ms. Goetz reported two (2) problems: they ran short of garland, and the garland purchased had LED lights. After looking at the garland at night, it was decided the lights were too bright. She stated the company will take the garland back and send the new garland; however, it will not be delivered before the Tree Lighting. Ms. Goetz stated a wreath will be hung on Town Hall, and Public Works will hang the wreaths on the lampposts this week.

--Mayor Mulligan

Mayor Mulligan reported he visited with the Golden Agers and answered many questions about the Township. He reported he received positive feedback on the Township Committee's work.

Mayor Mulligan reported he met with the Four Seasons concerning the ash trees and stated the issue will be reviewed during budget time. Mayor Mulligan reported there was also discussion about the new development, and reported Four Seasons requested additional screening from the developer. He stated for the record the Township is not involved; rather it is a request from Four Seasons directly with the developer.

Mayor Mulligan reported he Committee is working actively on the Library agreement and hopes to have it finalized in December. Ms. Marabello stated as long as the location of the Library and parking lot is determined, it can be finalized. Mr. Cook stated the Library is crunching the numbers to come up with a figure so the Memo of Understanding can be done. Mayor Mulligan stated the Library will need to update the Committee with a drawing or picture of the new location of the parking lot; a presentation by the Library will not be necessary. Mr. Cook stated a new site plan will be drawn up to show the changes.

If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

SECTION 4. Effective Date. This Ordinance shall take effect immediately upon its passage and publication, as required by law.
