The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Dave Cook, Susan Goetz, Glenn Johnson, Jay Taylor, and Mayor Dan Mulligan. Also present were Richard Preiss, PP, Township Planner; Kevin Van Hise, Esq., COAH Attorney; Denise Marabello, Township Administrator/Director of Finance; and Kathleen R. Cunningham, Municipal Clerk/Assistant Administrator. Mayor Mulligan led in the salute to the flag, and Ms. Cunningham gave the following Open Public Meetings Act statement:

Township Committee Minutes of November 28, 2016

On motion by Mr. Cook, seconded by Mr. Taylor and unanimously carried, the Township Committee Minutes of November 28, 2016 were adopted.

Reports and Communications

--Members of Committee

--Mr. Taylor

Mr. Taylor thanked the Cranbury Historical Society, stating there were approximately 180 people who attended the Wassail Event. Mr. Taylor reported work is being done on the sewer line at the History Center, and it has been determined the line can be "snaked" and will not have to be replaced. He thanked Mr. Don Herr and Herr's Plumbing for not charging the Township for the second camera scope. Mr. Taylor stated there is a four-foot square slate on the property, and he requested having Public Works lift the slate to determine what is underneath. He reported the basement windows do not close and the frames are rotting. He requested Public Works purchase plastic domes to cover the windows for the winter. For budget discussions, Mr. Taylor stated some quotes are needed for work on various Township buildings.

--Mr. Cook

Mr. Cook reported the garland is now hung on the railings at Brainerd Lake and stated it looks great. He thanked Ms. Goetz and Mr. Taylor for their efforts.

Mr. Cook reported the Library attended the School Board Meeting, and the Board of Education agreed to move the parking lot 20 feet north. He reported the BOE also agreed to the subterranean basin versus the rain garden as a savings, which will cover the cost of the second site plan. Mr. Cook reported on the contingencies for the bidding process. He stated there is a 5% contingency on the actual build and they are looking into completion bonds in the event they run into fiscal issues based on the bid. He stated the Township Committee should be able to do the Memorandum of Understanding at the December 19th meeting. Mr. Taylor stated he is concerned with Change Orders. Mr. Cook explained Change Orders are discretionary, and if necessary, the Library will have to come up with the additional funding. He stated the amount the Township is committing to is firm. There was discussion about contingency amounts and the

bidding process. Mr. Cook stated the hope is to go to bid in January. He stated there are contingencies built into every phase of the project. He stated once the site plan is finalized, the project will go out to bid and the price comes back, the 5% contingency is added. Mayor Mulligan clarified there is not a hard cost number yet; however, once that number is determined, the Library will need to have the funding before proceeding with construction. Mayor Mulligan stated the Memo of Understanding should contain the wording that the Library must have the funds collected to cover the bid plus the 5% contingency. Mayor Mulligan asked Ms. Marabello to confirm that a 5% contingency is sufficient. There was additional discussion concerning contingencies and change orders. Mayor Mulligan stated the Committee will seek guidance from the professionals concerning the amount of contingency, and the issue will be addressed at the December 19th meeting.

--Ms. Goetz

Ms. Goetz thanked all the volunteers who helped with the holiday decorations, including Mr. Dave Szabo, Ms. Lee Nissen, and Mr. Keith Shaw. Ms. Goetz stated the garland looks beautiful and the lights will be on timers, which have been ordered. She stated some garland and lights will also be hung at Town Hall. Ms. Goetz also thanked the Fire Company for its assistance with the holiday decorating.

--Mr. Johnson

Mr. Johnson reported he attended the Board of Health Meeting and stated the BOH is proceeding with an Ordinance that would prohibit smoking in the Township parks.

Mr. Johnson reported he followed up with the Board of Elections concerning redistricting in the Township. He stated there were difficulties in District 2 on Election Day due to the size of the District. Mr. Johnson explained to the BOE that an additional district was not needed; however, residents could be moved to equalize the size of the existing districts. He further explained the new districts were already drawn up that he could show to the BOE. Mr. Johnson reported he received a call the following day from the BOE, which stated there is a Federal law that prevents the BOE from redistricting within a certain time period of a census. He stated there is a mid-point census (5-year point) and based on those census numbers, the redistricting could be done. Mr. Johnson does not believe the redistricting will be done before the next election.

Reports and Communications

-- Mayor Mulligan

Mayor Mulligan thanked all involved with the holiday decorating and suggested thinking what could be added next year. He stated he received feedback to add decorations in the Business District.

Mayor Mulligan appointed Ms. Donna Eisenhauer to the Recreation Board of Commissioners with a term expiration date of December 31, 2020. The Township Committee agreed with the appointment.

Mayor Mulligan stated the Township is working on changing the truck route on Station Road. He stated residents can request corrections or updates on routes on GPS.gov for the different map providers. Mr. Cook stated trucks should be routed to Route 130 instead of being routed through the business district. Ms. Goetz clarified that at present Station Road is the truck route and that needs to be corrected. Ms. Marabello stated she will be meeting with Chief Varga and Mr. Bill Tanner, Township Engineer to discuss the issue.

Mayor Mulligan stated budget discussions will be in January.

--Subcommittees

There were no reports from Subcommittees.

--Department Heads

Mr. Michael Kervan, Chief of the Cranbury Fire Company gave his report since the last meeting: 28 calls (YTD 487), including a fork lift fire in a warehouse, assisting Hightstown Police Department in apprehending two (2) suspects, a vehicle fire, and a gas leak at the Hagerty construction site. Chief Kervan reported this weekend Santa will be delivering gifts. He stated the Fire Company needs volunteers. He reported for the month there were 168.89 volunteer man hours (YTD 2,418.94 hours).

Mayor Mulligan inquired about the headcount at the Fire Company, and Chief Kervan reported there are three (3) new recruits and the numbers are going in a positive direction.

Mayor Mulligan reported Mr. Sandy Kerzner made a donation in the Township's name to the Diabetes Foundation.

Ms. Cunningham reported there were no additions or changes to the Agenda.

If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

SECTION 4. Effective Date. This Ordinance shall take effect immediately upon its passage and publication, as required by law.

Ms. Marabello stated she had nothing to report.

--Assistant Administrator

Ms. Cunningham stated she had nothing to report.

Reports from Township Boards and Commissions
There were no reports from Township Boards and Commissions.

Public Comment

Mayor Mulligan opened the meeting to public comment.

Mr. Robert Dillon, Hightstown-Cranbury Station Road, addressed the Township Committee concerning the Cranbury Brickyard (CBY) construction near his home. Mr. Dillon distributed a memo and photos of the area near his home depicting the difficulties they are experiencing due the construction. Mr. Dillon stated CBY is the only construction area without deceleration lanes, left turn lanes and shoulders on the roadway. All other warehouse construction sites have these to alleviate traffic hazards. Mr. Dillon stated there is no circulation plan for traffic for the 2.7 million square feet of warehouse being constructed. He stated every vehicle going to the site uses Brickyard Road, not Cranbury Station Road. Mr. Dillon reported the number of trucks passing his home to the site during the months of September through December and stated the trucks start as early as 4:00 a.m. and continue at times through 7:00 p.m. He stated some of the trucks use Jake Brakes to stop at the intersection, which is not permitted by ordinance in Cranbury Township.

Mr. Dillon further described the site and lack of screening, the lighting and the neon signage which all affect his home. He reported the amount of construction dust/dirt affecting his home has increased tremendously. He stated he feels the Township has more consideration for the warehouses on Route 130 and Cranbury Station Road and feels his area is discriminated against. He stated he pays taxes to the Township and feels consideration is not given to him and his neighbors. Mr. Dillon stated the same principles were not applied to the CBY site that were applied to any other site in the Township.

Mr. Dillon requested the Township Committee consider lessening the impact of previous decisions made by the Planning Board, Engineer and Traffic Engineer. Mr. Cook inquired if the Dillon's had brought this information to the Planning Board, and Mrs. Barbara Dillon stated they had been before the Planning Board. She stated the bottom line is that Cranbury Brickyard Road cannot sustain this amount of traffic. Mr. Cook stated much of this traffic is construction traffic, which will eventually end.

There was discussion about the traffic flow and lack of traffic circulation plan. There was also discussion about landscaping, and Mrs. Dillon stated there is no room for landscaping. Mrs. Dillon stated the warehouses are much higher than they should be. Mayor Mulligan inquired if the Engineer is on site during

the construction, and Ms. Marabello stated Mr. Glenn Gerken, PE, has been on site. Mayor Mulligan stated Mr. Dillon's information will be forwarded to Mr. Gerken to review. He stated there are items the Township Committee can address, such as the speed limit. He stated the Township addressed speed limits on all Township Roads recently. Ms. Marabello stated there are laws regulating at what speed limits can be set. Ms. Marabello stated she, Chief Varga and the Township Engineer, Bill Tanner, went to Cranbury Brickyard to look at the road. She stated the road can be 50 mph; however, at the Township's discretion, the speed was made 40 mph. She stated the speed limit for Cranbury Brickyard Road would never be 25 mph. Mr. Taylor stated Cranbury Brickyard is not a County road, and the Township has the authority to set a speed limit of 50, 35 or 25 mph and suggested pushing the 25 mph further out on the road. Ms. Marabello stated Chief Varga and Mr. Tanner have to be consulted concerning the speed. Mayor Mulligan stated Mr. Gerken will be contacted concerning the site.

Mrs. Dillon inquired what action can be taken against trucks riding on the wrong side of the road. Mayor Mulligan encouraged the Dillon's to call the police whenever they see anything illegal occurring. He stated the Police and the Township Committee cannot do anything if they don't know about it. There was discussion about the Township's Ordinance for construction hours, and Mr. Richard Preiss, Township Planner, stated the hours were the same for Residential and Commercial/Industrial Zones. Mayor Mulligan stated if the trucks are out at 4:00 a.m., the Dillon's must call the Police. He inquired the direction the trucks go when leaving the construction site, and Mr. Dillon stated "always right." Mr. Preiss stated he did not remember the details of the traffic study, but stated a very comprehensive review was done by the Traffic Consultant. He further stated the construction is being monitored by Mr. Gerken, and stated the construction is being done according to the site plans. He stated the landscaping, screening and signage were evaluated and approved and all should be done in accordance with the plans. Mr. Preiss stated the landscaping that is utilized in Cranbury now is not to hide the buildings but to hide the truck loading and parking. He stated that is why the Planning Board goes through a huge amount of detail to make sure the buildings are attractive so they can be seen. The Township wants businesses to be successful.

Mrs. Dillon inquired what the Township will do if the road is not able to handle the traffic that will be generated from the warehouse. Mr. Preiss stated the only thing that can be done when approving a site is to project the traffic. He stated Cranbury, unlike many municipalities, requires a post-construction traffic study to monitor the traffic, which is done after the buildings are at a certain percentage of completion. Mrs. Dillon stated it is very dangerous on the roadway when trucks are riding over the double yellow line. Mr. Preiss stated this is now construction traffic; however, Mrs. Dillon stated the trucks will still be large and the road cannot handle it. Mayor Mulligan stated the area around the Dillon's home will be very different than it was the last 45 years, and there is not much that can be done about that, except enforcing the laws that are in effect. He stated the Dillon's need to call the Police, and if the Police are not getting the job done, the Township Committee needs to be notified. He stated the Dillon's information will be passed on to Mr. Gerken to validate that the checklist on the plans is being followed. Mayor Mulligan suggested having him come to the next Township Committee meeting, or if not available then to come in January, to address the Dillon's concerns. Ms. Marabello stated the speed limits would have to be discussed at a subcommittee level before being addressed at a Township Committee meeting. Mayor Mulligan stated the issue would be put on the Agenda as a Work Session item. Mr. Dillon stated he will be coming regularly to meetings now.

Hearing no additional comments, Mayor Mulligan closed the public portion of the meeting.
