

MINUTES OF THE CRANBURY TOWNSHIP  
BOARD OF RECREATION COMMISSION  
VIRTUAL MEETING – November 19, 2020  
7:00 P.M.

**TIME AND PLACE OF MEETING:** The regular meeting of the Cranbury Township Board of Recreation Commissioners was held on November 19, 2020 at 7:00 pm by remote access videoconferencing in response to COVID-19 and the updated Open Public Meeting Act guidelines.

**CALL TO ORDER:** With a quorum present, Kevin McConnell, President, called the meeting to order at 7:00 P.M. and Sonya Harrison acted as Recording Secretary of the meeting.
