- Camp available in six, one-week sessions starting July 6 and ending August 13
- CAMP FEES ARE \$160 per person, per week (Week 1 - July 6-9 is \$130)
- Camp Hours will be from 8:30am-3:00pm
- We will have four groups: K-1, 2-3, 4-5, and 6-8 and will remain separated throughout the day
- Registration fees are NON-REFUNDABLE
- Maximum of 12 campers per group, spaces filled first come, first served
- Camp available to CRANBURY RESIDENTS ONLY
- NEW THIS YEAR - LOCAL WALKING TRIPS WITHIN CRANBURY INCLUDING "LUNCH ON US" once a week

## **Camp Information**

**COVID-19 POLICY – Please read the COVID-19 Policy prior to registering for camp. These policies will be strictly adhered to. Parents/guardians must submit the COVID-19 waiver form with the registration information.**

Please take time to read all of information provided. If you have any additional questions, call the Recreation Office at 609-664-3128.

Camp will be held outdoors at Village Park. This summer, the camp will be open to CRANBURY RESIDENTS ONLY.

### **HOW TO REGISTER**

- Only one registration packet per student is needed.
- You can mail in the Registration Form or drop off at the Town Hall drop box.
- Checks should be made out to “Cranbury Recreation” (Any registration received without payment will be returned).
- PROGRAM CAPACITY - is limited to the first 12 registered children per age group per week. Anyone registering after capacity is met will be placed on a waiting list.
- MEDICAL FORM - Each participant MUST complete and submit a Personal Health & Medical Record form prior to the start of camp or your child WILL NOT be permitted in camp.
- COVID-19 PARENT WAIVER – Each participant MUST read the COVID-19 Policy and complete and submit at COVID-19 Waiver form prior to the start of camp or your child WILL NOT be permitted in camp.

### **REGISTRATION**

We will be offering camp in 6, one-week sessions. You may register for one or all of the sessions.

### **REFUND POLICY**

### **RETURNED CHECK POLICY**

There will be a penalty fee of \$20 for each returned check by the bank for insufficient funds. To maintain registration in the program, payment must be made in cash to the Recreation Dept. in the amount of the returned check. Individuals who are penalized once for a returned check will be required to make all future payments for programs in cash.

### **FINANCIAL ASSISTANCE**

Those individuals seeking financial assistance should contact the Recreation Office prior to registration.

### **BRINGING PERSONAL ITEMS TO CAMP**

The Recreation Department does not encourage campers to bring in personal items from home. If your child does bring items to camp, please label these personal items with your child's full name. The Recreation Department assumes no liability for items brought to camp from home and will not make any type of restitution for missing or damaged items.

### **TRIPS/LUNCH ON US**

Each group will have a local trip (within walking distance of camp) each week. Cranbury Museum, Firehouse, First Aid Station, etc. The camp fees will also include a once a week “Lunch on Us” where we provide lunch for all campers from a local Cranbury establishment.

## **COVID-19 Cranbury Summer Recreation Policies For Campers, Staff & Families**

### **CSRC=Cranbury Summer Recreation Camp**

This COVID - 19 Operational Plan is developed pursuant to N.J. Executive Order 149 which allows for opening of Youth Summer Camps effective July 6, 2020. The plan includes written policies and procedures which must be adhered to in addition to all other regulations issued by the N.J. State Department of Health and guidance provided by the Middlesex County Office of Health Services.

#### **Pre-Camp Training for Staff and Participants**

Cranbury Recreation will conduct on-line training for staff and camper/families which will include updates on the basic principles of emergency first aid, blood borne pathogens, infection control, hand washing practices, personal protective equipment (PPE) and COVID-19 signs and symptoms. At all times, staff will cooperate with state and local health officials should any situations arise that require investigation or follow-up.

#### **DAILY TEMPERATURE TAKING**

Adults must take the campers temperature at home before they leave for camp. If the camper's temperature is above 100.4, do not bring them to camp.

At designated entry points, campers and staff will be screened for fever or signs of COVID – 19 illness prior being permitted to enter the camp or participate in camp programming. Symptoms related to COVID - 19 include:

- Fever or chills
- Cough
- Shortness of breath or difficulty breathing
- Fatigue
- Muscle or body aches
- Headache
- New loss of taste or smell
- Sore throat
- Congestion or runny nose
- Nausea or vomiting
- Diarrhea

If a temperature is recorded at any time above 100.4, the camper or staff member will not be admitted to camp. If symptoms are noticed during the camp day, the camper or staff will be isolated and removed and must be picked up immediately from CSRC. Instances will immediately be reported to the reported to Communicable Disease Services and the Middlesex County Office of Health Services.

#### **FACE COVERING**

Staff and campers will be asked to wear cloth face coverings that completely cover the nose and mouth during check in and dismissal. Staff and campers will also be required to wear cloth face coverings when social distancing of 6 feet between individuals and/or assigned groups cannot be maintained, except where doing so would inhibit that individual's health. Staff and campers will not be required to wear masks when social distancing is being adhered to.

## **Infection Control Strategies**

CSRC management shall implement the following prevention and mitigation strategies to slow and limit COVID - 19 exposure and spread:

1. Require staggering drop off and pick up times to avoid large groups from congregating in one location. When campers are dropped off, parents and children must remain at a minimum of 6 feet from others at all times.
2. Communicate and educate staff, parents, and campers in COVID - 19 safety measures including:
  - Staying home when ill
  - Proper hand hygiene and respiratory etiquette
  - Wearing face coverings
  - Avoiding touching your face as much as possible
  - Reporting illnesses and symptoms to the Camp Director or other staff member at the camp immediately

## **Social Distancing & Other Infection Control Methods**

1. Face coverings are to be worn by campers and are most essential in times when physical distancing is difficult to maintain.
2. Handwash and hand sanitizer stations will be provided in areas around the camp, and hand sanitizer will be provided to staff for their use and to share with campers.
3. Staff will implement enhanced cleaning and disinfection procedures using EPA approved disinfectants and following CDC guidance.
4. Campers will be discouraged from sharing of items that are difficult to clean, sanitize, or disinfect.
5. Infection control procedures will be instituted for areas around the camp, including entrances, dining areas, restrooms, and other areas prone to congregation.
6. There will be a limit on any non-essential visitors, volunteers, and activities involving external groups or organizations.
  - a. Visitors shall be required to wear cloth face coverings while visiting the youth camp unless doing so would inhibit the individual's health. If a visitor refuses to wear a cloth face covering for non-medical reasons and if such covering cannot be provided to the individual at the point of entry, the visitor will be denied entry.
  - b. Group events, gatherings, or meetings where social distancing of at least 6 feet between people cannot be maintained will be avoided. Group size will be limited to the extent possible.
  - c. Field trips and special performances will not be permitted. If the camp becomes aware that an individual tests positive for COVID - 19, we will immediately notify staff and families of a confirmed case while maintaining confidentiality.
7. Actions to take in response to individuals exhibiting signs and symptoms of COVID - 19 (e.g. fever, cough, shortness of breath) while on-site:
  - a. Immediately separate the ill person from the well people until the ill person can leave the camp. The caregiver attending to the ill camper and the camper should wear a face covering and maintain social distancing within the care area.
  - b. Staff members will be sent home and advised on next steps by the Camp Director.
8. Individuals with Suspected or Confirmed COVID-19:
  - a. Individuals (e.g., children, care providers, or staff) who have symptoms consistent with COVID19, will be sent home or denied entry. Refer to the isolation and quarantine chart below to determine when they may return.
  - b. COVID-19 symptoms include cough, shortness of breath or difficulty breathing, fever (100.4° F or higher), chills, muscle pain, sore throat, new loss of taste or smell, or other signs of new illness that are not related to a preexisting condition (such as seasonal allergies).



- c. A suspected case is a person who shows symptoms of COVID-19 but has not yet been tested or is waiting for test results. A confirmed case is a person (with or without symptoms) who received a positive result from a COVID-19 laboratory test.
9. Isolation & Quarantine - timetable for return to camp facilities:  
The following provides information on isolation and quarantine and when individuals may return to childcare facilities.
  - a. Individuals who have symptoms of COVID-19 AND
    - have tested positive (by PCR, rapid molecular or antigen testing) OR
    - have not been tested (i.e. monitoring for symptoms at home)

Should stay home and away from others until:

    - i. At least 10 days have passed since their symptoms first appeared AND
    - ii. They have had no fever for at least 72 hours (three full days without the use of medicine that reduces fever) AND
    - iii. Other symptoms have improved (for example, symptoms of cough or shortness of breath have improved)
  - b. Individuals who have NO symptoms and have tested positive should stay home and away from others until:
    - i. 10 days have passed from the collection date of their positive COVID-19 diagnostic test AND they have not developed symptoms.
  - c. Individuals who have symptoms and have tested negative should stay home and away from others until:
    - i. 72 hours after their fever has ended without the use of fever reducing medications and other symptoms improve.

\*Close contact is defined as being within 6 feet for at least a period of 10 minutes.  
 \*\*Siblings and household members should also remain at home for 14 days.

  - d. If a suspected or confirmed case of COVID-19 infection occurs in one defined group within the center, the ill person will be sent home.
    - I. Other staff and children in the group would be considered close contacts of that case and must be quarantined in their homes for 14 days.
    - II. Parents/guardians and staff facility-wide will be informed of the situation.
    - III. The CDC guidance for cleaning and disinfection should be followed.
    - IV. Other groups within the childcare facility can continue to function, with daily and vigilant screening for illness occurring and social distancing and personal and environmental hygiene measures strictly adhered to.
    - V. If suspected or confirmed cases occur in multiple groups within the facility, then all childcare operations within the facility need to be suspended.
10. Should a staff member or camper test positive for COVID - 19, the Middlesex County Office of Health Services will be contacted immediately as well as the NJ Department of Health and, in addition, response will include the following:
  - a. Establishment of an isolation space.

- b. Adequate amount of personal protective equipment (PPE) will be made available, accessible, and provided for use.
- c. The Camp Director shall contact Middlesex County Office of Health Services and the State Health Department Youth Camp Safety Project for guidance. The appropriate State or Local Health official will provide direction if a camp closure is warranted, following the identification of positive case(s) at the camp. The duration of closure may be dependent on staffing levels, outbreak levels in the community and the number of close contacts the camper had. Staff and children are discouraged from attending another facility if the camp is closed.
- d. Staff will assist the Camp Director in identifying close contacts of positive COVID - 19 cases. This should be done in conjunction with the Middlesex County Office of Health Services.
- e. Staff will close off areas used by a sick person and not use these areas until after cleaning and disinfecting them (for outdoor areas, this includes surfaces or shared objects in the area, if applicable).
- f. To reduce the risk of exposure, we will wait at least 24 hours before cleaning and disinfecting. If 24 hours is not feasible, we will wait as long as possible.

11. Actions to take on returning a staff or camper after COVID - 19 Diagnosis or Exposure

- a. Close contacts and/or sick staff members or campers should not return to camp until they have met CDC's criteria to discontinue home isolation.

#### **IV. Protocols for Camp Facilities**

- A. All camp programs will be held outdoors. Staff will arrange staggering of activities to minimize intermingling between groups of campers. Physical barriers will be provided where necessary and social distancing of 6 feet will be maintained as well as frequent handwashing.
- B. Policy and procedures for cleaning and disinfection: Routine daily cleaning and disinfection prior to camp opening and as much as possible of common surfaces such as shared equipment (staggered use,) benches, tables, seats and bathrooms. This also includes disinfecting of all shared objects, equipment, supplies, etc. using an approved sanitizer as outline by the CDC.
- C. Signage will be posted promoting show social distancing, handwashing, face coverings, and other prevention methods.

#### **V. Attendance Requirements**

- A. Ensure, to the maximum extent possible, that groups include the same group of children each day and that the same staff remain with the same group of children each day. Ideally, groupings developed on the first day will remain intact throughout the duration of the camp session or season whichever is longer.
- B. Camp staff should minimize camper movement between groups. Groups shall stay together and if interactions with other groups occur, social distancing must be maintained between groups.
- C. Staff and campers must social distance and wear face covering especially when social distancing cannot be maintained.



- D. Proper Staff ratios for campers must be maintained according to the New Jersey Youth Camp Safety Standards.
- E. If campers bring their own food or drink, social distancing is to be provided during consumption of any food or drink items.

## **VI. Sports Activities**

- A. When participating in any sports activities, campers should adhere to social distancing procedures.
- B. Campers and staff must be cognizant of sports etiquette regarding social distancing and hygiene (i.e., no spitting, high-fives, handshakes, etc.)
- C. Staff and campers should avoid use of items that are not easily cleaned, sanitized, or disinfected (i.e., soft or plush toys, equipment, or supplies)
- D. Reusable items for use by staff and campers should be cleaned, disinfected and air-dried after each use and prior to being reused.

THE ATTACHED WAIVER AFFECTS IMPORTANT LEGAL RIGHTS YOU, YOUR CHILD(REN) AND/OR YOUR OTHER FAMILY MEMBER(S) AND/OR DEPENDENT(S) MAY HAVE IN THE EVENT YOU, YOUR CHILD(REN), AND/OR OTHER FAMILY MEMBER(S)/DEPENDENT(S) BECOME EXPOSED TO, INFECTED WITH, OR SUSTAIN BODILY INJURIES AND/OR PROPERTY DAMAGE FROM HIGHLY CONTAGIOUS VIRUS(ES) AND DISEASES.

#### **I. Background and Purpose**

The CRANBURY TOWNSHIP and the CRANBURY TOWNSHIP Department of Recreation (hereinafter jointly and separately referred to in the attached WAIVER as the "CRANBURY TOWNSHIP") sponsor(s) and offer(s) to the public the option of participating in or attending a variety of indoor and outdoor physical, social and educational programs and activities, including competitive and non-competitive sports and sporting events, organized leagues, day camps, games, and instructional/training programs and camps (collectively referred to hereinafter and in the attached WAIVER as the "RECREATION PROGRAM(S)"). These RECREATION PROGRAM(S) are held on CRANBURY TOWNSHIP property and other public and semi-public places that are accessible to large numbers of people on a daily basis.

Due to the ongoing COVID-19 pandemic, and until further notice, any adult age 18 or older wishing to enroll themselves, their child(ren) or any other dependent(s) family members into a CRANBURY TOWNSHIP RECREATION PROGRAM, or seeking to otherwise voluntarily participate in a CRANBURY TOWNSHIP RECREATION PROGRAM as a coach, counselor, instructor, referee, official, or volunteer, is required to complete, sign and return this WAIVER TO CRANBURY RECREATION by no later than the enrollment deadline set for the specific RECREATION PROGRAM in which participation/access is sought.

Enrollment and participation in any CRANBURY TOWNSHIP RECREATION PROGRAM(S) and permission to access any CRANBURY TOWNSHIP facilities/property and equipment to participate in or use at a RECREATION PROGRAM is expressly conditional on properly completing, signing, and returning this WAIVER in a timely manner.

**Access to and participation in any CRANBURY TOWNSHIP RECREATION PROGRAM(S) and/or CRANBURY TOWNSHIP facilities, property and equipment used in a RECREATION PROGRAM may be denied or revoked at any time for failure to properly complete, sign and return this WAIVER.**

By signing this WAIVER and initialing each page, I/WE acknowledge and agree that I/WE have been provided with, read and fully understand: (i) the Center for Disease Control's ("CDC") and the New Jersey Department of Health's ("NJDOH") information and guidelines for preventing/protecting against, and recognizing the signs and symptoms of, infection for SARS-CoV-2 (the virus that causes COVID-19) and the related illnesses and medical conditions called COVID-19 and Multisystem Inflammatory Syndrome in Children ("MIS-C")(collectively the "PANDEMIC ILLNESSES"); and the CRANBURY TOWNSHIP DEPARTMENT OF RECREATION'S "COVID-19 Operational Plan" for 2021.

I/WE further acknowledge, understand and agree that:

1. The CDC and NJDOH have determined that the PANDEMIC ILLNESSES are highly contagious viruses, diseases and medical conditions.
2. Exposure to or infection from these PANDEMIC ILLNESSES may cause serious permanent bodily injury, including respiratory failure, cardiac arrest, and death in healthy persons of all ages.
3. These PANDEMIC ILLNESSES are new. The standards and recommendations on how to prevent and protect against the risk of exposure to infection and the spread of these PANDEMIC ILLNESSES continues to change as more data becomes available.
4. These PANDEMIC ILLNESSES presently exist and remain prevalent throughout all areas of the State of New Jersey and continue to infect persons and spread throughout all counties and local communities, including the residents of the CRANBURY TOWNSHIP.
5. These PANDEMIC ILLNESSES have a high probability of spreading to person(s) who are either in direct contact with, or in close proximity to (within about 6 feet or 2 meters) an infected person.
6. The CDC and NJDOH believe these PANDEMIC ILLNESSES are most likely to spread from person to person by droplets produced into the air when an infected person coughs, sneezes, talks or otherwise moves air out through their nose and mouth; and from touching/contacting surfaces on which droplets containing the virus exist.

7. There is no known vaccination(s), immunization(s) or cure for these PANDEMIC ILLNESSES.
8. The CDC and the NJDOH maintain that the best way to prevent and protect against infection and/or spread of these PANDEMIC ILLNESSES is to self-quarantine and to avoid contact with other individuals, large gatherings and spending time in public places and buildings.
9. CRANBURY TOWNSHIP and the CRANBURY TOWNSHIP DEPARTMENT OF RECREATION ("CRANBURY TOWNSHIP") sponsor(s) and offer(s) to the public the option of participating in or attending a variety of indoor and outdoor physical, social and educational programs and activities, including competitive and non-competitive sports and sporting events, organized leagues, day camps, games, and instructional/training programs and camps ("RECREATION PROGRAM(S)") which are essential to the social, physical, educational and character development and the mental and physical health of the public.
10. Attending or participating in any CRANBURY TOWNSHIP RECREATION PROGRAM poses an inherent risk of infection and a heightened risk of injury from and exposure to these PANDEMIC ILLNESSES regardless of the measures taken by the CRANBURY TOWNSHIP: (i) to avoid close contact with other persons, including infected persons; (ii) to disinfect CRANBURY TOWNSHIP facilities, equipment and public property; and (iii) to discover, contact trace, and quarantine infected persons and/or persons exhibiting signs and symptoms of infection of these PANDEMIC ILLNESSES.
11. Attending and/or participating in a CRANBURY TOWNSHIP RECREATION PROGRAM may also increase the risk of exposure to these PANDEMIC ILLNESSES and the further spreading of these PANDEMIC ILLNESSES to other family members, PROGRAM PARTICIPANTS, and third persons.

By signing this WAIVER, I/WE do further acknowledge the contagious nature of these PANDEMIC ILLNESSES, and that an inherent and heightened risk of danger to infection and exposure to these PANDEMIC ILLNESSES exists for all PROGRAM PARTICIPANTS, persons and other participants attending any CRANBURY TOWNSHIP RECREATION PROGRAM at this time. I/WE acknowledge and agree to voluntarily assume all risks that I/WE, the PROGRAM PARTICIPANT(S), and our other family member(s) may be exposed to or infected by these PANDEMIC ILLNESSES by attending or participating in any CRANBURY TOWNSHIP RECREATION PROGRAM; and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I/WE understand that the risk of becoming exposed to or infected by these PANDEMIC ILLNESSES at a CRANBURY TOWNSHIP RECREATION PROGRAM may result from the actions, omissions or negligence of myself and others, including, but not limited to the CRANBURY TOWNSHIP'S officials, officers, employees, and volunteers; and other participants/attendees of the RECREATION PROGRAM and their families.

I/WE, on behalf of ourselves, the PROGRAM PARTICIPANT(S) and the other dependents of my/our household, I/WE voluntarily agree to assume all of the foregoing risks, and do accept sole and complete responsibility for any and all injuries, damage(s) and other losses to the PROGRAM PARTICIPANT(S), my/our other dependent(s), the other members of my/our family, and/or to myself/ourselves for attending or participating in a CRANBURY TOWNSHIP RECREATION PROGRAM, including for all bodily injuries, disabilities, permanent disabilities, deaths, illnesses, damages, losses, claims, demands, liabilities, medical treatment and expenses, attorneys fees, costs of suit and/or expenses of any kind that is incurred in connection with attending or participating in any CRANBURY TOWNSHIP RECREATION PROGRAM.

I/WE, on behalf of myself/ourselves, the PROGRAM PARTICIPANT(S), my/our other household members and/or dependents, HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, WAIVE AND HOLD HARMLESS CRANBURY TOWNSHIP, THE CRANBURY TOWNSHIP DEPARTMENT OF RECREATION, AND EACH OF THE CRANBURY TOWNSHIP'S OFFICIALS, OFFICERS, EMPLOYEES AGENTS, VOLUNTEERS AND REPRESENTATIVES FOR AND FROM ANY AND ALL CLAIMS, DAMAGES, DEMANDS, LOSSES, LIABILITIES, ACTIONS, COSTS AND EXPENSES OF ANY KIND ARISING OUT OF OR IN ANY WAY RELATING TO THE ACCIDENTAL AND/OR NEGLIGENT EXPOSURE TO THESE PANDEMIC ILLNESSES FROM ATTENDING OR PARTICIPATING IN ANY CRANBURY TOWNSHIP RECREATION PROGRAM(S).

I/WE UNDERSTAND AND AGREE THAT THIS WAIVER AND RELEASE INCLUDES ANY AND ALL CLAIMS BASED ON THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF THE CRANBURY TOWNSHIP, THE CRANBURY TOWNSHIP DEPARTMENT OF RECREATION AND THE CRANBURY TOWNSHIP MUNICIPALITY'S OFFICIALS, OFFICERS, EMPLOYEES, AGENTS, VOLUNTEERS AND REPRESENTATIVES, REGARDLESS OF WHETHER INFECTION FROM THESE PANDEMIC ILLNESSES OCCUR BEFORE DURING OR AFTER PARTICIPATION AND/OR ATTENDANCE IN ANY CRANBURY TOWNSHIP RECREATION PROGRAM(S).

By signing this agreement, I/WE further acknowledge that I/WE have read and discussed with the PROGRAM PARTICIPANT(S) the provisions of this WAIVER and the dangers and risks associated with attending and/or participating in any of the CRANBURY TOWNSHIP'S RECREATION PROGRAM(S); the PROGRAM PARTICIPANT(S) fully understand(s) and appreciate(s) these dangers and risks; and the PROGRAM PARTICIPANT(S) voluntarily wishes to enroll in, participate and otherwise attend the CRANBURY TOWNSHIP'S RECREATION PROGRAM.

This WAIVER does not supersede, circumvent, or cancel CRANBURY TOWNSHIP Recreation Department's Main Participation Agreement or Rules and Regulations.

If any part of this WAIVER is found by a court of competent jurisdiction to be invalid, the remainder of this WAIVER release from liability shall nevertheless remain in full force and effect and the offending provision or provisions severed here from.

I/WE, have read and accept the terms and conditions of this, and acknowledge and agree that it shall, to the fullest extent allowed by law, be effective upon me, and my respective heirs, personal representatives, and estate.
