Also, discussion on a 1 mile color-themed run. Maybe a table set up every ¼ mile w/colored powder that can be tossed at runners as they pass as an incentive. Offering prizes for the run. Ideas of having student council sit at the tables as well as peer leaders. Instruction on mindful meditation for women. Also demonstration of proper use of a handwashing station.

Secretary Engelbert was asked about ordering inflatables. She thought Board was going to discuss the budget first. She also mentioned using a rock climbing wall. Lt. Owens suggested using Mark the Fireman who owns bouncy houses, cotton candy machines and other fair-related items.
