# Community Forestry Plan -

<u>Volunteer Work Hours</u> – Mrs. Larson worked one hour; Ms. Easton worked 11 hours; Mrs. Swale worked two hours.

<u>EAB in Cranbury</u> – The trees in Four Seasons are all down. Sav-A-Tree did the work. The stumps remain. Ms. Easton met Rutgers and state officials and participated in an overwintering larval study.

Three quotes will be gathered for the re-write of the CFMP.

Tree Planting Plan- There is no plan for 2017.

<u>Arbor Day</u> – Ms. Easton and Mrs. Larson will decide on the location of the planting on Main Street and the species for the ceremony.

<u>Young Tree Pruning workshop</u> – Paul Cowie will conduct this workshop for board members and the DPW on Thursday, June 15, at 9:00 a.m. at the township offices. The Environmental and Parks Commission members will be invited. Pruning will be conducted off site.

<u>NJISST conference</u> – Ms. Easton attended this with Barbara Rogers, the chair of the Environmental Commission. They received an updated report on the Emerald Ash Borer in New Jersey, that the insect is spreading quickly; and the biological management of EAB. Also communications of awareness of emerging invasive plants in town.

<u>Applewood</u> – Ms. Easton will contact Secretary of the Planning Board Josette Kratz on the tree planting plan and removal of the No Net Loss trees.
