TOWNSHIP COMMITTEE MEETING BUDGET MEETING January 20, 2020

The Township Committee Budget Meeting of the Township of Cranbury was held at 9:00 a.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Michael Ferrante, Barbara Rogers, Evelyn Spann, Jay Taylor and Mayor Scott. Also present was Denise Marabello, Township Administrator/CFO and Acting Clerk. Mayor Scott led in the salute to the flag, and Ms. Marabello gave the following Open Public Meetings Act statement:

Lieutenant DeChiara discussed requests made within the Capital Budget which include; vehicle purchases, message boards and computer equipment. All were approved by the Township Committee.

Capital Plan – Various items were discussed and approved. The Township Committee asked that the Village Park walking path be looked at further by Thomas Decker, Township Engineer. To be discussed at a future Township Committee meeting.

Use of Surplus and Tax Rate – The Township Committee agreed to a flat tax rate for Cranbury residents and to use \$1,600,000 of surplus to fund the dredging of Brainerd Lake.

Salary Pool – The Township Committee agreed with the salary pool presented.

LOSAP - (Mr. Taylor recused himself and left the dais during LOSAP discussion) The Township Committee agreed to provide the maximum amount allowed by the State.

Fire and First Aid Contribution – The Township Committee agreed to provide the maximum contribution of \$154,518.75 to the Fire Company. Not to be paid until they provide financials showing what they used last year's \$150,000 on. The Township Committee agreed to provide the maximum contribution of \$70,000 to the First Aid Squad and an additional \$35,000 upon receipt of an audit.

Operating Expense Increases – Ms. Marabello presented the line item increases.

The Mayor opened the meeting to public comment. No public comment.

Mayor Scott closed the public comment portion of the meeting.

Mayor Scott requested a motion to adjourn. On motion by Mr. Ferrante, seconded by Ms. Spann and unanimously carried, the meeting adjourned at 12:05 p.m.
