--Mayor Taylor reported he conducted a reading program at the Cranbury Public Library last Saturday. He read a letter received from New Jersey Monthly responding to a letter he sent to them concerning Cranbury's ranking on a "Best Places to Live" list. He stated he received a nice letter back from the Publisher who will have the Editor contact Mayor Taylor to address his questions. He thanked the Cranbury Lions Club for a wonderful parade.

Mayor Taylor reported a Proclamation will be read for the Bookworm on June 12<sup>th</sup> to welcome them back to Town.

Reports and Communications

--Members of Committee

Mr. Cook

Mr. Cook reported if all goes well with the Township Engineer on Tuesday, the Township should have the RFP for the Village Park remediation project, which includes addressing severe erosion on the Lake's edge.

Mr. Cook discussed the electrical capabilities on the Brainerd Lake Bridge. He stated an RFP must be done to do the electrical work on the Bridge, which was not part of the County Project. He asked for the Committee's input on having either permanent or temporary lighting capability for skating in the winter. He reported the difference in cost for permanent or temporary lighting would run "north of \$10,000" for the fixed lighting. Mayor Taylor stated the residents appreciated the Fire Department lighting the Lake last winter. He asked Mr. Cook if any consideration was given to having a system to play music. The Township Committee was in favor of the temporary lighting fixtures.

Mr. Mulligan

Mr. Mulligan stated ceiling fans would be a great addition to Town Hall.

Mr. Mulligan stated he placed "Slow Down" traffic signs on Station Road between South Main Street and Route 130, and stated he received very positive feedback from the neighbors. He stated he would like to find funds to purchase more signs for around Town or rotate these signs.

Ms. Goetz stated she feels the signs lose their impact if they remain in one place for a long time.

Mayor Taylor stated he asked Chief Varga about the funding for the new signs that will be needed as a result of the new traffic study. Mayor Taylor stated the signs are fairly costly and is hoping grant money is available to help purchase the signs.

Ms. Goetz

Ms. Goetz reported two (2) weeks ago Princeton Hydro applied the first application of herbicide treatment on the Lake. She stated residents were notified by regular and certified mail and information was posted on the Township's website. She stated right now there are a lot of dead leaves on the Lake. She reported Princeton Hydro did an assessment to determine what types of weeds were in the Lake so the proper herbicide could be applied. Ms. Goetz reported Princeton Hydro noticed the Lake has an invasive species called the water chestnut, which grows in shallow lakes and is a very aggressive grower. She stated there is an herbicide to handle the water chestnut; however, that herbicide is used to handle a mass of plants. She stated Brainerd Lake has clusters here and there. Ms. Goetz stated the consultant had to report the water chestnuts to the State because the State keeps a list of the bodies of water containing water chestnuts, and there is an eradication team to address them. She stated if the problem is not addressed, the Lake and fish will eventually be choked off. Ms. Goetz reported on Saturday a team of people will go out in canoes and will wear leather gloves to pull out the water chestnuts. The plants will be put into plastic bags and will then be thrown out. She stated this recommended process will need to be done routinely.

Ms. Goetz reported on Tuesday night there will be a public meeting hosted by the Subcommittee at 7:00 p.m. in the Community Room on the concept plan for the redevelopment of the Cheney, Hagerty and Kushner tract.

Mr. Johnson

Mr. Johnson reported since last meeting he attended a Board of Health meeting, a Library Facilities Meeting and Shade Tree Commission meeting. He stated he and his wife attended the Presbyterian Church's Strawberry Festival.

Agenda Additions/Changes

Ms. Cunningham reported Resolution # 06-15-071 was being removed from the Consent Agenda as the signed agreement has not been received back from Corner House. She reported Resolution # 06-15-076 is being added to the Consent Agenda. She stated this Resolution authorizes the Mayor and Clerk to sign a Rights-of-Way Use Agreement with Cross River Fiber, Inc.

Public Comment - For Agenda Items

Mayor Taylor opened the meeting to public questions and comments for items on the Agenda. There being no comments, the public portion of the meeting was closed.

WHEREAS, 143-3 Speed Limits of this chapter addresses speed limits for both directions of traffic along the following streets or parts of streets; and

WHEREAS, the Township of Cranbury Police Department has requested a complete list of streets with speed limits be included in the Code; and

WHEREAS, the Township Engineer has certified by statute or speed survey that the following speed limits be established.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, Middlesex County, New Jersey, as follows:

Unless another penalty is expressly provided by New Jersey statutes, every person convicted of a violation of this ordinance or any supplement thereto shall be liable to a penalty of not more than \$50 or imprisonment for a term not exceeding 15 days or both.

SECTION 2. Repealer. All ordinances and resolutions, or parts thereof, inconsistent with this Ordinance, are hereby repealed.

SECTION 3. Severability. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

SECTION 4. Effective Date. This Ordinance shall take effect immediately upon its passage and publication, as required by law.

RESOLUTION DIRECTING THE PLANNING BOARD TO INVESTIGATE WHETHER  
BLOCK 10, LOT 10 AND BLOCK 12, LOT 1 CAN BE CONSIDERED  
A NON-CONDEMNATION AREA IN NEED OF REDEVELOPMENT

WHEREAS, the Local Redevelopment and Housing Law gives a municipal governing body the power to cause a preliminary investigation to be made to determine whether an area of the municipality is in need of redevelopment (*N.J.S.A. 40A:12A-4a(1)*); and

WHEREAS, pursuant to the Local Redevelopment and Housing Law, no area of the municipality shall be determined to be a redevelopment area unless the governing body of the municipality first, by resolution, authorizes the planning board to undertake a preliminary investigation to determine whether a proposed area is a redevelopment area according to statutory criteria (*N.J.S.A. 40A:12a(6)*); and

WHEREAS, the tract consists of the following lots identified on the tax maps of the Township of Cranbury: Block 10, Lot 10 and Block 12, Lot 1, and is commonly referred to as the "Cranbury Brick Yard"; and

WHEREAS, Lot 10 of Block 10 is a 372.77 acre parcel that is generally rectangular, and is bounded by New Jersey Highway Route 130 to the west, Brick Yard Road to the south and Hightstown-Cranbury Station Road to the east, while Lot 1 of Block 12 is a 19.43 acre triangular parcel, bounded by Hightstown-Cranbury Station Road to the west, the New Jersey Turnpike to the east and Brick Yard Road to the south; and

WHEREAS, the identified parcels are both in the L-LI Zone; and

WHEREAS, the identified parcels are located at: 22 Hightstown-Cranbury Station Road; and

WHEREAS, the Township Committee would like the Cranbury Township Planning Board to determine whether the "Cranbury Brick Yard" can be considered a "non-condemnation area in need of redevelopment," pursuant to the Local Redevelopment and Housing Law; and

WHEREAS, the redevelopment area determination shall authorize the municipality to use all those powers provided by the Legislature for use in a redevelopment area other than the use of eminent domain.

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Cranbury in the County of Middlesex, State of New Jersey, that the Cranbury Township Planning Board is directed to undertake a preliminary investigation to determine whether the tract of land that includes Block 10, Lot 10 and Block 12, Lot 1, is an area of the municipality in need of redevelopment, according to the criteria set forth in the Local Redevelopment and Housing Law.

A Resolution Requesting the Governor and State Legislature to Create a Statewide Special Task Force on Volunteer Retention and Recruitment for Long and Short Term Strategies

**WHEREAS**, the overwhelming majority of municipalities in the State of New Jersey depend upon volunteer firefighters and/or volunteer EMS personnel to provide first responder service; and

**WHEREAS**, for some time now, there has been a reduction of new volunteers willing to serve their communities and difficulty retaining existing trained and experienced members; and

**WHEREAS**, the men and women of our volunteer departments sacrifice their family, employment and recreational time to provide dedicated and caring service to their communities with no compensation; and

**WHEREAS**, the cost in a community of providing paid services, in the event local volunteer services were no longer available due to a lack of volunteer personnel, would create an unthinkable and unbearable hardship on the municipality and local taxpayer;

**NOW, THEREFORE BE IT RESOLVED**, that the Township Committee of the Township of Cranbury, County of Middlesex request the Governor and State Legislature create a Statewide Special Task Force on Volunteer Retention and Recruitment to develop short term and long term strategies, incentives and policies to insure that the state's volunteer first responders ranks stabilize and grow to be able to adequately service the communities where they exist; and

**BE IT FURTHER RESOLVED**, that the Township Committee of the Township of Cranbury recommends that the task force schedule regional workshops/focus group meetings with volunteers and local officials to fully understand the issue and to assist them with the development of their plan recommendation; and

**BE IT FURTHER RESOLVED**, that the Municipal Clerk of the Township shall forward a certified copy of this Resolution to Governor Chris Christie and the New Jersey State Legislature for their attention and consideration.

Public Comment

The Mayor opened the meeting to public questions and comments.

Mr. Richard Kallan, Wynnewood Drive, asked the Township Committee's thoughts on trying to make Old Trenton Road look narrower. He stated the road is very wide and without thinking, it is very easy for drivers to increase their speed. He asked if the Committee would consider placing an island in the middle and would the County pay for it. There was additional discussion about the speed limit on Old Trenton Road and ways to make the road narrower to slow down traffic.

Mr. Jerry Riccardi, Jersey Central Power & Light, stated he wanted to bring to the Township Committee's attention JCP&L's website which allows residents to report power outages, street light outages and also access personal account information, which you need to sign up for. Mr. Riccardi described the other features of the website. He explained how the power outage system works. The Committee thanked Mr. Riccardi for the information.

Ms. Connie Bauder, Petty Road, spoke against the Speed Ordinance which was introduced. She stated she is against lowering speeding limit on Plainsboro Road. She stated it is a waste of time and money and will not be enforceable. The Ordinance will be addressing all roads in the Township. Mayor Taylor stated if you are driving on an unsigned country road, the speed limit is 50 mph. He stated right now Plainsboro Road is 45 mph. The main issue is to curtail speeding into the Township. Ms. Bauder stated she was against lowering the speed limit.

Ms. Bauder stated dredging the Lake is a mistake now if there will be work on Liberty Way. She stated sediment will be coming downstream, and it will be a waste of money to dredge the Lake. Ms. Goetz addressed the dredging, stating it is something that has to be done periodically. She stated the plan is to dredge the Lake from the Bridge down and to excavate deeper by the Bridge. There was additional discussion about dredging and about frequently it must be done. The last time the Lake was dredged was in 1975.

Mayor Taylor stated the Liberty Way Project is on the Master Plan; however, it is not something that the Township will be doing in the next few years. Mr. Cook stated there is really no way to fund the Project.

There being no comments, the Mayor closed the public portion of the meeting.
