

TOWNSHIP COMMITTEE MEETING
October 28, 2013

The regular meeting of the Township Committee of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: David Cook, Susan Goetz, Daniel Mulligan, Jay Taylor and Mayor Glenn Johnson. Also present were Denise Marabello, Township Administrator/Director of Finance and Kathleen Cunningham, Municipal Clerk/Assistant Administrator. Mayor Johnson led in the salute to the flag, and Ms. Cunningham gave the following Open Public Meetings Act statement:

Ms. Goetz stated she wanted to clarify the minutes reflect the Downtown Beautification Project costs signed for in the bid are covered by a grant; however, she stated there are a couple of items such as the light posts that are not covered. Ms. Goetz stated she wanted the public to be aware that a few items outside of the bid specs are not covered by the grant. On motion by Mr. Taylor, seconded by Ms. Goetz, and unanimously carried, the Regular Township Committee Minutes of October 14, 2013 were adopted.

Reports and Communications

--Mayor

Mayor Johnson reported he would defer his report until the next meeting.

--Township Committee

Mr. Mulligan reported a Plainsboro Road resident inquired about the timeline to correct the Plainsboro Road drainage issue. Mr. Mulligan stated residents would like to be "kept in the loop" concerning the timeline. Ms. Marabello has been working with the Township Engineer and stated survey work has already started there.

Mr. Cook stated, as previously reported, the Brainerd Lake Bridge and Dam Project was awarded to Rock Solid. He reported Rock Solid submitted their bonding to the County; however, the County wants some of the language revised before issuing the Notice to Proceed. Signs should be erected this week alerting residents to the upcoming construction.

Mr. Taylor reported residents have been giving him positive feedback on Cranbury's new Channel 3 station and stated residents are already watching the new channel. Mr. Taylor reported he will be meeting with Ms. Marabello and Chief Rickey Varga to discuss security for the upstairs offices.

--Township Committee (Continued)

Ms. Goetz stated HPC brought to her attention the possibility of a grant application for up to \$24,000 non-matching funds that HPC would like to commit to downtown beautification. Ms. Goetz stated HPC will need assistance completing the extensive grant application. Ms. Goetz asked if Bill Tanner, Township Engineer, could assist with the application, and Ms. Marabello agreed. Ms. Goetz stated if a grant is received, HPC would like to expand on the downtown beautification effort.

Ms. Goetz reported she and Mr. Cook heard from the Historic Society and the Woman's Club and both are eager to extend their help to supplement the beautification efforts, both downtown and on the Dam. Ms. Goetz stated no specific plans are set yet; however, both groups have stepped up to offer their assistance. Mr. Cook stated there is an interest on having flowers on the lights, similar to Hightstown; however, Ms. Goetz stated an irrigation system is not part of the current project because of a shortage of funding.

Ms. Goetz reported the Environmental Commission is concerned with the water runoff from car washings. She stated car washes are a common means of fund raising in Cranbury; however, there is a problem with the runoff going into the Creek. Next week the Environmental Commission is doing a pilot study in the storm water swale by the Fire House to see if it is a suitable place for a rain garden. The idea would be to refocus the water through a rain garden instead of into the Creek so that the runoff water would be filtered before reaching the Creek.

Mr. Mulligan stated several residents spoke to him about the lighting on Main Street and also inquired if the light posts could have electrical sockets to plug into. Ms. Goetz stated the Township does not own the light posts, but rather leases them from the utility company. She stated there is no way to meter the usage if there are plugs on the poles.

There were no Subcommittee reports.

Agenda Additions/Changes

Ms. Cunningham reported there were no agenda additions or changes.

Public Comment (For Items on the Agenda)

Mayor Johnson asked if the public had any comments on agenda items. Mr. Bill Kanawyer, Brainerd Drive, asked that while the security of the building is being discussed, consideration for access to the building be given to the Clock Winding Committee. Mr. Kanawyer asked if the products used for the car washes were biodegradable. Ms. Goetz stated the Environmental Commission is looking into all aspects of the impact of car washes. She stated the EC does not want to stop car washes but wants to minimize the potential negative impact on the environment.

Hearing no public additional comment, the Mayor closed the public portion of the meeting.

- a). Discussion on Implementing a Volunteer Incentive Program for the Cranbury Volunteer Fire Company and the Cranbury First Aid Squad.

Mr. Taylor left the dais.

The Township Committee discussed implementing a Volunteer Incentive Program to attract and retain volunteers for the Cranbury Volunteer Fire Company and the Cranbury First Aid Squad. As background for the public, Mayor Johnson explained the Fire Company had forwarded to the Township Committee some ordinances from other municipalities which provide incentives for volunteers. Mayor Johnson stated in general the incentives included forgiving the some Township fees. The Fire Company requested the Township Committee consider offering incentives in Cranbury. The purpose of the incentives would be to attract and retain volunteers in the Fire Company and First Aid Squad.

Mr. Cook stated Cranbury has a volunteer Fire Company, and stated the budget cost of paying for members would be a financial burden to the Township. Mr. Cook stated the idea is to create an environment to retain existing volunteers and also to bring in new members. Mr. Cook stated fees and possibly a monetary incentive would be discussed as a package. Possible fees to waive would include fees for park rental, dog and cat licensing, construction permits and recreation. He stated the incentives would not just be for new members coming in but for existing volunteers as well.

Mr. Mulligan stated the current incentive is LOSAP, which is \$1,585 annually. He stated the goal was to look at how to enhance the incentives. Mayor Johnson stated last year the Committee called municipalities last year to ascertain what they paid in LOSAP. He stated most municipalities pay less LOSAP than Cranbury. Mr. Cook stated he did not know the financial impact of waiving fees for volunteers. Ms. Goetz stated she doubted not having permit fees waived would prevent volunteers from joining the departments. Ms. Marabello explained dog/cat licenses and construction permits have portions that must be paid to the State, and stated \$5.80 of every dog license is sent to the State. Ms. Marabello presented the numbers of volunteers who had pets and stated it was minimal. Fees for construction permits would vary depending on when members applied for construction permits. She stated there are currently 31 Cranbury residents in the First Aid Squad and Fire Department. Ms. Marabello stated the volunteers would have to pay the State portion of fees and the Township portion could be waived.

Mr. Cook asked Mayor Johnson if there was a municipality he would like to use as a model for Cranbury. Mayor Johnson stated instead of specifying a menu of free permits and license fees, one municipality reimburses a first responder up to \$500 per year. For budgetary purposes in Cranbury, the worst case scenario of every responder using the maximum \$500 allowed, \$19,000 would have to be reflected as a line item. Mayor Johnson stated probably most of that would not be spent. Ms. Marabello stated that \$19,000 would have to be put in the Operating Budget, and volunteers would have to provide receipts to be reimbursed. Mr. Cook asked about offering a lower amount, and Mr. Mulligan suggested \$250. Mr. Cook asked if the waived fees would be decided tonight and Mayor Johnson stated all fees would apply except those that cannot be waived (taxes and sewer hook-ups). There was additional discussion on the fees to be waived and the requirements necessary to be eligible. Mr. Mulligan stated waiving fees is a way to retain members, but suggested having something, like a sign-on bonus to attract new members. Ms. Marabello stated she did not see anything about sign-on bonuses from other municipalities.

a). Discussion on Implementing a Volunteer Incentive Program for the Cranbury Volunteer Fire Company and the Cranbury First Aid Squad.

The Committee decided to start with a \$250 allowance for each member and revisit the incentives again in the future. Ms. Marabello stated an Ordinance will be needed. Ms. Goetz inquired if it would be beneficial to speak to the First Aid Squad and Fire Department to see if this was enough incentive.

Mr. James Taylor, South Main Street, spoke as a resident and stated he wanted to clarify a number of items. Mr. Taylor reported that eligibility for incentives was defined as volunteers are full members and receive LOSAP and would not be eligible for any incentives until all criteria was met. Mr. Taylor clarified the amount of LOSAP given this year was the same and last year and was not the maximum LOSAP.

Mr. Taylor stated it would be beneficial to stay away from creating a budgetary line item for reimbursements because there is a 2% cap. By waiving fees, a line item would not have to be created in the budget, and it would be a simpler process. Mr. Taylor stated summer camp fees could be waived as children could be added to the various age groups without impacting Recreation's budget; however, volunteers would be required to pay for field trips for their children.

Mr. Cook asked Mr. Taylor if the Committee should discuss the incentives with the two (2) organizations, and Mr. Taylor stated if the Committee was considering cash reimbursements, it would be beneficial to speak to both groups. Mr. Mulligan stated he was in favor of the \$250 incentive (total approximately \$10,000 a year). Mr. Taylor stated if the Fire Company was trying to attract volunteers with children, waiving fees for summer camp would be an attractive incentive.

There was additional discussion about monetary incentives, what fees to waive, and who in the organizations would benefit from the incentives. Mr. Mulligan stated he was in favor of the monetary reimbursement because it was broad and applied to all rather than focusing on one (1) program. Mr. Mulligan stated offering incentives now would cost less than having to have a paid fire company.

Ms. Beth Veghte, Chairman of the Recreation Commission stated the incentives were discussed at the Recreation meeting and the Commission felt the Committee should use other alternatives than recreation fees as incentives. Ms. Veghte stated over the last few years the Township Committee has stressed how the Recreation Commission has to be cost effective while running their programs. She stated the fees charged pay for the costs of the specific program. Ms. Veghte stated the amount the Township subsidizes Recreation has decreased over the past few years. She stated she is in favor of giving the first responders some incentive and suggested giving a break on their taxes. Ms. Veghte stated the number of campers impacts the number of counselors needed or buses required for trips. Ms. Goetz asked Ms. Veghte if the Recreation Commission would consider a discount on the weekly fee. Ms. Veghte stated they could look into a discount. There was discussion that this discount would not benefit volunteers without children. Ms. Marabello stated employees receive a 10% discount and the same could be offered to first responders. Ms. Veghte stated the numbers will have to be looked at going forward and perhaps be revisited or have a cap. Ms. Veghte stated she will have Mr. Ken Jacobs, Recreation Director, run some figures to see if it is feasible to offer a 10% discount.

Mr. Richard Kallan, Wynnewood Drive, stated the Township Committee lost vision of trying to provide a little bonus to the first responders to attract and retain volunteers. Mr. Kallan stated the money is not an incentive and should not be an issue. He stated that small amount of money is not going to make a difference.

Mr. Kallan stated there must be a simple way to offer incentives to first responders without making it complicated. Mr. Mulligan agreed stating a \$250 incentive would be cleaner. Mr. Kallan stated the incentive program must be fair to all.

Mr. Cook asked if the Committee was in agreement about the Ordinance to be written. At this point it was decided to go with the \$250 incentive and wait for information back from the Recreation Director concerning a 10% discount. Mr. Mulligan stated he would rather stay with just the monetary incentive. Ms. Marabello stated the 2014 budget must be looked at before deciding the dollar amount.

Mr. Taylor returned to the dais.

Reports from Township Boards and Commissions

Mr. Kristie Venanzi, President of the Cranbury Public Library Board, reported the Facilities Committee is in the process of speaking with architects for the design of the new Library. She stated a couple of items need to be clarified at this point, including a sight survey which would be important for the architects for their planning process as well as sewer, water and other utility information. She inquired if the parking lot could be started in advance of the Library. She stated they will go to the Planning Board to request a change in location for the Library compared to where it is located on the Master Plan. After the Planning Board meeting, the Committee will report back to the Township Committee after that meeting. The Township Committee stated they did not know the placement of the new Library or the parking lot. Ms. Marabello stated a surveyor would be needed. Ms. Venanzi questioned the location of sewer connections. Ms. Marabello stated an engineer would determine where the Library would connect to the sewer system. Mr. Mark Berkowsky, Facilities Committee, explained it would be helpful to have the location of utilities and the topography of the land before proceeding with the architect, and requested permission to contact the Township Engineer, Bill Tanner. The Township Committee agreed to share any information it has on that property and stated the School may also have some additional information.

Ms. Beth Veghte, Chairman of the Recreation Commission, stated the Recreation Commission would like to be included in the discussion of the positioning of the new building. She stated some of the land is recreation land. Ms. Goetz clarified that discussion would be held by the Planning Board.

Reports from Township Staff and Professionals

--Administrator's Report

Ms. Marabello reported the bond sale would be held on Tuesday, October 29th. She stated the Township still has a "AAA" bond rating by Standard & Poor's. She reported when the Township first started this process, the rates were at about 4%, however, the rates have dropped in the last two (2) weeks. She reported the Bond Counsel is very enthusiastic that the Township will receive lower than 4% at the bond sale.

Ms. Marabello stated the Township has received a letter from AT&T looking for cell sites in the Cranbury area. She explained this letter is to gauge if the Township is interested in cell towers, and if so, AT&T will send a proposal. Ms. Marabello reported she referred AT&T to the Township's Code. Ms. Goetz inquired if income would be generated from the cell towers, and Ms. Marabello stated there is a franchise fee. Mr. Cook stated this was discussed a few years

ago and stated there is a cell tower on the east side of Route 130. He stated cell towers ruin the vista and suggested having more antennas put on an already existing tower. Ms. Marabello stated she wanted the Township Committee to be aware AT&T is looking for sites.

Ms. Goetz asked about the funds received for recycling. Ms. Marabello explained every year the Township receives money back depending on the amount of recycling collected. Ms. Goetz reported \$63,000 was received in 2011 for recycled materials.

Mr. Mulligan stated the "AAA" bond rating is huge and commended Ms. Marabello for her efforts through these tougher economic times.

Reports from Township Staff and Professionals

--Assistant Administrator's Report

Ms. Cunningham stated she had nothing to report.

Public Comment

The Mayor opened the meeting to public questions and comment.

Mr. Bill Bunting, Prospect Street, asked the Township Committee to have the Township Attorney write a letter concerning Wheatfield Road. Mr. Bunting stated he wrote him a letter, however, he has not received a response back. Mr. Bunting explained he has lived on Prospect Street for most of his life and stated recently several homes have been built on Wheatfield Road. He stated there is a sign that states Wheatfield is a private road; however, Mr. Bunting said the road is owned by the Township and is Lot 14.03. He explained Mr. Don Patterson farms Lot 14.03 for the Township, and stated he owns Lot 13, Lot 35 and 114, which all have a right to use Wheatfield Road. Mr. Bunting explained the two (2) neighbors paved Wheatfield Road and have tried to prevent Mr. Patterson from using the road. Mr. Bunting stated he has written four (4) or five (5) letters to the neighbors stating he and Mr. Patterson have a right to use the road for ingress and egress to access the farm. Mr. Bunting stated he would appreciate having the Township Attorney write a letter to the neighbors on Wheatfield Road. Mr. Bunting stated he will bring a suit against them if they continue to hinder or harass anybody with farm equipment coming in on Wheatfield Road. Mr. Bunting stated he would appreciate some assistance from the Township.

Mayor Johnson reported the Stiglics approached him about a month ago to ask him to find out who had rights to use Wheatfield Road. Mayor Johnson stated it had already been researched at Town Hall and he was given a document that explained the landowners who had a right to use that road. Mayor Johnson stated he sent that information to the Stiglics as an attachment to an e-mail. Mr. Bunting stated that has not stopped the harassment and a letter from the Township Attorney would clarify the rights. Mr. Mulligan asked if the police could be called, and Mr. Bunting stated he would rather not do that. Ms. Marabello stated the Township did not pave the road and does not plow it because the road was not deeded back to the Township. Mr. Mulligan asked if the Township Committee wants to involve the Township in a neighbor dispute or should the neighbors be resolving the issue. Mr. Bunting stated there is no question the road is owned by the Township. Mr. Mulligan suggested the police would be the first course of action.
