The regular meeting of the Township Committee of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Susan Goetz, Daniel Mulligan, Jay Taylor and Mayor Glenn Johnson. Mr. David Cook was absent. Also present were Denise Marabello, Township Administrator/Director of Finance and Kathleen Cunningham, Municipal Clerk/Assistant Administrator. Mayor Johnson extended congratulations to Jay and Kristen Taylor on the birth of their twin boys last Thursday. Mayor Johnson reported he attended meetings with a developer, the DRC, Recreation Board, Planning Board, and the Zoning Board hearing. He stated he also attended the pumpkin carving event at the school

-- Township Committee

Mr. Mulligan offered his congratulations to Mr. Taylor on the birth of his sons and offered his congratulations to Mayor Johnson on his re-election to the Committee. Mr. Mulligan stated resident, Walter Gay, passed away. He stated he was a resident who made a great positive impact in a short amount of time. Mr. Mulligan stated Mr. Gay was a friend and stated he attended a celebration of Mr. Gay's life with neighbors and friends at Teddy's.

Mr. Mulligan stated there is the drainage issue on Plainsboro Road and inquired if Mr. Tanner established a timeline yet for the project. Ms. Marabello stated survey work is currently being done; however, a start date has not yet been established. Mr. Mulligan stated the residents on Plainsboro Road were voicing their concerns about large trucks using the roadway, and stated the police have placed signs stating over 4-ton trucks should not be on the road.

Mr. Mulligan stated he and Mayor Johnson worked with Ms. Marabello and Public Works to place a barrier at the end of Old Hightstown Road (located at the intersection of South Main

Street and Old Trenton Road). He stated people were driving on the road and residents living there complained the traffic was becoming heavy. Mr. Mulligan stated he has seen many cars now turning around at the barriers and did not realize how many cars were using the road.

Mr. Taylor offered his congratulations to Mayor Johnson and Mr. Mulligan on their re-election. Mr. Taylor reported there will be a pumpkin roll on November 16th at Village Park. The event is a fundraiser for an Eagle Scout project. Mr. Taylor stated he has been contacted several times by Mr. Frank Brennan concerning a Township pipe that runs behind houses on North Main Street to Bunker Hill. Mr. Taylor inquired if funds could be set aside at budget time to have a camera study done. He stated if the pipe does not go anywhere, perhaps it could be closed to prevent further flooding in residents' backyards. Mr. Taylor explained the pipe has either been blocked by a foundation or debris over time. He suggested a camera survey would be less costly than taking on a bigger construction project to identify the problem. Ms. Cunningham suggested Township Engineer, Bill Tanner, be contacted because she believed a camera study may have been done by the previous Township Engineer. Ms. Goetz asked if the cost associated with that study would also be available to give the Township Committee an idea of cost in case the study has to be done again. Mr. Mulligan summarized, stating the Township Engineer should be contacted to see if there are existing records, determine who owns the pipe, what the actual problem is, and then go forward from there.

Mr. Taylor reported \$6,000 construction permits were issued during the previous month, including permits for "Sandy" repair, downtown beautification, and bridge/dam work.

Ms. Goetz reported the "Downtown Beautification" work is a little behind schedule as some details are still being reviewed. She stated there is meeting this week with the Fire Company, the Township Engineer and Chief Varga, and the bump outs are being pulled back a little to allow for the trucks to make the turns. She stated the work should start soon and stated there have been a lot of questions concerning the bump outs. She stated the bump outs are not just for aesthetics, but are to make the Township ADA compliant. She reported the bump outs are marked on the streets, and clarified the inside line is where the bump out will actually be.

Ms. Cunningham reported there were no agenda additions or changes.

Public Comment (For Items on the Agenda)

Mayor Johnson asked if the public had any comments on agenda items.

Mr. Tom Connolly, Petty Road, inquired what the "Special Services Apparatus" was listed on Resolution # R 11-13-140. Ms. Marabello explained it is a truck for the Fire Company, which was approved in the 2013 Capital Plan. Mr. Taylor clarified a number of years ago the water tanker needed replacement and the Fire Company funded the purchase of the tanker out of their funds in return for the Township at a later date purchasing a special services truck and a brush truck. Hearing no public additional comment, the Mayor closed the public portion of the meeting.

a). Discussion of 2014 Township Committee Meeting Schedule

The Township Committee discussed the 2014 Township Committee meeting schedule. Mayor Johnson commented if the Reorganization Meeting was scheduled too late, it interfered with the scheduling of the meetings of all the other Boards and Commissions. Mayor Johnson asked if the evening of January 1st would work for the Committee, and the consensus was that was a family day. Ms. Cunningham asked if a reorganization meeting could be scheduled during the day; however, it was thought Thursday at 6:00 p.m. would be the best date and time. a). Discussion of 2014 Township Committee Meeting Schedule (Continued)

Meetings on Monday holidays will continue to be scheduled on the Tuesday instead as the Committee agreed it was better meeting the next day than waiting three (3) weeks for the next meeting. The meeting schedule lists the second meetings in July and August as "optional." Ms. Cunningham stated the Township holidays are listed on the bottom of the schedule. Mr. Mulligan suggested changing the August 25th meeting to Tuesday, August 26th because that is the tentative date of the Mayor's Golf Tournament. The Township Committee reviewed and agreed on the 2014 Meeting Schedule.

Reports from Township Boards and Commissions

Mr. Mike Kervan, Chief of Cranbury Fire Company, reported 33 incidents in October (year-to date 276 calls). He reported, including drills, the Company had 228 man hours in October. Mr. Kervan reported the Fire Company is using their new radios and stated the siren had to be reprogrammed to work with the new radios. Ms. Goetz thanked Mr. Kervan for meeting to discuss the proposed bump outs, and Mr. Kervan stated the Fire Company was satisfied with the compromise. Mr. Taylor asked how many hours were required to obtain Fire Fighter 1, and Mr. Kervan stated he believed it was 160 hours. Mr. Kervan explained the State requires every fire fighter attend a mandatory minimum of one (1) drill quarterly and one (1) live fire training exercise annually. Mr. Kervan stated the Fire Company will make an effort to have a member present at the first Township Committee of every month to give report or answer questions.

Reports from Township Staff and Professionals

--Administrator's Report

Ms. Marabello reported the Township received a rate of 2.875% at the recent bond sale, a phenomenal low rate which will save the Township over \$1 million in interest over 30 years.

Reports from Township Staff and Professionals

--Assistant Administrator's Report

Ms. Cunningham stated she had nothing to report.

Public Comment

The Mayor opened the meeting to public questions and comment. Mr. Tom Connolly, Petty Road, recommended items on the agenda be more clear and should have in parentheses a definition of what the item is. Mr. Connolly asked if the Township is paying for the light posts for the Bridge/Dam Proejct, and Ms. Goetz explained the Township is leasing the light posts through PSE&G. Ms. Marabello stated the upfront cost of the light posts is approximately \$10,000. Ms. Goetz stated extras such as the benches, planters, etc. may be funded by the Woman's Club plus an HPC grant (which Mr. Tanner and Ms. Cunningham are working on.) Ms. Goetz stated the Woman's Club and Historical Society approached the Committee and are interested in making contributions to the Downtown Beautification Project.

Mr. Connolly stated Village Haircutters is moving to West Windsor, and he asked if the Committee knew why they were leaving Cranbury and who is moving in. Mr. Mulligan stated Teddy's Restaurant owns the building; however, they have not decided if they will be renting the property or what they will do with the space.

Mr. Connolly asked when the construction work on Petty Road will begin. Mayor Johnson explained there are a number of steps that must be first taken, i.e., a drainage study will determine how much of the roadway will be have to be redone. Mr. Mulligan stated the Township will have to seek grants to assist with the funding of the project. The Township Engineer has discussed this issue with the Township Committee and a study has not been authorized yet.

Public Comment (Continued)

There being no additional comment, the Mayor closed the public portion of the meeting.

Mayor Johnson reported he had no Mayor's Notes.
