Ms. Goetz reported she also attended the "Beautification Subcommittee" Meeting. She reported approximately 30 residents attended the meeting. She attended the Board of Health meeting and reported 99 animals received the Rabies vaccine. Ms. Goetz reported a complaint about barking dogs by residents who live on Petty Road was heard at the Board of Health meeting. Ms. Goetz indicated this is an ongoing problem throughout the Township and even if the Police are called, by the time they arrive, usually the dog(s) stop barking.

Mr. Johnson reported at the last Township Committee meeting two (2) members of the Human Services Board came to speak about the Board needing help running functions. He stated he and Mr. Mulligan met with them and suggested the Human Services Board join the Recreation Board. Mr. Taylor cautioned the Human Services Board is responsible for other services, i.e., social services. Ms. Marabello explained any social services issues are handled by Middlesex County Department of Social Services and not by Cranbury Township's Human Services Board. Ms. Marabello indicated going forward, this process will remain.

Mr. Taylor reported the construction fees have increased for the month of September. There were 13 building permits issued for a total of \$35,821. (Papa Johns and Petco have submitted applications to retrofit their warehouses.) Other permits issued include: 19 electrical for a total of \$16,260; 17 plumbing for a total of \$1,629; and four (4) fire permits for a total of \$1,386. The inspections for September were: 58 building, 36 electrical, 22 plumbing and seven (7) fire inspections. There were 28 residential and 12 non-residential certificate of approvals issued in September. Mr. Taylor reported this is the first time the amount of fees collected has gone up.

Mr. Taylor reported vehicle maintenance costs for October included replacing the throttle body on Truck # 501, and replacing high pressure oil line and exhaust temperature sensor on Truck # 504 for a total expenditure of \$1,616.

### Reports from Township Boards and Commissions

Mr. John Jackson, Chairman of the Board of Health, suggested the Township conduct an online census for dog and cat licensing. However, he stressed with the Township Committee that the on-line census for dog licensing may not take the place of the statutorily-required State Dog Census. Mr. Jackson reported there were 189 dog licenses and 30 cat licenses issued to date for 2012 compared to 248 dog licenses and 24 cat licenses issued in 2011.

### Work Session

### a). Discussion of NJDOT Grant Application Options

The Township Committee discussed various options for the upcoming NJDOT grant application to be submitted by Mr. Bill Tanner, Township Engineer. Mr. Tanner reported Cranbury Township can submit for two (2) grants, which may not be in the same category. A grant application will be submitted for the second phase of the downtown beautification project, which is considered a "Quality of Life" grant. The other grant application will be to repair a roadway. The roads needing repair include Cranbury Brickyard Road, Petty Road and John White Road.

Mr. Tanner stated only half of John White Road would be repaired as the other half belongs to Plainsboro Township. He suggested applying for a grant jointly with Plainsboro in the future to have the entire roadway paved.

At the September Township Committee meeting, residents expressed concern about the conditions of Petty Road. Mr. Tanner went out to look at Petty Road and met with resident, Ms. Connie Bauder, who had pictures of Petty Road when the paving work was done in 1995. Dry wells installed at that time have been ineffective. Mr. Tanner stated the road's drainage consists only of the dry wells, which were full of water when he went to survey the road days after any rainfall. In order to repair the road, the Township would have to remove the existing road, replace the drainage system and repave the road. Mr. Tanner stated the drainage is critical and must be replaced before any road work is started. He stated the roadway varies in width between 16 and 17 feet. The pavement is sinking and breaking up along the edges, which forces cars to travel along the center line. Mr. Tanner recommended the entire road be totally reconstructed and a storm drainage system with an outlet to a brook or other discharge point be constructed. He predicted the work on Petty Road would cost over \$1-million, not including permit and engineering costs and acquiring drainage easement rights. Mr. Tanner stated he could not recommend applying for the NJDOT grant for work on Petty Road at this time.

Ms. Marabello stated repairs to Petty Road can be added to the Capital Plan at budget time; however, that does not mean the Township will do an ordinance or spend the money.

Mr. Tanner reported Cranbury Brickyard Road is in poor condition. He stated the roadway connects Route 130 through to Monroe, and currently the Turnpike Authority is working on the road erecting a bridge over the Turnpike. Mr. Tanner stated Brickyard Road would be a good option to apply for because a section of the road is already being repaired. Mr. Tanner stated there is upcoming development on Cranbury Brickyard

Road, and work on that road should be done as there will be a lot of truck traffic during that development. He recommended Cranbury Brickyard Road be the choice for the grant application.

### **Public Comment**

The Mayor opened the meeting to public questions and comments:

Mr. Peter Connolly, Petty Road, spoke about how embarrassing the condition of Petty Road is for the residents and stated it is not fair for the Township to dismiss the problem. He reported he often has visitors to his home who ask him "what's with the road?" He stated no other road in the Township is in such poor shape. He requested the Township Committee reconsider their decision and fix the road. He stated it is only a matter of time before something tragic happens on the road.

Mr. Bob Dillon, Hightstown/Cranbury Station Road, stated Brickyard Road is only in bad shape from Mid-State Filigree northbound for approximately 300 feet. Mr. Dillion recommended only this section should be repaired. He stated the Turnpike is continually running trucks and heavy construction equipment on the road. Mr. Dillon stated Brickyard Road from his property to Chamberlin & Barclay should be done.

Mr. Dillon asked Mr. Tanner, Township Engineer, if drainage work can be done on Petty Road without removal of the roadway. Mr. Tanner responded the roadway would need to be removed since the drainage is right at the edge of the pavement; however, a study would have to be performed first and that has not been done yet.

Mr. David Martin, Petty Road, stated he does not want Petty Road widened. He stated speeders will use the road and making the road wider is only asking for trouble. Mr. Martin stated money should not be used to widen Petty Road.

Ms. Laura Jackson, Petty Road, stated the center of Petty Road is not lined up correctly. She recommended re-aligning the center of the road. She stated the dry wells which were installed in 1995 are now sinking lower than the road.

Ms. Connie Bauder, Petty Road, reported the cracks started right away in 1995 when the roadwork was done. She stated the road was not good since the beginning. She stated the easements on the former Oschner property were never recorded properly.

Mr. Jim Romaine, Petty Road, stated his main concern is safety. He stated the drainage freezes in the winter and children that wait for the school bus to pick them up can slip and fall. He stated the condition of the road needs to be addressed for the safety of his children and his neighbor's children.

Mr. Blase Toto, Petty Road, stated the condition of the road was better before it was repaired. He reported the dry wells immediately sunk and stated a road width of 16 feet is not adequate. Mr. Toto stated widening the road would definitely be beneficial and recommended removing the dry wells completely.

Mr. Peter Connolly, Petty Road, recommended not waiting for something tragic to happen on Petty Road and suggested the Township Committee members drive the road to see the condition of the road for themselves.

Mr. Richard Kallan, Wynnewood Drive, suggested the easements on Petty Road be corrected before any repair work commences.

Public Comment (Continued)

There being no further comments, the May closed the public part of the meeting.

Mayor's Notes

Mayor Cook thanked the Shade Tree Commission for removing bad trees in the Township.

He announced Candidates' Night will be held at 8:00 p.m. on October 10<sup>th</sup> in the School Cafeteria.

Mr. Tom Ingegneri, South Main Street, asked why a sign was erected at Barn Park indicating it was a "Tow Away Zone". Mr. Taylor responded the Parks Commission decided to have a sign put up. If there is not a parking issue and the sign is not needed, Mr. Ingegneri requested the sign be removed and stated he will not park there again.

On a motion by Ms. Goetz, seconded by Mr. Johnson and unanimously carried, the meeting adjourned at 9:00 p.m.
