

SPECIAL TOWNSHIP COMMITTEE MEETING  
July 5, 2011

A Special Meeting of the Township Committee of the Township of Cranbury was held at 9:30 a.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: David Cook, Glenn Johnson, Daniel Mulligan, Jay Taylor. Mayor Win Cody participated via teleconference. Also present were Denise Marabello, Township Administrator/Director of Finance; Kathleen R. Cunningham, Clerk/Assistant Administrator, and Jean Golisano, Deputy Clerk. Ms. Cunningham led in the salute to the flag, and gave the following Open Public Meetings Act statement:

Ms. Kathleen Cunningham, Clerk, announced the only item on the agenda is Cranbury Township Resolution # R 07-11-087, which would authorize the use of the Township's Municipal Seal to Rutgers University Press for publishing the book tentatively entitled "Cranbury: A New Jersey Town from the Colonial Era to the Present".

Mayor Cody stated his appreciation to Professor John W. Chambers for writing the book and asked the Township Committee for any questions or comments. Mr. Cook stated he is glad Professor Chambers was near completion on his project and is happy to authorize use of the Township Municipal Seal. Mr. Taylor agreed from the Historical Society viewpoint.
