# Reports and Communications

-- Mayor

Mayor Stout reported on the Planning Board meeting he had attended last Thursday and reported it was a re-organizational meeting; re-appointing members, swearing in members and the professionals to their respective positions. The Planning Board also discussed the need for a Master Plan update and stated part of this flows out of the work that Mr. Stannard and Mr. Cody did next year as well as recognition from residents, professionals and others that the Township does need to take another look at its Master Plan. Mr. Stout reported he and Mr. Stannard have requested they be provided with a scope in the budget and the Planning Board prioritizes what elements of the Plan need to be addressed so proper resources are allocated. Mayor Stout also reported that the Planning Board adopted a site plan approval for the former Silvi Concrete plant on Cranbury-Hightstown Road which has been dormant for at least ten (10) years. It will be a small warehouse for a contractor/landscaper. Mayor Stout reported the Township Committee will be having its budget meeting this Saturday, January 16<sup>th</sup> from 9:00 until 2:00 p.m.

#### Reports and Communications (Continued)

#### -- Members of Committee

Mr. Cody reported the Helene Cody Foundation will be doing the 5K race again on Cranbury Day and would like to give a presentation to the Township Committee at the February 8<sup>th</sup> meeting. Mr. Cody also reported there is a meeting at COAH on Wednesday, January 20th to consider the Township's conditional certification and will issue the final certification in 60 days. He stated the Township will have to make a decision within the 60 days on how many units will be at the Route 130-D site and move to acquire the "family unit site" by September. The Township Committee will have a Work Session at its February 8<sup>th</sup> meeting. Mr. Cody also reported he had attended the Zoning Board of Adjustment meeting and the "Verdi" project on South River Road was on the agenda. However, as one of the members had to recuse himself, the Board postponed this item until the next meeting. Also on the schedule for the next meeting is Buy-Rite Liquors expansion. Mr. Cody reported also discussed was the role of the Township Engineer vs. Zoning Board Engineer, etc. and asked for definition on the various roles of the different engineers so there is not duplication on projects. Ms. Waterbury, Township Attorney, reported there is a very well-defined delineation and can lend her assistance to the question and help identify any Code changes that may have to be made. Ms. Smeltzer indicated she is planning to prepare a list of duties for the Township Engineer and currently is preparing a "transition list". Mayor Stout asked that the Planning and Zoning Boards be asked to do the same.

Mr. Cook stated in reference with the COAH issue, the Township should be compliant with COAH'S decision, whether it is Round Three, or something different as Mr. Cody reported the Township is compliant at this point in time. Mr. Cook stated in speaking with the New Jersey League of Municipalities, the change in the Governorship has changed the outlook and environment for COAH significantly. The Governor is stating he does want to change COAH or abolish it. Secondly, the Appellate Court heard arguments back in December that came both from developers and municipalities that as it stands now, COAH does not function well and is disruptive for developers because many municipalities have taken a "no growth approach". Mr. Cody reported the Township should have a better idea no later than July how any COAH changes will affect the Township.

Ms. Cunningham, Clerk, announced an amended Temporary Budget Resolution, Cranbury Township Resolution # R 01-10-023 was being added due to grant monies received for two programs, one being the "Drunk Driving Enforcement" and the second "Over the Limit Under Arrest" Program.

Reports from Township Staff and Professionals Police Chief Edward Kahler's Monthly Report

Police Chief Edward Kahler gave the Township Committee his report for the month of December, 2009. Chief Kahler reported there were 100 summonses issued during the month. Cell phone violations: 3, Expenditures (highest to lowest) were shift coverage, special details and Court. The Traffic Bureau reported there were 28 crashes in December and the snow and ice conditions of late have caused a jump in the number of motor vehicle crashes and disabled vehicles. The Detective bureau had 11 new investigations and closed 6. The CERT team assisted with the second H1N1 vaccination clinic held at the Cranbury School on December 8th. The CERT members generated inoculation records, assisted with crowd control and helped distribute literature. The bicycle patrols were not out at all during the month. The vehicle mileage was 11,354 miles. Arrests were 11; DWI-3, Assault-2, Burglary-1, Warrants-4, Hindering-1. Chief Kahler reported the second vaccination clinic held at the Cranbury School on December 8, 2009 was a complete success. During the recent significant snow fall, several police officers volunteered to remain at headquarters to ensure that they would be able to report for their next shift. The officers, who worked up to eighteen-hour shifts, stayed in the Police Department's new shelter which was built by Matt Mikula for his Eagle Scout project. The Department received a certificate of appreciation from ProLogis Trust for its participation in the "Toys for Tots Program". Mr. Taylor thanked the Chief for the good work his Department performed during the recent snow storm. Mayor Stout reported the Township Committee will be asking Departments to track their Department's budgets every month and the Police Department will be required to do so as well.

#### Administrator's Report

Ms. Smeltzer reported installation of the garage doors at the Fire House are underway however, there was a damaged panel and they are awaiting delivery of the replacement panel. Ms. Smeltzer also reported at the County level, Ryan Rapp, previously with the Agricultural Development Board has moved on and she was recently introduced to Mary Morrison, his replacement. If the Township should have any questions concerning farmland preservation, she will be the contact person at the County Agricultural Board.

Mr. Cody asked about how the Township determines when the lake is safe for skating. Mr. Cook stated he was always told there had to be 8" office before skating is allowed. Mr. Thorne, Public Works Director, had tested the ice recently and there was only 3" of ice.
