The regular meeting of the Township Committee of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were: Township Committee members: Winthrop Cody, David Cook, Richard Stannard and James Taylor. Mayor Stout was absent. Also present were: Christine Smeltzer, Administrator, Denise Marabello, Assistant Administrator and Kathleen R. Cunningham, Clerk. Mr. Stannard led in the salute to the flag and Ms. Cunningham gave the following Open Public Meetings Act statement:

Mr. Stannard announced under the Public Comment, there will be a limit of three (3) minutes for comments.

Report from Recreation Director: Re: Status of Well for Ball Field, etc.

Mr. Ken Jacobs, Recreation Director, gave a report of the status of the irrigation well for the ball field. Mr. Jacobs reported he had obtained quotes for the irrigation well and it appears the costs will be approximately \$20,000 and there will be enough money to also irrigate the School soccer fields. Mr. Jacobs stated he feels very strongly the well should be located behind the base ball field on the Township property and not on the School property. The School has a number of concerns with having it on their property. Mr. Jacobs stated the problem will most likely be running electric to the well, however, the Township has spent the grant money well it obtained from the County and there will be more than enough money to cover the entire project. Mr. Jacobs reported he has spoken with the Township Engineer, Bill Tanner, and both agree the project will have to go out to bid as it is over the bid threshold. Mr. Jacobs indicated he will be turning over all of his paperwork to Mr. Tanner. Mr. Cody asked if the electrical installation is the most expensive item. Mr. Jacobs indicated his experience with PSE&G in the past has been they will bring the power to you very inexpensively. However, the Township will be responsible for trenching the location. Mr. Jacobs is waiting to hear back from PSE&G. The well pump is a 15 horsepower pump which will require a transformer. Mr. Jacobs indicated the Township has to spend the grant money by the end of the year and if the Township can install electric out at the ball field it would be very beneficial. Mr. Taylor requested the Construction Official take a look at the specs for the well and approve it.

Mr. Taylor reported the Parks Commission's "Easements Committee" is starting to narrow down a date for when they are going to meet. This Committee is a subsection of the Parks Commission which was created to come up with a solution for the Township easements that lead to public lands. Mr. Taylor reported along Millstone Park there are a few easements which are not identifiable today, and the Easements Committee will recommend what kind of identification will be appropriate for marking the easements to make them more identifiable to the public. The Easements Committee has asked Mr. Taylor to ask the Township Committee to agree that they should look at all easements within the Township and not just a specific area.

Mr. Taylor reported the Fire Company is requesting the Township look at the dry hydrant which is located in Brainerd Lake. Mr. Cook has offered to ask Mr. Tanner to ask the divers when they start their work in the Lake to do so.

Mr. Cody thanked the Cranbury Arts Council and everyone who was involved for a great "Cranstock" event.

Mr. Cody reported at the last Township Committee meeting, residents requested the Township inquire as to why the School had changed the bus route from Parkview Road to Old Trenton Road. Mr. Cody, Liaison to the School Board, stated even though the decision is within the School's preview, he had followed up. Mr. Cody was told the rationale was the bus stop had been a safety issue. Pulling into the cul-de-sac was more dangerous than stopping on Old Trenton Road (which presently is now 35 m.p.h.). Mr. Cody commended the Police Department for monitoring the site while construction has been taking place on Old Trenton Road.

Mr. Taylor reported he had received an email from a resident this morning across from where Farmstead Way is located. There has been a number of people witnessing passing on the right hand side onto the lawn area (heading towards East Windsor Township). Mr. Cody added the late high school bus also has cars passing it when it is stopped. Chief Varga, who was in the audience, asked that he be given an approximate time and he will have a patrol car in the area.

Mr. Cook reported there are a number of projects underway. Projects currently going out to bid will be Zurfluh driveway off of the back of the school property that leads to a home and is adjacent to land the Township now owns and involves the driveway maintenance. The other project is the "Griggs Road, Phase II" which is essentially paving. Mr. Cook stated he hopes these projects will be ready to go out to bid by the meeting of October 25th. Mr. Cook reported another item is the public storage barn at Public Works. The original plan was to have the storage shed on the site which was formerly a land fill. The building will be relocated to another location. In addition, going to bid will be a Public Works vehicle washing
