Dr. Daniel Notterman, Chairman of the Township's Board of Health, gave a presentation on the H1N1 Virus and vaccination:

Dr. Notterman reported the Board of Health is not responsible for administering the vaccine; Middlesex County is. He reported this particular strain started with a pig in Mexico who developed four (4) different viruses and stated every 10-20 years there are major pandemics that break out. He reported the virus is spread by coughing and can stay in the air for a full 24 hours. He added an individual is actually contagious one (1) day before getting ill with the virus. Children can infect individuals within ten (10) days after being sick.

Dr. Notterman stated persons in their 60s most likely will not get the virus because this strain is very similar to a strain that hit in the 60s and they have most likely have built up immunity to the virus.

Dr. Notterman reported children with neuro-developmental problems are at high risk as well as children under five (5) years of age and the elderly population.

Dr. Notterman suggested the following preventive measures: washing hands and keeping family members who are ill isolated from others. He urged staying at home if a family member is ill as you can carry the germs. He stated the virus is unrelated to the swine flu vaccine of the 70s. He recommended if anyone thinks they have been exposed or are exhibiting symptoms of the flu, they should buy either Tamaflu or Relenza and this will shorter the duration by 30% (1-1.5 days).

He stated the Fire Company is having a problem with members being able to make fire calls during the day and they will be discussing their options with the Township Committee during the budget process.

Reports and Communications (Continued)

---Members of Committee (cont'd)

Mr. Stannard reported Mr. Cody had attended both the Development Review Committee ("D.R.C.") meeting and the Zoning Board of Adjustment meeting as part of their evaluations of various committees to make the process more "small business friendly". The D.R.C. had approved a small photography studio application. The members approved the use with no extra funds having to be spent by the applicant nor any professional fees.

Mr. Dietrich Wahlers, Chairperson of the Turnpike Tree Subcommittee, explained this project is about damage that may be done by the Turnpike Widening Project and which may affect water quality, underbrush and growth. He stated this is not necessarily a plus for a municipality. The subcommittee held its first meeting on Wednesday, November 4, 2009 in the Gourgaud Gallery at Town Hall. The subcommittee produced a list of locations for various plantings of trees and Mr. Wahlers asked the Township Committee to review it and get back to him. He also inquired about putting trees along Liberty Way. Both Ms. Smeltzer, Township Administrator and Ms. Marcelli, Engineer, indicated there are certain areas along the warehouses that are in the public right-of-way. Mr. Wahlers also reported the subcommittee will be meeting the next two (2) Thursdays and make its recommendations. He reported the trees are 2 ½" x 3 ½" wide and 10' tall. The seedlings that are planted will go on wetlands on both the Frosztega and Barclay properties. Mr. Wahlers stated the subcommittee has asked if the Township can use under bushes instead of trees and if the Township can store or inventory the trees. In addition, he has a call into D.O.T. to request to put some trees on the median of Route 130 in the Township.

Reports from Township Staff and Professionals

Police Chief Edward Kahler gave his monthly report for the month of October, 2009. Chief Kahler reported a total of 124 summonses had been issued. 11 --speeding and 10 for cell phone violations. Expenditures (highest to lowest) were: shift coverage, school/training and shift extensions. He stated there had been a sudden jump in flu-like illnesses within the Department which accounted for a large portion of the overtime expenditures. The Traffic Bureau reported there were 33 crashes in October, the Detective Bureau reported 10 new investigations and 8 closed investigations. The CERT term assisted with traffic control and public safety on Halloween. Chief Kahler stated the efforts of the CERT members are greatly appreciated. He reported the bicycle patrols were out four (4) times during the month and vehicle mileage was 10, 229 miles. Eight (8) arrests had been made: D.W.I. - 2. Burglary -1, Theft-0, Warrants-4, Controlled Dangerous Substances-0 and Miscelleanous-1. Chief Kahler also announced "Operation Medicine Cabinet" will take place on Saturday, November 14. 2009 from 10:00 a.m. - 2:00 p.m. Residents may drop off their unused prescription medications, no questions asked, at Police Headquarters. The medications will be turned over to the Drug Enforcement Administration for destruction. He stated "Operation Medicine Cabinet" is in response to the growing number of teens and young adults rummaging through medicine cabinets for unused medications. Chief Kahler reported the Ford Escape Hybrid arrived and he will have a detailed performance report in two (2) months. The Boy Scout shelter project is complete and Chief Kahler commended Matt Mikula for an excellent job relocating items in the storage room, painting the walls, painting the floor and refurbishing the existing shelving. Matt and his team also provided cots, blankets and medical kits. He reported the Department had received thank you notes from Boy Scout Greg Carroll for

participating in the Helene Cody 5K run. Greg presented the Police Department with a check which was returned back to the Helene Cody Foundation, and the Cranbury Arts Council sent a thank you note for help with the Cranstock event. In particular were Sgt. Frank Dillane, Officer Mike Cipriano and Captain Rickey Varga. Ms. Julia Johnson, who experienced car trouble in September called headquarters to offer her thanks to Officer Paul Lindenfeld for his assistance. Chief Kahler also reported the Department should be receiving the fingerprint machine shortly (funded by a grant from Homeland Security).

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Mr. Bob Dillon, 32 Hightstown-Cranbury Road, asked the Township Committee the age of the old police cars and mileage. He reported he works on the New Jersey State Police vehicles and having regular maintenance performed is a big factor in being able to keep vehicles longer. Mr. Dillon urged the Township not to purchase several cars each year.

Mr. Dillon also spoke of his concern about an area in close proximity to his home where the Turnpike will be removing trees. The Turnpike is not replacing the trees and he requested that the trees be replaced as they are of value both for visual advantages as well as to deter sound. Mr. Wahlers suggested Mr. Dillon get in touch with the Department of Environmental Protection to convey his concerns to them.

Mr. Dillon also spoke against the Development Review Committee having the authority to approve certain applications and not having to notice those within 200 feet of the subject property.

Mr. Dan Mulligan, Old Cranbury Road, asked if the Township can give the residents any additional information on COAH. Mr. Stout responded the Township is hoping to see "a sea of change" with the new Governor's Administration and that the new Governor follows through with his campaign promises. Mr. Panconi added nothing has changed concerning the Route 130-D site being utilized for affordable housing.

Mr. Stannard reported The Cranbury School has been designated again as a "Blue Ribbon School" and this honor is only bestowed on approximately 300 schools in the United States.

Mr. Dietrich Wahlers, 33 Hagerty Lane, asked if he can be provided a report tracking the Township's \$1.5 million which is in surplus and showing if any of the monies taken out are being replenished. Ms. Smeltzer will ask Ms. Marabello to furnish Mr. Wahlers with the report.

There being no further comments, the Mayor closed the public part of the meeting.
