Mayor Stout reported he had been in communication several times with the New Jersey Department of Transportation regarding a recommendation recently made by the North Jersey Transportation Planning Authority (NJTPA) to locate a truck rest area at the Molly Pitcher Rest Stop on the New Jersey Turnpike in Cranbury Township and will keep everyone informed as he gets more information on the proposal.

Mr. Panconi reported he had his January meeting with the Fire Company. There had been a total of 17 calls; nine (9) were from 6:00 a.m. - 6:00 p.m., eight (8) from 6:00 p.m. - 6:00 a.m. and six (6) calls between 7:00 a.m. – 3:00 p.m. The Public Works employees had responded to all of the calls. Of the calls; nine (9) were of the automatic alarm type and eight (8) had been false alarms. WHEREAS, the Township of Cranbury allows legalized games of chance known as raffles and bingo to be conducted within the Township; and

WHEREAS, pursuant to State law, an application for a raffle or bingo license must be reviewed and approved by the Township Committee; and

WHEREAS, the New Jersey Administrative Code, N.J.A.C. 13:47-1.1 *et seq.*, allows a municipal governing body by ordinance to delegate to an individual its authority to approve the granting of raffle and bingo licenses; and

WHEREAS, in order to expedite the process of approving or denying applications for raffle and bingo licenses and to avoid unnecessary delay or expense, the Township Committee of

the Township of Cranbury wishes to delegate to the Township Clerk the authority to review and approve or deny applications for raffle and bingo licenses; and

WHEREAS, the Township Committee also wishes to update other Township requirements pertaining to the issuance of raffle and bingo licenses;

NOW THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, in Middlesex County, New Jersey, as follows:

1. <u>Section 1. Article I, "Raffles and Bingo", of Chapter 99, "Licensing"</u> <u>Amended.</u> Article I, entitled "Raffles and Bingo", of Chapter 99 of the "Code of the Township of Cranbury" ("Code"), entitled "Licensing", is hereby deleted in its entirety and replaced with <u>new</u> Article I, "Raffles and Bingo", in Chapter 99, which shall read as follows:

ARTICLE I

Raffles and Bingo

§ 99-1. Statutory authority.

As provided for by the Bingo Licensing Law, N.J.S.A. 5:8-24 *et seq.* and the Raffles Licensing Law, N.J.S.A. 5:8-50 *et seq.*, qualifying organizations may conduct games of chance known as bingo and raffles within the Township of Cranbury.

§ 99-2. License required.

No qualifying organization shall conduct a bingo or raffle within the Township without first having secured a license therefor pursuant to State law.

§ 99-3. Issuing authority defined.

Pursuant to N.J.A.C. 13:47-1.1, the Township Clerk is hereby designated as the issuing authority responsible for approving bingo and raffle licenses in the Township of Cranbury.

§ 99-4. Application.

All applications for bingo or raffle licenses must be filed with the Township Clerk, together with a processing fee of five dollars (\$5.00) per application and written evidence of compliance with all applicable provisions of N.J.S.A. 5:8-24 *et seq.* and N.J.S.A. 5:8-50 *et seq.* pertaining to qualifications, applications, regulations and licensing.

§ 99-5. Days of operation.

A bingo or raffle license may be issued for any day of the year without limitation as provided for by N.J.S.A. 5:8-31 and N.J.S.A. 5:8-58.

§ 99-6. Suspension or revocation of license.

Pursuant to N.J.S.A. 5:8-30 and N.J.S.A. 5:8-57, and in accordance with the requirements set forth therein, the Township Committee may, after a public hearing thereon, suspend or revoke any issued bingo or raffle license for any violation of this Article or State law, and may suspend the operation of a bingo or raffle pending said public hearing, which hearing shall be held no later than five (5) days following said suspension of operation.

2. <u>Section 2. Repealer.</u> All ordinances or resolutions or parts thereof inconsistent with this Ordinance are hereby repealed.

3. <u>Section 3. Severability.</u> If any section, subsection, paragraph, clause or provision of this Ordinance is adjudged by the courts to be invalid, such adjudication shall apply

only to the section, subsection, paragraph, clause or provision so adjudged, and the remainder of this Ordinance shall remain valid and effective.

4. <u>Section 4. Effective Date.</u> This Ordinance shall take effect immediately upon its passage and publication, as provided for by law.

CALENDAR YEAR 2008 ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the governing body of the Township of Cranbury in the County of Middlesex finds it advisable and necessary to increase its CY 2008 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the governing body hereby determines that a 1 % increase in the budget for said year, amounting to \$63,910.45 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

Cranbury Township Ordinance # 02-08-07 (Continued) **WHEREAS** the governing body hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the governing body of the Township of Cranbury, in the County of Middlesex, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2008 budget year, the final appropriations of the Township of Cranbury shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 1 %, amounting to \$63,910.45, and that the CY 2008 municipal budget for the Township of Cranbury be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

Mayor Stout stated the Ordinance gives the Township the ability to save money by being able to take advantage of the lower interest rates on some of its older bonds. BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF CRANBURY, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The Township of Cranbury in the County of Middlesex, New Jersey (the "Township") is hereby authorized to:

Cranbury Township Ordinance # 02-08-05 (Continued)

- (i) currently refund all or a portion of the \$1,756,000 outstanding principal amount of its General Improvement Bonds, Series 1998 (the "1998 Bonds"), originally
- (ii) issued in the principal amount of \$2,756,000, dated June 15, 1998, which amount matures on June 15 in the years 2008 through 2018, inclusive (the "1998 Refunded Bonds") and which are subject to redemption on or after June 15, 2008 at the option of the Township at a redemption price of 100% of the principal amount of the 1998 Refunded Bonds to be redeemed; and

(ii) advance refund all or a portion of the \$7,826,000 outstanding principal amount of its General Improvement Bonds, Series 2002 (the "2002 General Improvement Bonds") originally issued in the principal amount of \$10,526,000, dated December 1, 2002, which amount matures on December 1 in the years 2010 through 2022, inclusive (the "2002 Refunded Bonds" and, together with the 1998 Refunded Bonds, the "Refunded Bonds") and which are subject to

redemption on or after December 1, 2009 at the option of the Township at a redemption price of 101.0% of the principal amount of the 2002 Refunded Bonds to be redeemed.

Section 2. In order to finance the cost of the purpose described in Section 1 hereof and the costs of issuance associated therewith, negotiable refunding bonds are hereby authorized to be issued in one or more series in the aggregate principal amount not exceeding \$10,750,000 (the "Refunding Bonds") pursuant to the Local Bond Law of the State of New Jersey.

Section 3. An aggregate amount not exceeding \$200,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-51(b) has been included in the aggregate principal amount of Refunding Bonds authorized herein.

Section 4. The Township desires to provide for all or a portion of the principal amount of the Refunded Bonds outstanding and the interest and redemption premium, if any, thereon in order to provide for savings in debt service as a result of lower interest rates in the bond markets.

Section 5. The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township is increased by the authorization of the Refunding Bonds provided in this refunding bond ordinance by \$10,750,000, and that an amount representing the principal amount of the Refunded Bonds will be deductible from gross debt. The obligations authorized herein will be within all debt limitations prescribed by that law.

Section 6. A certified copy of this refunding bond ordinance as adopted on first reading has been filed with the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey prior to final adoption.

Section 7. This refunding bond ordinance shall take effect 20 days after the first publication thereof after final adoption, as provided by the Local Bond Law, provided that the consent of the Local Finance Board has been endorsed upon a certified copy of this ordinance as finally adopted.

2008 BUDGET INTRODUCTION

Mayor Stout thanked everyone and the public who had attended the Budget Meetings and worked hard to get the Budget assembled for introduction and stated that on March 24, 2008 the Public Hearing will be held on the proposed 2008 Budget and will welcome again input from the public.

2008 BUDGET INTRODUCTION (Continued)

Mayor Stout reported after more than twelve hours of open public meetings, the Township Committee proposes a municipal budget of approximately 12.4 million dollars. This is a 1.35%

increase over the 12.2 million dollar budget in 2007, for approximately a \$166,000 increase. One cent in the property tax raises approximately \$185,000 in tax revenue. Mayor Stout stated this year the Township will need a three-cent increase in taxes to achieve the Budget. The cause of the difference is due to statutory mandated increases such as Public Library Funding (\$65,000) and there had been a decrease in revenue anticipated of approximately \$500,000 from the previous year (sources other than taxes). Mayor Stout also stated, exercising sound fiscal management the Township wants to keep up the same level as in the past of paying down debt and will be paying down approximately several million dollars in 2008. Overall the Township's tax rate will increase from .35/\$100 of assessed value to .38/\$100 of assessed value. The increase is approximately a \$202.00 increase to someone who has an assessment of \$673,000 on their home. Mayor Stout reported the Chief Financial Officer, Ms. Marabello will report further at the Public Hearing on March 24, 2008.

A RESOLUTION ESTABLISHING REGULATIONS AND FEES FOR THE USE OF CRANBURY TOWNSHIP'S ATHLETIC FIELDS

WHEREAS, to address the ever-increasing demand for the use of Cranbury Township's playing fields (including soccer, lacrosse and field hockey fields, softball fields, and baseball

Reports from Township Staff and Professionals

Ms. Waterbury, Esq., Township Attorney, reported on two items for upcoming agendas for possible action. The first issue arises intermittently in the Township concerning a request from a property owner to install a fence encroaching on the Township's easement. Recently a resident on Danser Drive requested he be allowed to install a fence. Ms. Waterbury explained usually the process is for the Township Engineer to review the request first to make sure the fence would not interfere with the drainage easement's function. Once the Engineer is satisfied there is no issue from an engineering standpoint, an encroachment agreement has to be signed and filed with the original Deed for the property. Ms. Waterbury stated both she and Ms. Marcelli have reviewed the request and it does not appear to be a problem however there are a few requirements which need to be included in the agreement. Ms. Waterbury will prepare an agreement and resolution for the next Township Committee meeting. She also stated the number of such requests is fairly infrequent and should continue to be addressed on a caseby-case basis. Ms. Waterbury reported she had received a request from a company, 4 Connections, LLC., a local and intra-exchange telecommunications company that installs dark fiber rings around existing utility poles located in metropolitan areas. They are coming to the Township to seek permission to install fiber optic cable on existing poles and some of the conduit. Ms. Waterbury indicated the Township must take action, by either granting or withholding consent, per Title 48 (the State Statute governing all public utilities). This particular carrier is governed by the Federal Telecommunications Act which means the Township cannot withhold consent unreasonably or arbitrarily. Ms. Waterbury reported there are a few technical questions both she and Ms. Marcelli, Engineer have and Ms. Marcelli has suggested a small subcommittee be formed for the purpose of meeting with them to get more technical information from them. Once all the information is

obtained, a request should be made to 4 Connections LLC to come and make a formal presentation to the Township

Committee so the public can understand as well as the Township Committee what is being requested. An ordinance would then be prepared.

Reports from Township Boards and Commissions There were no reports.

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Mr. Rohit Mathur, 5 Danser Drive, stated he is the resident who has requested installation of a

fence on the Township easement and wanted to clarify that he understood what Ms. Waterbury, Township Attorney had reported and that if the Township Committee approves the agreement and resolution at the next meeting he could install his fence. Ms. Waterbury responded that was the case, however, he will be required to obtain a permit for the fence through the Construction Department. There being no further comments, the Mayor closed the public part of the meeting.

Work Session

a. Report from Police Chief Jay Hansen on Police Department

Chief Jay Hansen updated the Township Committee on the Police Department's activities for the month of January, 2008. Chief Hansen reported the Department's overtime had been less than it was in January, 2007, but higher than usual due to school, training and shift coverage. Chief Hansen gave the following statistics for the Department: There were a total of 265 summonses issued during the month of January, 2008: 165 – Village Area, 54 speeding and 111 for other; 81 – Route 130, 3 speeding and 78 for other. East of Route 130 – 19, 1 speeding and 18 for other. There had been ten (1) revoked driving summonses issued, three (3) for reckless driving, two (2) D.W.I., seven (7) unlicensed drivers and one (1) unregistered vehicle. The radar had been deployed on 111 occasions: Cranbury Neck Road-10. Dev Road-9. Halsey Reed Road-9. Maplewood-6, North Main-13, Old Trenton-9, Plainsboro Road-27, Route 130-3, South Main-8, South River Road-1, Station Road-7 and Undisclosed-17. The radar speed sign had not been deployed as normal--on 12 occasions: Cranbury Neck Road-1, Maplewood-2, Old Cranbury Road-2, South Main Street-5 and Station Road-2. The decoy car had been deployed on eight occasions: Cranbury Neck Road-1, Dey Road-2, Plainsboro Road-1, Route 130-1, South Main Street-2 and South River Road-1. The bike patrol had not been out during the month of January. Mayor Stout indicated he had been surprised by the large number of offenses for unlicensed and revoked drivers. Chief Hansen responded it is becoming more and more of a problem. Mayor Stout asked if the number of summonses issued had increased from January 2007. Chief Hansen indicated it had by a factor of 2.3. Mayor Stout asked what the highest speeding offenses had been on some of the Township's roads and streets. Chief Hansen reported: 52 m.p.h. on North Main Street (25 m.p.h.), 54 m.p.h. on Cranbury Neck Road (25 m.p.h.), Plainsboro Road – 69 m.p.h. (in a 45 m.p.h. residential zone). Chief Hansen stated the majority of credit goes to the newly-formed Traffic Bureau and he hoped to have the numbers the same next month, if not higher. Mr. Panconi asked the procedure when a driver is stopped for being unlicensed, etc. Chief Hansen reported the cars are taken to Cranbury Service Center or George's Garage and a member of his/her family with a driver's license may pick up the vehicle the next day. Mr. Panconi also asked about the trucks parking across from the BP Gas Station in the triangle overnight and asked if anything could be done about it. Ms. Stave indicated the property is owned privately and Chief Hansen indicated nothing could be done unless the Township passes an ordinance prohibiting overnight parking.

Mayor's Notes

Mayor Stout reported the Library Board of Trustees had sent a letter, indicating they had changed its by-laws in January to allow nine (9) members on the Board and that Andre Mento be appointed. Mayor Stout made the appointment. Mr. Mento's term will expire on 12/31/2012.

Mayor Stout also reported the Township had received a letter from the Middlesex County Transportation Coordinating Committee asking for two (2) Cranbury Township representatives. Mayor Stout reappointed Ms. Marcelli, Township Engineer and Ms. Stave. Mayor Stout urged everyone to look at the proposed 2008 Budget, stating a lot of hard work had gone into its preparation. Mayor Stout stated in particular, there are cap levies and other constraints on the Budget this year. In addition, Mayor Stout stated it was his feeling, the decrease in miscellaneous revenue is something new, however, the Township would most likely be seeing the same in the future. Mr. Wittman asked if the Budget was going to be posted on the Township's web site. Ms. Cunningham, Clerk, stated the Budget Summary will be posted on the web site on Tuesday morning and will be available to the public Thursday afternoon. Ms. Smeltzer explained the Budget has to be filed in Trenton first before the public may have it. Ms. Cunningham stated, because of that requirement (the State get the Budget first) the Budget will now be available on Friday from her office.
