Mayor Stout led in the salute to the flag and Ms. Cunningham gave the following Open Public Meetings Act statement:

Reports and Communications

--Mayor

Mayor Stout reported the Township had received an application for the 2009 Local Safety and High Risk Rural Roads Program and recommended the Township pursue the application. Mayor Stout stated the Program has a cap of over \$1-million and he noted most of the roads were in other counties. Mayor Stout reported the deadline to file an application is December 31, 2007. Mayor Stout asked the Township Administrator, Ms. Smeltzer, to review the application with the Township Engineer, Ms. Marcelli. Mayor Stout also reported he had received a telephone call from Freeholder Jim Polos, inquiring if the Township was interested in applying for an energy sustainability grant through the County, based on the Township's energy audit. Mayor Stout stated since the energy audit was not before the Township Committee yet, he would speak with the working energy group to determine if they could recommend some ideas. Freeholder Polos requested having the information by the end of the year. Messrs. Panconi and Wittman recommended doing something about the doors to Town Hall, noting they are not insulated doors. Ms. Smeltzer mentioned the heating system in the Fire House is ready to break down. Mayor Stout asked Mr. Panconi, liaison to the Fire Company, to research the issue and obtain any supporting data on the status of the heating system. Mayor Stout reported the paving is almost complete at The Four Seasons at Cranbury K-Hov Development.

Agenda Additions/Changes

Ms. Cunningham, Clerk, announced under Item # 10 on the Agenda, "Reports from Township Professionals and Staff", she had two items two report on: the first one being the recent General Election and the second, 2008 Mayor and Township Committee appointments to Township Board, Committees and Commissions. Also, three Resolutions were being added to the regular Resolution list: Cranbury Township Resolution # R 12-07-187, 188 and 189. Ordinance

Second Reading

Ms. Waterbury, Township Attorney, explained at the Township Committee meeting held on November 26, 2007, the Ordinance had been scheduled for a public hearing. At that time a decision had been made to table the Ordinance and in the interim the Professionals went back

and further reviewed the Ordinance. Ms. Waterbury stated, more significantly however, it was only one week away from the anticipated release of new rules by the Council on Affordable Housing dealing with Third Round Obligations for municipalities. She added, no one knows yet what the new rules will be, however, it was rumored there will be significant changes. Ms. Waterbury indicated it may be more appropriate to re-visit the Ordinance at the beginning of 2008. Ms. Waterbury recommended not taking any action on the Ordinance at the present time. Ms. Waterbury added, the reason for changing the zoning on the Route 130-D site was due to the Township's application to the State and delaying the Ordinance would not jeopardize the pending application.

A motion to enter an Ordinance entitled, "Cranbury Township Ordinance # 11-07-13, AN ORDINANCE OF THE TOWNSHIP OF CRANBURY, MIDDLESEX COUNTY, NEW JERSEY, AMENDING CHAPTER 150 OF THE CODE OF THE TOWNSHIP OF CRANBURY TO ADD A NEW R-ML III RESIDENTIAL MT. LAUREL II ZONE", was present for second reading and final adoption. The Ordinance was published in the Cranbury Press, posted on the Township Bulletin Board and website and copies were available to the public. The Mayor opened the public hearing on the Ordinance. Mr. Mark Berkowsky, representing Cranbury Housing Associates, stated there were details in the Ordinance he would be discussing with Professionals outside of a public forum and would be recommending some changes to the Ordinance. No one else present wished to speak, so the hearing was declared closed. On motion by Mr. Stannard, with no one seconding the motion, the Ordinance did not pass, due to lack of a motion.

Reports from Township Staff and Professionals

Report on Hazardous Route Evaluation: Ms. Waterbury, Township Attorney, reported she had reviewed the matter of developing a hazardous route evaluation further with the Township Administrator, Ms. Smeltzer. Ms. Smeltzer gave a brief summary, explaining the Township had been approached by the School to evaluate a hazardous route and she and Ms. Waterbury had determined the decision was not up to the Township. The Township's role would be to assist the School in determining a hazardous route. Ms. Smeltzer indicated the Statute, Title 18-A: 39-1.5, gives a number of ways of evaluating a hazardous route: population density, traffic volume, average vehicle velocity, existence or absence of sufficient sidewalk space, roads or highways that are winding or that have blind curves, roads and highways with steep inclines or declines, drop offs that are in close proximity to a sidewalk, bridges or overpasses that must be crossed to reach the School and busy roads or highways that must be crossed to reach the School. Ms. Smeltzer reported the Statute does re-iterate directly after giving the examples, "A school district must work with municipal officials in determining the criteria necessary for the designation of a hazardous route. Ms. Smeltzer added, she had spoken with Chief Hansen concerning the criteria listed in the State Statutes and he felt they were adequate and sufficient and recommended asking the School if they had any items they wished to add. Ms. Smeltzer offered to work with Ms. Waterbury and draft a letter to the School. Ms. Waterbury added, statutorily the Township does not have the authority to designate a hazardous route, rather it is the School Board's responsibility to come up with a hazardous route, as indicated in the Statutes. Ms. Waterbury suggested in addition, the letter state that homeowners had come to the Township Committee meeting to voice his displeasure concerning the lack of the School Board addressing the busing issue and safety of the children living on Cranbury Neck Road.

Report from Township Clerk

Report on recent General Election, November 6, 2007:

Ms. Cunningham, Clerk, reported on November 6, 2007 the General Election had been held. There were two (2) three-year seats up for election. Messrs. Stout, Stannard and Hasselbach were the three candidates for the two (2) seats. Mr. Stout received 578 votes, Mr. Stannard 548

and Mr. Hasselbach 553. However, when the absentee and provisional ballot votes were counted, Mr. Stout received 24 absentee and 3 provisional, for a total of 605, Mr. Stannard

received 28 absentee votes and two (2) provisional votes, for a total of 578 and Mr. Hasselbach received 15 absentee votes and one (1) provisional vote for a total of 569, making Messrs. Stout and Stannard the winners. Mr. Hasselbach filed for a re-count on November 21, 2007 and a re-count was taken at Middlesex County on Thursday, November 29, 2007. The County declared Mr. Stannard the winner. Ms. Cunningham reported she received the Official Election Returns from the County Clerk's Office on December 3, 2007. Ms. Cunningham noted, there are 2,519 registered voters in the Township and at the General Election 1,107 had voted; a little over 43% of the electorate.

Report on 2008 Appointments to Board, Committees, Commissions and Professionals

Ms. Cunningham, Clerk, reported on the 2008 Township Committee and Mayoral Appointments:

Ms. Cunningham reported on October 2, 2007 she had mailed out letters to all the Board, Committee and Commission Chairs requesting they let her know if any of their members did not wish to serve and if so, his/her recommendation to replace that person. To date all of the Chairs had responded. Ms. Cunningham also passed out charts showing the vacancies, chairs recommendations, etc. as well as a Draft Resolution for the re-organization meeting of Professional appointments which are usually made at that meeting (this year falling on January 7, 2008). Ms. Cunningham requested Township Committee members get back to her no later than December 28, 2007 with the information concerning appointments so she has enough time to prepare the Resolution for the re-org meeting.

Reports from Township Boards and Commissions

There were no reports.

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. There being no comments, the Mayor closed the public part of the meeting.

Mayor's Notes

Mayor Stout reminded everyone to be aware of safety while driving as this being a very busy Season, drivers are not always paying attention.

On motion by Mr. Wittman, seconded by Mr. Stannard and unanimously carried, the meeting adjourned at 7:40 p.m.
