The regular meeting of the Township Committee of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call was: Township Committee members: Richard Stannard, Pari Stave, David Stout and Wayne Wittman. Mayor Panconi was absent. Ms. Stave served as the Deputy Mayor. Also present was: Trishka Waterbury, Esquire, Attorney, Cathleen Marcelli, Engineer, Thomas C. Witt, Administrator and Kathleen R. Cunningham, Clerk. Deputy Mayor Stave led in the salute to the flag and Ms. Cunningham gave the following Open Public Meetings Act statement:

Ms. Stave reported, as a member of the Barn subcommittee, the Township and Lions Club had come to an agreement as to the use and occupancy of the two barns on the former Updike property. Ms. Stave explained the Resolution to adopt the Agreement would be on the Agenda for the meeting of August 28th as Messrs. Stannard and Stout could not vote on the Ordinance as members of the Lions Club and with Mayor Panconi absent, there would not be a quorum. Once the Township Committee votes and adopts the Ordinance the barns can then be repaired (the wagon house and corn crib). Ms. Stave also mentioned the Cranbury Historical and Preservation Society were actively seeing funds for the restoration and repair of the barns.

Ms. Stave also reported a meeting of the Recreation subcommittee had been held to preliminary look at the comments and statistics that had come from the public meeting held in July. Ms. Stave stated the subcommittee would wait until there was more clarity and facts of the input before presenting everything to the Township Committee and indicated one item that had been presented throughout the meeting had been a desire to have all types of recreation provided for all age groups. Ms. Stave indicated the subcommittee would go back to the Planning Board with that recommendation to get the process moving.

--Subcommittees (Continued)

Ms. Stave reported she had attended a Human Services meeting a few weeks ago at which Peg Chester, Middlesex County, addressed the members. Ms. Chester presented some of the County programs which were available to seniors living in the Township. Ms. Stave explained, without a community senior center it was difficult for the Township to utilize those services and recommended that a specific room be designated in Town Hall for use by the seniors. Ms. Stave asked for the Township Committee's approval to designate the Recital Room in the lower level of Town Hall for use every day and possibly weekends for use by the seniors. Ms. Stave stated some of the uses would be: one-half day per month for free counseling, another round of consulting for seniors for Medicaid Part B Prescription Drug Plan, senior exercise programs. Motor Vehicles to do a presentation on safety and conduct a course on safe driving so that seniors could get a reduction in their car insurance as well as to provide picture I.D.s to those without driver's licenses and to have the County Surrogate's Office conduct a seminar on wills and livings wills. The Township Committee unanimously supported Ms. Stave's recommendation. Ms. Stave also stated the Human Services Commission would be having a table at Cranbury Day near the Township Committee's table and would be distributing information to seniors on counseling and other issues. Ms. Stave reported the Township had not been using the allocated hours for counseling services available from the Social Services Director, who is shared by Plainsboro Township. The hours do accumulate so the Township will not lose them. Ms. Stave added, John Ritter would be working with the Clerk, to improve the data base on the Township's web site for seniors.

Mr. Stout reported he and Mr. Dietrich Wahlers, E.C. member, had attended a D.E.P. Seminar. Mr. Stout stated he had attended several sessions--beneficial uses of landfills, funding and how funding mechanisms and reimbursements occur when the cleanup of brown fields are involved and "brown fields to green fields".

Mr. Stout also reported the Township had received a letter on August 4th from the Attorneys for the owners of the former Unexcelled property, asking the Township to amend the 208 Sewer District. Mr. Stout asked that this item be a Work Session item on September 11th and asked that Ms. Marcelli be present to discuss this with the Township Committee and to let them know the process, whether or not there is a regulatory clock involved and what the response options would be for the Township. Mr. Wittman recommended that the Township look at expanding the service in that area as well to others. Ms. Stave recommended the Township address the issue of changing the zoning to exclude the wetlands from the calculation of the F.A.R. Ms. Waterbury, Township Attorney, indicated Mr. Van Hise, who had substituted for her at the Township Committee meeting in which this issue had been discussed, had a note indicating he had been asked by the Township Committee to track down an Ordinance from Hillsborough Township and was unable to locate it. Mr. Stout indicated he had a copy and had provided both Tom Harvey, Planning Board Chairman and Joe Stonaker, Planning Board Attorney, a draft copy of an Stream Corridor Ordinance, prepared by the Stony Brook Millstone Water Shed, which incorporated the Hillsboro Ordinance into it. Mr. Stout recommended the Township move forward in the adoption of the Stream Corridor Ordinance which had been prepared by the Water Shed.
