A RESOLUTION AUTHORIZING EXECUTION OF AGREEMENT FOR SALE OF DEVELOPMENT EASEMENT TO THE STATE AGRICULTURE DEVELOPMENT COMMITTEE.

WHEREAS, the Township Committee has, by Ordinance and as required by the Local Lands and Buildings Law, N.J.S.A. 40A:12-1 et seq., authorized the sale of a development easement and all of the nonagricultural development rights and development credits on property designated on the Tax Map of the Township of Cranbury as Block 23, Lot 12.01 and Block 25, Lot 19 and commonly referred to as the Barclay Farm ("Property") to the State Agriculture Development Committee (SADC); and

WHEREAS, the sale of the development easement and all of the nonagricultural development rights and development credits to SADC shall ensure the permanent preservation and restriction of the Property to agricultural use pursuant to the Agriculture Retention and Development Act, N.J.S.A. 4:1C-11 et seq. and the Garden State Preservation Trust Act, N.J.S.A. 13:8C-1 et seq., and the rules and regulations adopted pursuant thereto; and

WHEREAS, in consideration for the sale, the SADC will pay the Township \$14,400.00 per acre; and

WHEREAS, the sale shall be subject to such other reasonable terms and conditions as set forth in an Agreement to Sell Development Easement.

PUBLIC HEARING COMMUNITY DEVELOPMENT BLOCK GRANT

Mayor Stannard opened the Public Hearing on the Community Development Block Grant at 7:30 p.m. The \$19,500 in funds will be used to fund low to moderate housing needs in the Township of Cranbury. Additional projects based on community needs being evaluated is the placement of ADA accessible playgrounds in the Township Parks or improving pedestrian access via sidewalks and curb cuts along pedestrian walkways.

Mr. Mark Berkowsky, representing Cranbury Housing Associates, mentioned that last year, \$50,000 was given to the CHA under this grant.

There being no further comments, the Mayor closed the public hearing at 7:43 p.m.

b. Police Station Update

Mark Berkowsky provided the Township Committee with the monthly status report on the Cranbury Police Station. Mr. Berkowsky mentioned that the ground breaking may now be delayed until May 2004 with an occupancy of 2005. Mr. Panconi requested that the architect, Mr. Schmitt be present at the next Township meeting on February 9, 2004.

a. Cranbury Municipal Assessment Report

The final report on the assessment by Stony Brook-Millstone Watershed Association for Cranbury Township was given by Noelle J. MacKay. The Watershed presented two suggestions. Those suggestions are to conduct an Environmental Resources Inventory with the help of the Environmental Commission and create (and adopt) a Stream Corridor Ordinance. The Township Committee requested that the Environmental Commission review the report and then give the Township Committee its recommendations.

b. Preservation of Barclay Farmhouse and building

Bobbie Marlow of HPAC and Gail Hunton, HPAC historic consultant, addressed the Township Committee on preserving the farmhouse and buildings located on the Barclay South Property. The Township Committee requested the Township Attorney to review the Township's options concerning an easement and a decision will be made at the next Township meeting on February 9, 2004.

c. Township Employee Manual

The proposed Employee Manual complies with both the requirements set forth by the Joint Insurance Fund (JIF), that the Township is a member of and the Municipal Excess Liability Fund (MEL). Both of these organizations have encouraged municipalities to review and have an approved plan on file by 1 March 2004. The Township Committee reviewed and amended several items in the Manual. Mr. John Ritter, Plainsboro Road requested that copies be made available to the public for review. Mr. Carr, Township Administrator will provide Mr. Ritter with a copy. This item will be on the agenda of February 9, 2004 for further consideration.

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Ms. Betty Wagner, Township Historian asked the status of the Holland House. The Township Attorney explained that the County has not yet recorded the Deed and this is causing a delay. There being no further comments, the Mayor closed the public part of the meeting.
