Mayor Stannard also reported the homeowners there are very conscientious about lining up the students for the bus. They have assigned seating on the bus for the students; being very well organized. Some inpatient drivers are running the stop sign.

WHEREAS, D&R has entered into an agreement with John H. Kirkenir (Alliance Homes) and Warren Kiesler to acquire the Kiesler farm in order to preserve it permanently as deed-restricted farmland; and

WHEREAS, in connection with the above-referenced acquisition, D&R will also obtain a fee simple interest in property located on John White Road in Cranbury Township and designated on the Cranbury Township Tax Map as Block 22.01, Lot 2 (the "White" property); and

WHEREAS, the Township Committee finds that it is the public interest to assist D&R with the abovereferenced acquisition and to acquire said permanent right of public access and use for passive recreation and conservation purposes, either alone or in conjunction with the County of Middlesex; and

WHEREAS, the Township Committee of the Township of Cranbury adopted Ordinance 10-04-25, entitled "Bond Ordinance Providing for the Acquisition of Land for Use as Open Space by the Township of Cranbury, in the County of Middlesex, New Jersey, Appropriating \$500,000 Therefor and Authorizing the Issuance of \$500,000 Bonds or Notes of the Township for Financing the Cost Thereof"; and

3. The Mayor, Administrator, Clerk, Attorney, Engineer, and other appropriate officers and employees are hereby further authorized and directed to undertake any and all such acts and execute any and all such documents as may be necessary to effectuate the purposes hereof.

4. This ordinance shall take effect upon passage and publication, as required by law.

§ 33-10. Private duty service.

Police officers of the Cranbury Township Police Department shall be available for private duty service for special events, road closings, traffic duties, security at private parties or events, etc. Payment for services shall be as follows:

1. The fee to be paid to the Township for such services shall be sixty dollars (\$60.00) per hour. Of this amount, fifty dollars (\$50.00) per hour shall be paid to the police officer providing the service and ten dollars (\$10.00) per hour shall be retained by the Township.

- The minimum amount of time for which police officers may be hired shall be four (4) hours per officer, except that the minimum shall only be three(3) hours per officer for services rendered on behalf of The Cranbury School.
- 3. Any person who has requested private duty service and cancels the private duty three hours or less before the agreed upon start time shall be responsible for payment of the four (4) hour minimum per officer, except that The Cranbury School shall only be responsible for payment of the three (3) hour minimum per officer in such instances.

a. Scout Service Projects on Township Property

Ms. Marcelli briefed the Township Committee and indicated she had spoken to Mr. Mark Berkowsky regarding this issue as it affects the new Police Station location. It was recommended this issue be referred to the Police Station SubCommittee and ask Verizon to explain to the SubCommittee why the location must be at the new police station site.

Public Comment

The Mayor opened the meeting to public questions and comments on those items not on the agenda. Mr. Mark Berkowsky asked the status of the negotiations with Comcast Cable, with reference to the new police station. Ms. Beauregard responded the Township is still in negotiations with Comcast. Mr. Richard Kallan, Wynnewood Drive asked if the putting of golf balls had been addressed in the ordinance, 11-04-27, which had been adopted this evening as he has noticed individuals putting golf balls at various Township parks. Mayor Stannard responded the police would be enforcing the ordinance and all safety issues in the parks. Ms. Beth Veghte, Bunker Hill, also responded to Mr. Kallan the police would be monitoring the parks. There being no further comments, the Mayor closed the public part of the meeting.

Ms. Beth Veghte, Recreation Board Chairperson, requested a sign be placed at the entrance to the West Property, directing people to the soccer and lacrosse fields. Ms. Veghte indicated there is a problem, especially for out of town individuals, finding the fields. The Township Committee discussed the signage with Ms. Veghte and recommended the issue be brought up at the Parks meeting on Wednesday and also provide the Township Engineer, Ms. Marcelli, with a diagram of the proposed sign. Mayor Stannard indicated the matter could then be discussed again at the December 20th meeting. Ms. Stave recommended the Parks Planning Commission work on standardizing signs throughout the Township as some of the parks have signs and not others.

Public Comment (Continued)

Ms. Beauregard made a recommendation the Township Committee be given an inventory of which parks need signs, how many, etc. Mayor Stannard indicated this issue will be listed as a Work Session item on the agenda of the December 20, 2004 meeting.

Mayor's Notes

Mayor Stannard indicated a letter had been received from Mr. and Mrs. Gerberich concerning some of the safety issues, signs, stripings in the road and possibly sidewalks in the Evans Tract and the Township Committee would be looking into that.

The Township Committee discussed not having a meeting on December 27, 2004, due to the holidays. On motion by Ms. Stave, seconded Ms. Beauregard and unanimously carried, the meeting of December 2004 was canceled.
