Demystifying Local Government – Encore Presentation – Mr. Ferrante –

Mr. Ferrante began with thanking Boy Scout 52 for their attendance at the meeting. Mr. Ferrante gave an encore presentation of the "Demystifying Local Government" presentation for the public. Mr. Ferrante began with the disclaimer that the presentation was to be used as an educational guide and not a legal document. The presentation covered many common questions asked regarding local government. He opened the floor to members of the audience for any questions. A member of the audience asked what the age limit was for volunteers on the boards and commissions, which was answered with 18 years of age. A Cub Scout asked that the Cub Scouts also be recognized as being in attendance along with the Boys Scouts. Another member of the audience questioned if when the Mayor speaks, whether publicly or written, does he have the authority to represent the Township Committee as a whole? Is he publicly speaking for the Township Committee? Mr. Goodell, Township Attorney, answered that due to the current form of government, the Mayor is considered one of five members and all have equal voting powers. The committee members vote amongst themselves to elect a Mayor annually and the Mayor then leads and sets the agendas, however, all are equal. When any Mayor is speaking in public it should be viewed as their opinion only and may not represent the views of the other members of the committee. Mr. Ferrante advised the audience that the

presentation would be available on the township website for additional viewing. Ms. Betty Conover ended public comment with her thanks to Mr. Ferrante for the presentation.

• Members of Committee -

Dr. Rogers –

Dr. Rogers reported on the Cranbury Historical Preservation Society. She stated the society has requested information regarding the Danser property. Dr. Rogers conveyed information from Shade Tree Commission regarding Arbor Day on April 24th and "Shade Tree's focus on tree healthcare and planting". She stated they are currently trying to locate a special area for the planting of a Salem Oak sapling on Main Street that was supplied to all municipalities from a historic tree. Dr. Rogers reported the Sustainability Subcommittee met and the Wellness Fair is scheduled for May 16th at the Cranbury School. Dr. Rogers added later in the meeting that the Communication Subcommittee is waiting for the new sound system to be installed to move forward with recording committee meetings in order to have the video placed on a site such as YouTube for viewing. Ms. Marabello advised the sound system has been ordered and is planned for installation in the Spring.

Mr. Ferrante –

Mr. Ferrante reported there were four (4) candidates to fill the vacancy on the Board of Education left by Mrs. Spann's election to the township committee. The replacement has been chosen.

Mr. Ferrante shared a story regarding the strong sense of community in Cranbury for helping a local family after their loss of a family member.

Mrs. Spann –

Mrs. Spann met with the Fire Department as Building and Grounds and discussed improvements that were requested to be made at the station. She also completed a walkthrough of the History Center. She attended the last Historic Preservation Committee meeting and reported the next Planning Board meeting had a change in date.

Mayor Scott –

Mayor Scott reported on the most recent Coffee with the Mayor and Police Chief at Teddy's. He reported that many residents discussed concerns with truck traffic and intersections (no right turn on red). Their concerns have been referred to the Traffic Subcommittee for review.

Mayor Scott advised that he met with PSE&G regarding the implementation of lighting across from Heritage Park. Their discussion covered partial changing of existing lights and/or adding light fixtures and he reported on monetary differences of the two options. The members were in agreement to move forward with the installation of new lights and the replacement of what was recommended in the contracts.

Mayor Scott reported on his meet and greet with the township employees at Town Hall. Ms. Marabello coordinated a time for the Mayor to be available for all employees to meet him and become acquainted with employees from each department.

BOND ORDINANCE AUTHORIZING THE DREDGING OF BRAINERD LAKE APPROPRIATING \$4,000,000 THEREFORE AND FUNDING \$1,600,000 FROM CAPITAL IMPROVEMENT FUND AND \$200,000 FROM CAPITAL SURPLUS AND AUTHORIZING THE ISSUANCE OF \$2,200,000 BONDS OR NOTES OF THE TOWNSHIP TO FINANCE PART OF THE COST THEREOF.

BE IT ORDAINED BY THE TOWNSHIP COMMITTEE OF THE TOWNSHIP OF CRANBURY, IN THE COUNTY OF MIDDLESEX, NEW JERSEY (not less than two-thirds of all members thereof affirmatively concurring) AS FOLLOWS:

Section 1. The several improvements described in Section 3 of this bond ordinance is hereby authorized to be undertaken by the Township of Cranbury, in the County of Middlesex, New Jersey (the "Township") as a general improvement. For the several improvements or purposes described in Section 3, there is hereby appropriated the sum of \$4,000,000, including the sum of \$1,600,000 as the down

payment required by the Local Bond Law. The down payment is available by virtue of provision for down payment or for capital improvement purposes in one or more previously adopted budgets.

Section 2. In order to finance the cost of the improvement or purpose not covered by application of the down payment, negotiable bonds are hereby authorized to be issued in the principal amount of \$2,200,000 pursuant to the Local Bond Law. In anticipation of the issuance of the bonds, negotiable bond anticipation notes are hereby authorized to be issued pursuant to and within the limitations prescribed by the Local Bond Law.

Section 3. (a) The improvement hereby authorized and the purpose for financing of which the bonds are to be issued for the dredging of Brainerd Lake.

- (b) The estimated maximum amount of bonds or notes to be issued for the improvement or purpose is stated in Section 2 hereof.
- (c) The estimated cost of the improvement or purpose is equal to the amount of the appropriation herein made therefore.

Section 4. All bond anticipation notes issued hereunder shall mature at such times as may be determined by the chief financial officer; provided that no note shall mature later than one year from its date. The notes shall bear interest at such rate or rates and be in such form as may be determined by the chief financial officer. The chief financial officer shall determine all matters in connection with notes issued pursuant to this ordinance, and the chief financial officer's signature upon the notes shall be conclusive evidence as to all such determinations. All notes issued hereunder may be renewed from time to time subject to the provisions of the Local Bond Law. The chief financial officer is hereby authorized to sell part or all of the notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The chief financial officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the notes pursuant to this ordinance is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the notes sold, the price obtained and the name of the purchaser.

Section 5. The Township hereby certifies that it has adopted a capital budget or a temporary capital budget, as applicable. The capital or temporary capital budget of the Township is hereby

amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. To the extent that the purposes authorized herein are inconsistent with the adopted capital or temporary capital budget, a revised capital or temporary capital budget has been filed with the Division of Local Government Services.

Section 6. The following additional matters are hereby determined, declared, recited and stated:

- (a) The improvement or purpose described in Section 3 of this bond ordinance is not a current expense. It is an improvement or purpose that the Township may lawfully undertake as a general improvement, and no part of the cost thereof has been or shall be specially assessed on property specially benefitted thereby.
- (b) The period of usefulness of the improvement or purpose within the limitations of the Local Bond Law, according to the reasonable life thereof computed from the date of the bonds authorized by this ordinance, is 40 years.
- (c) The Supplemental Debt Statement required by the Local Bond Law has been duly prepared and filed in the office of the Clerk, and a complete executed duplicate thereof has been filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs of the State of New Jersey. Such statement shows that the gross debt of the Township as defined in the Local Bond Law is increased by the authorization of the bonds and notes provided in this bond ordinance by \$2,200,000 and the obligations authorized herein will be within all debt limitations prescribed by that Law.
- (d) An aggregate amount not exceeding \$100,000 for items of expense listed in and permitted under N.J.S.A. 40A:2-20 is included in the estimated cost indicated herein for the purpose or improvement.

Section 7. Any grant moneys received for the purpose described in Section 3 hereof shall be applied either to direct payment of the cost of the improvement or to payment of the obligations issued pursuant to this ordinance. The amount of obligations authorized but not issued hereunder shall be reduced to the extent that such funds are so used.

Section 8. The chief financial officer of the Township is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection

valorem taxes upon all the taxable real property within the Township for the payment of the obligations
