### **Reports and Communications**

- Mr. Ferrante Thanked Mayor Scott and the members of the Fire Commission, First Aid Squad, Police Department and Department of Public Works employees that participated in the Memorial Day Drive-By Parade within the Township.
  - Mr. Ferrante reported he remotely attended both the Environmental Commission and Board of Education meetings.
- Dr. Rogers Reported she attended the Parks Committee meeting remotely and thanked the Department of Public Works for their work in the township parks. She added the next Shade Tree Commission would be held in June.
  - Dr. Rogers further added that the Memorial Day parade was well received by township residents.
- Mrs. Spann Reported on attending these various meetings; Planning Board, Historic Preservation Commission, Municipal Alliance and Zoning Committee. The Zoning Committee has two recommendations that they plan to present to the Township Committee once public meetings return to in person forum. The Zoning Committee's next meeting is scheduled for June and will be discussing work needed on the current sign ordinance.

- Mr. Taylor Announced the passing of township resident Bonnie Thompson. Mr. Taylor remembered her work with the Historical Society and Lions Club, where she served her community for over 50 years.
  - Mr. Taylor thanked all that participated in the Memorial Day Parade. He added that the parade route did highlight low hanging branches from trees that restrict fire apparatus. Mayor Scott asked Mr. Taylor to supply a list for the Department of Public Works to address hazards.
  - Mr. Taylor reported he remotely attended the Board of Recreation Commissioners meeting. Mr. Taylor stated discussion on summer camp and drive in movies.
  - He added that the current deer ordinance be reviewed regarding the lottery to address active duty and deployed members to insure they can participate in the lottery system for the hunt. Steve Goodell, Township Attorney, to review.
- Mayor Scott Thanked everyone for helping the Lions Club successfully complete the Drive By Memorial Day Parade. He thanked the Fire Company, First Aid Squad, Police Department, Department of Public Works and the Lions Club.
   Mayor Scott added the following:
  - Sidewalks Bikes not sharing the sidewalks with walkers and not yielding to pedestrians.
     He spoke to Chief of Police and Chief Varga will forward concerns to the Traffic Bureau.
  - He wants to acknowledge 2020 seniors and provide something for graduation.
  - His speech at the War Memorial for the Memorial Day Parade was placed on a Cranbury Township YouTube channel.
  - Mr. Ferrante asked Ms. Marabello the status of the accessibility of Town Hall and the employees. Ms. Marabello advised that employees have returned on staggered shifts Monday -Friday. Few employees have been in the building daily since the pandemic began, including herself and Municipal Clerk Debra Rubin. Others were directed to work remotely prior to the return on staggered shifts. Town Hall will open to the public once other safety provisions are put into effect. Necessary supplies need to be obtained prior to opening. Town Hall should be prepared for opening to the public in the next few weeks. Mayor Scott questioned when public meetings would be able to resume in Town Hall. Ms. Marabello advised that due to social distancing guidelines the meeting room in Town Hall will only allow approximately 8 members of the public to attend.

### Work Session -

a). Economic Development Advisory Committee Discussion – Mayor Scott introduced this as a need for a comprehensive plan to market the town with retaining the existing businesses and attracting new businesses. Scott Miccio, Township Attorney, presented a draft ordinance for the members to review based on plans utilized from other towns. He advised that this ordinance would not solely be for use during COVID 19 as it is written to last through December 2022. Mr. Miccio reviewed the contents of the draft ordinance, which included; establishing the committee, membership, terms, powers & duties, expenditures & funds, advisory function, meeting schedule and need for recording secretary amongst members. He presented the contents to the members in order for a decision to be made on moving forward with an ordinance or redrafting as a resolution. Mayor Scott opened the discussion to the committee members. Members of the committee discussed their various reasonings for either ordinance or resolution in the establishment of the

SECTION 1: There is hereby approved as a capital project within the Township of Cranbury not to exceed the costs noted below:

Project/Purpose Cost

Dredging of Brainerd Lake \$650,000.00

SECTION 2: There is hereby appropriated from Capital Surplus in the sum of \$650,000.00 to cover the cost of the capital projects as described in Section 1 hereof.

SECTION 3: This Ordinance shall take effect upon final adoption and publication according to law.

SECTION 4: The capital budget of the Township of Cranbury is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith. ### **CRANBURY TOWNSHIP ORDINANCE 05-20-08**

### ORDINANCE ESTABLISHING A TEMPORARY PROCESS FOR PERMITTING OUTDOOR DINING

WHEREAS, on March 9, 2020, the Governor issued Executive Order 103, declaring a State of Emergency and Public Health Emergency throughout the State of New Jersey as a result of the COVID-19 coronavirus pandemic; and

WHEREAS, on March 16, 2020, the Governor issued Executive Order 104, limiting the scope of service and hours of operation for restaurants and certain retail establishments to balance the need to allow individuals to access food and other essential materials with the need to limit unnecessary person-to-person contact; and

WHEREAS, on March 21, 2020, the Governor issued Executive Order 107, further limiting the scope of service for restaurants as follows:

All restaurants, cafeterias, dining establishments, and food courts, with or without a liquor license, all bars, and all other holders of a liquor license with retail consumption privileges, are permitted to operate their normal business hours, but are limited to offering only food delivery and/or take-out services in accordance with their existing liquor licenses. If alcoholic beverages are to be sold from a restaurant, dining establishment or bar with a liquor license, such sales shall be limited to original containers sold from the principal public barroom. The on-premises consumption of alcohol is prohibited. All retail sales of alcoholic beverages by limited brewery licensees, restricted brewery licensees, plenary and farm winery licensees (and associated salesrooms), craft distillery licensees and cidery and meadery licensees must be in original containers and must be sold through customer pick up and/or delivered by licensees in accordance with their existing licensees.

WHEREAS, Executive Order 107 recognized that the Centers for Disease Control and Prevention ("CDC") has advised that social mitigation strategies for combating COVID-19 require every effort to reduce the rate of community spread of the disease and that COVID-19 spreads most frequently through person-to-person contact when individuals are within six feet or less of one another, and ordered further steps to mitigate community spread of COVID-19; and

WHEREAS, on March 21, 2020, the Governor issued Executive Order 108, invalidating any municipal restriction that in any way will or might conflict with any of the provisions of Executive Order 107; and

WHEREAS, if and when the Governor relaxes the limitation on scope of service and hours of operation for restaurants, those restaurants will likely be required to meet health-related social distancing guidelines; and

WHEREAS, restaurants in Cranbury Township may desire to offer outdoor dining as a way to meet those social distancing guidelines; and

WHEREAS, the Township Committee would like to establish a process for licensing outdoor dining during the State of Emergency and Public Health Emergency that is expeditious and efficient, while continuing to protect the public health, safety and welfare of the community; and

WHEREAS, outdoor dining is currently regulated through Cranbury Township Code Chapter 106, which establishes the requirements for an Outdoor Dining License, and Chapter 150-39, which permits outdoor dining as an accessory use in certain zones, provided the restaurant meets the requirements of the section which include, among other things, site plan approval; and

WHEREAS, the Municipal Land Use Law prohibits interim zoning ordinances except "in cases where the municipality demonstrates on the basis of a written opinion of a qualified health professional that a clear imminent danger to the health of the inhabitants of the municipality exists, and in no case shall the...interim ordinance exceed a six-month term" (NJSA 40:55D-90b); and

WHEREAS, the Governor's State of Emergency and Public Health Emergency recognize that the spread of COVID-19 presents a clear imminent threat to the health of all residents of the State of New Jersey.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, County of Middlesex, State of New Jersey, as follows:

Section 1. For the duration of the Governor's State of Emergency and Public Health Emergency, but for no longer than a period of six months from the effective date of this Ordinance, the requirements of Cranbury Township Code Chapter 106, "Outdoor Dining License," are temporarily modified as follows:

Section 106-2 Outdoor Dining License Required: Term: Annual Renewal

\*\*\*

E. In the case of an application for a renewal license only, if the outdoor dining use or layout is to be modified, the applicant shall first prepare and submit a new plan to the Township Zoning Officer, who shall determine whether such modification requires amended site plan approval from the applicable land use board distribute the new plan to the Chief of Police and the Municipal Health Officer for their review, and approve the plan provided it protects the public health, safety and welfare of the municipality and otherwise complies with the requirements of Chapter 106.

Section 106-3 Application Process

- A. Application for an initial outdoor dining license or a renewal license shall be made to the Township Clerk.
- B. The application shall be accompanied by the following:
  - (1) (Reserved)
  - (2) In the case of an initial application only, the resolution of approval from the appropriate land use board of the site plan for the outdoor dining use.
  - (3) In the case of a renewal application only, a signed certification from the applicant that all conditions of the site plan approval continue to be met.
  - (4) Insurance certificate as set forth in § 106-6 below.
  - (5) Proof that the applicant holds a valid occupational license for a business establishment.
- C. The Township Clerk shall approve or disapprove the application within 15 calendar days following its submission.

Section 2. For the duration of the Governor's State of Emergency and Public Health Emergency, but for no longer than a period of six months from the effective date of this Ordinance, the requirements of Cranbury Township Code Chapter 150-39, "Outdoor Dining Areas," are suspended.

Section 3. If any portion of this Ordinance is deemed invalid by any court of competent jurisdiction, the remainder shall survive in full force and effect.

Section 4. This Ordinance shall be effective immediately upon adoption and publication in accordance with law.
