Reports and Communications

- Mr. Ferrante Mr. Ferrante attended the Environmental Commission meeting, where the EC received a comprehensive overview of stormwater management from the Watershed. Mr. Ferrante acknowledged the terrible fire at Cranbury Pizza, and expressed relief that no one was hurt. He thanked the members of the Township Committee for contributing towards the \$500 Target Gift Card presented to the family that evening. He also thanked the members of the community who contributed to the GoFundMe that Laura Zurfluh arranged that evening, that currently has \$38,800 raised. He also asked Ms. Rubin to address the primary process when it came to departmental updates.
- Dr. Rogers Dr. Rogers requested Mr. Goodell explain the process when an individual make changes to township property. Mr. Goodell explained the township cannot maintain improvements made by residents and can inadvertently cause a liability. He expressed that all requests are to be made to the township's proper governing body in order to be properly vetted, regardless of size of request.

- Mrs. Spann She reported she attended the Middlesex 2040 Strategic Planning meeting. She also reported on attending the Zoning Committee, Municipal Alliance and Historic Preservation Commission meetings respectively.
- Mr. Taylor –. Mr. Taylor announced the Cranbury Business Association agreed to conduct the Town Wide Garage Sale.
 - Mr. Taylor then requested the members approve the expenditure of funds currently budgeted for the township fireworks to be used on the newly scheduled Drive-In Movie Night sponsored by the Board of Recreation Commission. Ms. Marabello questioned the cancellation of the annual township fireworks. Mayor Scott commented the intent is to postpone the fireworks until the Fall. Mr. Taylor reported the Recreation Commission was also planning on offering Summer Camp to Cranbury residents. He supplied the starting dates and the plan for closure of portion of park with snow fences being erected. Mr. Ferrante asked that Mr. Taylor extend the committee's gratitude to Tim Brennan for his exemplary work on preparing for Summer Camp.
 - Mr. Taylor to provide Ms. Marabello with contact information to send Cranbury Township flag with Kevin Lowery to be flown in Antarctica.
- Mayor Scott Mayor Scott will be participating in the upcoming public portion of Bicycle Network Plan meeting on June 23rd.
 - He reported the Mandala event, organized by resident Eman El-Badawi, was a successful event and attended by many community members. He added that the Candle Light vigil that followed was equally well attended and thanked everyone for making it successful, including the Cranbury Township Police Department.
 - Mayor Scott discussed the recent fire devastating local business, Cranbury Pizza. He reported on how the community reacted by starting a GoFundMe page for the displaced residents, spearheaded by resident Laura Zurfluh, and the action of the Cranbury Presbyterian Church by assisting in housing the family with a donation from an anonymous donor.

Subcommittees -

• Ms. Marabello discussed her follow up item on how to move forward with future Township Committee meetings. Information she received shows that maintaining virtual public meetings is currently the best option. In person meetings would require participants wearing masks and must allow for social distancing. Virtual meetings allow for more members of the public to attend. The suggestion of the using the Large Group Room is not an option as it is currently not open to the public and the Township Committee meetings would not take precedence for scheduling purposes. She recommended continuing all future meetings virtually until masks are no longer a requirement for attendees.

- Ms. Rubin provided information on the upcoming Primary Election being held on July 7th. She discussed material regarding the vote by mail process and locations for drop boxes. She reported on the weekly communications, which include all Middlesex County Clerks, the Board of Elections and the County Clerk's Office. Ms. Rubin added that material has been placed on the township website, sent to residents via email blast, a video placed on the township cable channel and Nixle alerts will be sent, all in an effort to help voters be informed on the process for the election.

Cranbury Township Land Development Ordinance § 150 – 43 Parking and loading areas:

Richard Preiss, Township Planner, explained this is the first of two proposed township ordinance amendments.
