Mr. Taylor reported the Fire Company did rescue training over the past weekend. He stated Cranbury attended the event with

# --Mr. Mulligan

Mr. Mulligan gave an update on the capital expense of a new server for the Police Station. He reported he met with Ms. Marabello, Lt. DeChiara and Abdul Hasan, the Township's IT consultant, to discuss the issue. He recommended approving the capital expenditure; however he stated it would not be used this year unless necessary. He stated next year the Township will have to spend funds to upgrade the infrastructure. Mr. Mulligan stated he is very comfortable with how the IT system is configured, including redundancy at both sites as well as cloud backup. Ms. Goetz inquired what would happen if one server failed, and Mr. Mulligan stated it could be replaced within a number of days. He stated that is why the funds should be available in case a server needs to be replaced this year. Mr. Mulligan stated there was also discussion about changing the Township's e-mail service next year.

#### --Ms. Goetz

Ms. Goetz reported she was invited to talk to the Presbyterian Seniors at their monthly breakfast. She stated there was a great turnout at the Cranbury Inn and stated there was a lot of interest in the development projects. She stated there was also interest in the budget.

#### --Mr. Johnson

Mr. Johnson reported most of his regularly-scheduled meetings over the last two (2) weeks were cancelled. He reported he attended the Princeton School Board Meeting, and there was discussion about the Princeton Charter School. Mr. Johnson stated the only update he could provide was that there are talks underway between the Princeton School Board and the Board of Directors of the Charter School to try to find a way to co-exist, and future funding requests will be a part of that effort. Mr. Johnson reported a decision concerning the funding should come from the Education Commissioner in the next few weeks.

### Public Hearing Community Development Block Grant

Mayor Cook officially opened the Public Hearing on the 2017 Community Development Block Grant of \$22,737.00. Ms. Cunningham announced, for the record, that this public hearing was advertised in the Trenton Times, posted in the Senior Room at Town Hall, posted at the Township's senior housing, posted on the Township's website, and posted on the Bulletin Board.

Mr. Mark Berkowsky, President of Cranbury Housing Associates, described for the public that the Community Development Block Grant Program is a federal program that flows through the County and the County administers the money. He reported when he first started the annual funding was approximately \$40,000 a year and that has now dwindled down to a little less than \$23,000 a year, which has remained fairly constant the last several years. Mr. Berkowsky explained that money comes to Township through an application grant program. He stated an application is completed every year, the details of the program are explained to the public and they propose what the funds should be used for each year. He stated in the past HVAC system and water heaters have been replaced. He stated they are hoping to use this year's funds to offset site engineering costs. He reported to date, the Township has received approximately \$100,000 in total under this grant.

Mayor Cook asked if there were any questions or comments from the public, and having none, closed the public portion of the hearing. He thanked Mr. Berkowsky for all of his time and hard work with affordable housing. Mayor Cook requested a motion to adopt the Resolution.

Update on Applewood Court by Mr. Mark Berkowsky

Mr. Mark Berkowsky, President of Cranbury Housing Associates, provided an update on the Applewood Court Project to the Township Committee. He stated what is on the record right now is that the funding is not to exceed \$4 million. He stated they are at the \$4 million number right now. He stated the biggest expense has been bringing water to the site. Mr. Berkowsky stated the construction has just started and there is some potential savings there. He stated the "soft" costs are eating up the budget. He stated it will be

Update on Applewood Court by Mr. Mark Berkowsky (cont'd.) important to get the apartments rented so the construction loan, which is expensive, can be converted to permanent loan, which is much cheaper. Mr. Berkowsky estimates funding will be needed around the June timeframe. Mayor Cook clarified that the water was the only item that was above and beyond what the budget called for.

Mr. Berkowsky stated CHA will start advertising for pre-applications for tenants on February 17<sup>th</sup>. He stated that period is for 90 days, which satisfies a requirement for veterans. After that 90-day period, there will be a lottery called a "random prioritization" because it is how the applications are viewed. He stated that process will be done in public in the Meeting Room where names will be picked and numbers assigned. Around May 24th applications will be put in different "buckets" according to family size and income to see who is qualified. Mr. Berkowsky stated final applications will be mailed on May 30<sup>th</sup> and on June 1<sup>st</sup> they will start showing the property. He stated occupancy should be between June and September. Mr. Berkowsky stated it is essential to obtain the easement to proceed with the Project. Ms. Marabello stated she spoke with the attorney earlier who reported a Judge still had not been assigned to the case and also the courts were backlogged. She emphasized to the attorney that this was high priority; however, the attorney cannot force the case to be scheduled. Ms. Goetz inquired about applicants currently on the affordable housing waiting list. Mr. Berkowsky explained this will be a separate list, and applicants will have to reapply to be considered for the Applewood Court lottery. He stated the units should be fully occupied within the three-month period. Ms. Goetz inquired if there is a demand and would a lottery be necessary. Mr. Berkowsky stated there is demand.

Mr. Berkowsky stated CHA submitted a document as a request to the Court to allow the income levels to be updated on an annual basis. He stated COAH has not adjusted the levels over the past several years. The Township Committee thanked Mr. Berkowsky for his report.

Those authorized to sign checks are the Mayor, designated members of Township Committee, the Director of Finance, Administrator, Assistant Administrator and Treasurer.

#### Other Funds and Accounts

Payroll account checks which do not require a voucher need only one signature by the Director of Finance, Payroll Clerk or Payroll Supervisor.

WHEREAS, a resolution authorizing this municipality to apply for the 2016 Recycling Tonnage Grant will memorialize the commitment of this municipality to recycling and to indicate the assent of Township Committee of the Township of Cranbury to the efforts undertaken by the municipality and the requirements contained in the Recycling Act and recycling regulations; and

WHEREAS, such a resolution should designate the individual authorized to ensure the application is properly completed and timely filed;

NOW THEREFORE BE IT RESOLVED by the Township Committee of the Township of Cranbury hereby endorses the submission of the recycling tonnage grant application to the New Jersey Department of Environmental Protection and designates Linda M. Scott, Recycling Coordinator to ensure that the application is properly filed; and

BE IT FURTHER RESOLVED, that the monies received from the recycling tonnage grant be deposited in a dedicated recycling trust fund to be used solely for the purposes of recycling.
