Fire Company:

Chief Charles Smith gave the monthly Fire Company report. Chief Smith reported on July and August responses: 56 total calls, 23 alarms, 9 assists to NJ Turnpike, 7 vehicle fires, 6 tractor trailer crashes, 1 double-decker bus crash, 2 rescues, 3 gas leaks, 6 mulch fires, 2 wires down, 11 mutual aid assistance. Year to date totals are 725 calls, 520 during the day, 205 at night and 113 first aid calls. The average response time is 7 minutes and 45 seconds which includes mutual aid. Chief Smith reported the County average is 13 minutes. Chief Smith confirmed the number of calls is on par with last year's calls.

Additionally, Chief Smith requested the Township Committee to budget for improvements to the firehouse for next year. Mayor Rogers and Chief Smith agreed to communicate and begin a preliminary list of requested improvements. (Chief Smith left the meeting at 7:56 p.m.)

ORDINANCE # 08-22-08

AN ORDINANCE OF THE TOWNSHIP OF CRANBURY, MIDDLESEX COUNTY, NEW JERSEY, APPROVING THE TRAFFIC SIGNAL IMPROVEMENTS FOR STATION ROAD AND HIGHTSTOWN-CRANBURY STATION ROAD

WHEREAS, the Township Committee of the Township of Cranbury, Middlesex County, New Jersey, finds it in the interest of public safety to install a Traffic Signal at the intersection of Station Road and Hightstown-Cranbury Station Road; and

WHEREAS, the County of Middlesex, the Township of Cranbury and Cranbury Brickyard, LLC entered into a Tri-Party Agreement on March 28, 2016, and recorded with the Middlesex County Clerk on June 7, 2016, concerning the Traffic Signal and setting forth each parties' duties and obligations with regard to the Traffic Signal; and

WHEREAS, the Township Engineer has submitted and certified all of the legislative requirements pursuant to N.J.S.A. 39:4 and N.J.A.C. 16:27; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, Middlesex County, New Jersey, as follows:

- 1. That the intersection of Station Road and Hightstown-Cranbury Station Road shall be controlled by a Traffic Signal in accordance with the Tri-Party Agreement entered into on March 28, 2016, and recorded on June 7, 2016, and the As-Built Traffic Signal Plan last revised May 1, 2020 and Timing Directive dated January 15, 2018, both prepared by Langan Engineering; and
- 2. That the Traffic Control Signal shall be in accordance with the provisions of the Manual on Uniform Traffic Control Devices, Title 39 of the Revised Statutes and the New Jersey Administrative Code, and shall be operated in conformance with the designated plans; and
- 3. If any article, section, subsection, sentence, clause or phrase of this Ordinance is, for any reason, held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance and they shall remain in full force and effect, and to this end the provisions of this Ordinance hereby declared severable; and
- 4. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed, to the extent of such conflict or inconsistency. In the event of any inconsistencies between the provisions of this Ordinance and any prior ordinance of the Township, the provisions hereof shall be determined to govern. All other parts, portions and provisions of the ordinances of the Township are hereby ratified and confirmed, except where inconsistent with the terms hereof.

This Ordinance shall take effect immediately upon second reading, final passage and publication as require by law.

Section 3. The capital budget of the Township of Cranbury is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith.
