The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Susan Goetz, Glenn Johnson, Dan Mulligan, and Mayor Dave Cook. Mr. Jay Taylor was absent. Also present were Denise Marabello, Township Administrator/Director of Finance; and Jean Golisano, Deputy Clerk. # Reports and Communications

--Mayor Cook

Mayor Cook appointed Mr. Adam Knierim as Second Alternate to the Parks Commission with a term expiring December 31, 2017.

Mayor Cook provided updates on the coordination of efforts with Middlesex County and the NJ DOT concerning the Route 130 Circle and the possibility of having the issues addressed at the same time the Millstone River Bridge repairs are being done, possibly in the next two (2) to three (3) years.

--Members of Committee

#### --Mr. Johnson

Mr. Johnson stated he received a question concerning Gil & Bert's closing hours. There was discussion about the Gil & Bert's hours being established by the Planning Board. The Township Committee agreed the hours (or change thereof) were a Planning Board, not Township Committee, decision. If Gil & Bert's would like to change their hours, the Township Committee stated they would have to go back to the Planning Board.

Mr. Johnson inquired about the security alarm going off in Town Hall over the weekend, and Ms. Marabello stated there have been problems with the system and stated Vector Security is coming out tomorrow to look at the system. She stated Verizon was out today checking the phone lines and the problem is with Vector.

# --Ms. Goetz

Ms. Goetz reported she attended the Environmental Commission Meeting. She stated last year the Daisy Scouts had planted a pollinator garden in the Nature Preserve. It was thought the plants died because of last year's drought; however, the plants came back. The Daisy Scouts are now planting 50 milkweed plants, which will attract the Monarch butterfly. She stated the Monarch butterfly, which is being threatened, feeds on the milkweed.

- --Ms. Goetz (cont'd.)

Ms. Goetz provided an update on the Spring Stream Cleanup stating 73 volunteers collected 60 trash bags (490 pounds). She stated most of the trash picked up was cigarette butts, and with the new Board of Health Ordinance prohibiting smoking in the parks, that may decrease in the future.

Ms. Goetz reported Cranbury is a Sustainable New Jersey Community and she stated there is also a Sustainable New Jersey School Program, which the EC is working on with Cranbury School. She reported there is a "green" group within the School and their application is being submitted this week for a Sustainable New Jersey School.

Ms. Goetz reported the Lake was drained three (3) years ago and she is receiving comments that the fishing is terrific.

She reported she attended an HPC Meeting where three (3) minor applications were addressed. Ms. Goetz reported HPC received a certificate from the Department of Interior. She stated the National Historic Preservation Act of 1966 is now 50 years old, and Cranbury Township has been a certified local government community since January 2009.

Ms. Goetz reported HPC is conducting a survey on homes within the historic district from a 2016 grant funding from the Federal Government. The survey information must be submitted by the deadline date of September 15<sup>th</sup>. HPC will attend a meeting in September to update the Township Committee.

#### --Mr. Mulligan

Mr. Mulligan reported the Library has gone out to bid for the new Library, which will allow the Township Committee to see if the funds are sufficient to start construction. The bid opening is scheduled for the end of July.

Mr. Mulligan thanked Mayor Cook for hosting a meeting with Keep Middlesex Moving (KMM), which he attended with Ms. Marabello, Chief Rickey Varga, and Mayor Cook. Mr. Mulligan stated the meeting was very productive, and he proposed that the theme for the Cranbury Day Township Committee table be focused on safe walking and safe biking. There was discussion concerning implementing safety programs that make sense for Cranbury. Mayor Cook stated distracted driving would also be addressed.

Mr. Mulligan agreed the fishing conditions at the Lake are favorable as his son has had great luck fishing.
