The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Susan Goetz, Glenn Johnson, Dan Mulligan, Jay Taylor and Mayor Dave Cook. Also present were Denise Marabello, Township Administrator/Director of Finance; and Kathleen Cunningham, Municipal Clerk/Assistant Administrator. Mayor Cook led in the salute to the flag, and Ms. Cunningham gave the following Open Public Meetings Act statement:

Township Committee Minutes of September 25, 2017

On motion by Mr. Taylor, seconded by Mr. Johnson and unanimously carried (with Messrs. Cook and Mulligan abstaining due to absence), the Township Committee Minutes of September 25, 2017 were adopted.

#### Reports and Communications

--Mayor

Mayor Cook reported he will be having a meeting tomorrow to discuss the upcoming "Local Freight Impact Fund" grant. Mayor Cook stated he hopes this could be used for Brickyard Road should the Township be awarded the grant.

#### **Reports and Communications**

--Members of Committee

Mr. Johnson – Mr. Johnson reported he had attended meetings of the Board of Health and Library Facilities' Committee. He also attended a Development Review Committee meeting at which "Italian Touch" restaurant discussed plans for the expansion of their building. Mr. Johnson also attended a Planning Board meeting at which plans for the Alfieri Half Acre Road Project were discussed.

Mr. Johnson reported he recently wrote a letter to the United State Postal Service, South Jersey District Office regarding having a mailbox moved from in front of the Post Office to a raised island on Park Place West. He has not received a response and wanted to make sure the Township Committee still wants this done before he writes another letter as the Township would pick up two (2) parking places on North Main Street, it would probably lose five (5) head-in parking places on Park Place West. The Township Committee members unanimously agreed to have Mr. Johnson pursue this.

Mr. Taylor – Mr. Taylor reported there have been discussions taking place by the Princeton Board of Education concerning continuing to allow the Cranbury students to attend. Mr. Taylor indicated the Princeton School District receives quite a lot of money from the Cranbury School to send students to the High School.

Mr. Johnson added, in his opinion, it is very unlikely that Cranbury's sending arrangement with the High School will end. The State does not want a community to be left without access to a high school, and for that reason the process for ending such a relationship is long and involved. Mr. Johnson stated in order for a

sending arrangement to terminate, the sending district must be able to make a sending arrangement with another school district of equal quality to the one that is leaving. Cranbury pays approximately \$5 million per year to Princeton to educate its high school students. The Princeton School Board pays more than \$5 million per year to a charter school that operates in Princeton. Further, the Cranbury School's Board Liaison to the Princeton School Board has discussed this many times, and believes our sending arrangement will continue.

Mr. Mulligan – Mr. Mulligan suggested the Township Committee have a work session with Mr. Tom Weidner, Chairman of the Parks Commission concerning the fencing in Village Park. The fencing either needs to be replaced or torn down and residents should be able to weigh in that live adjacent to it. Mr. Mulligan offered to reach out to Mr. Weidner.

Mr. Mulligan also reported new signs are done for Heritage Park and Parks would like to get similar signs for Village and Barn Park. Mr. Taylor recommended consulting with the Historical Society to make sure the Barn Park sign meets with their approval.

Ms. Goetz – Ms. Goetz reported she had moderated a "Town Hall Meeting" with the Democratic candidates for State Office, Senator Linda Greenstein, Assemblymen Wayne DeAngelo and Dan Benson. The group that sponsored the event is "Blue Forty". Approximately 60 people attended and it was held at St. David's Church, South Main Street. It was open for all towns in the 14<sup>th</sup> Legislative District. The Group is organizing having this event in each of the 40 legislative districts throughout the State.

Report (Update) by Mr. Mark Berkowsky, Cranbury Housing Associates on "Applewood Court."

Mr. Berkowsky reported on the status of Applewood Court. The parents have already been taking their children to The Cranbury School and once they move in, the children will be walking to school. He also reported 50% of the units have been leased and the Project is on budget. Mr. Berkowsky stated any additional monies will be used for landscaping on the south side of the Development. He plans on completion taking place in December with full occupancy by January.

Mr. Mulligan thanked Mr. Berkowsky and expressed the Township's gratitude for him moving so quickly on its affordable housing requirements in conjunction with the Court Order.

WHEREAS, N.J.A.C. 5:70-2.3 requires a certificate of smoke detector and carbon monoxide alarm compliance be issued prior to the change of occupant; and

WHEREAS, the Township of Cranbury Code Chapter 84 entitled Fire Prevention section 84-19 addresses the provisions for all of these fees; and

WHEREAS, the State of New Jersey has recently increased all of these fees by 29%; and

WHEREAS, the Fire Official recommends the Township of Cranbury increase their fees to reflect the State of New Jersey fees.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Cranbury, Middlesex County, New Jersey, as follows:

SECTION 1. The recitals contained in the foregoing preamble are incorporated herein as if fully restated.

Section 84-19 of the Code of the Township of Cranbury ("Code"), entitled "Fees," is hereby amended and shall read as follows (additions are <u>underlined</u>; deletions are in [brackets]:

#### § 84-19. Fees.

- B. In addition to the above, the fee for fire inspections of non-life hazard uses shall be as follows:
  - (1) Single occupancy under 1,000 square feet: [\$45] <u>\$58</u>.

- (2) Single occupancy 1,001 to 2,000 square feet: [\$70] <u>\$90</u>.
- (3) Single occupancy 2,001 to 3,000 square feet: [\$95] <u>\$122</u>.
- (4) Single occupancy 3,001 to 4,000 square feet: [\$120] <u>\$154</u>.
- (5) Single occupancy 4,001 to 10,000 square feet; [\$160] <u>\$206</u>.
- (6) Single occupancy 10,001 to 20,000 square feet; [\$210] <u>\$270</u>.
- (7) Single occupancy 20,001 to 50,000 square feet; [\$360] <u>\$464</u>.
- (8) Each additional 10,000 feet in excess of 50,000 square feet; [\$35] <u>\$45</u>.
- C. Notwithstanding Subsection A of this section, the application fee for a certificate of smoke detector and carbon monoxide alarm compliance (CSDCMAC), as required by N.J.A.C. 5:70-2.3, as said provision may from time to time be amended, shall be as follows:
  - (2) Requests for a CSDCMAC received four to ten business days prior to the change of occupant: [\$70] <u>\$90</u>; and
  - (3) Requests for a CSDCMAC received fewer than four business days prior to the change of occupant: [\$125] <u>\$161</u>.
- D. Permit fees shall be as follows:
  - (1) Type 1: \$54.
  - (2) Type 2: \$214.
  - (3) Type 3: \$427.
  - (4) Type 4: \$641.

SECTION 2. Repealer. All ordinances and resolutions, or parts thereof, inconsistent with this Ordinance, are hereby repealed.

SECTION 3. Severability. If any section, paragraph, subsection, clause or provision of this Ordinance shall be adjudged to be invalid, such adjudication shall apply only to the section, paragraph, subsection, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

SECTION 4. Effective Date. This Ordinance shall take effect immediately upon its passage and publication, as required by law.
