The Township Committee Meeting of the Township of Cranbury was held at 7:00 p.m. in the Town Hall Meeting Room. Answering present to the roll call were Township Committee members: Susan Goetz, Glenn Johnson, Jay Taylor and Mayor Dave Cook. Mr. Dan Mulligan was absent. Also present were Michael Herbert, Esq., Township Attorney; Denise Marabello, Township Administrator/Director of Finance; and Kathleen Cunningham, Municipal Clerk/Assistant Administrator. Mayor Cook led in the salute to the flag, and Ms. Cunningham gave the following Open Public Meetings Act statement:

Presentation of Letters of Recognition to Benjamin Cier and Hunter Pormilli for obtaining their Eagle Scout Awards

Mayor Cook presented Letters of Recognition to two (2) Boy Scouts for obtaining their Eagle Scout Awards. Mayor Cook stated Mr. Cier's project was to build a trash enclosure with a gate behind the Presbyterian Church Office. He also removed mulch, plantings and shrubs in front of the Church Office and improved the landscaping with brick edging for the flower beds. The Project benefitted the Church in both safety and beautification. Mayor Cook gave some background on Ben's time in scouting. Mayor Cook then acknowledged Mr. Pormilli's project, which was a 1-1/2 mile trail blazed and constructed to give the community a recreational trail for public access along Old Cranbury Road. The trail was cleared by the river and through the woods. Garbage was cleared; underbrush and dead branches and large vines were also cleared. Fallen branches were used to outline the cleared trail and the trail was blazed with yellow squares to identify the route of the trail, now called the Pin Oaks Loop Trail. Mayor Cook stated Mr. Pormilli worked with the Environmental Commission to plan the trail, bought the supplies and led the work of constructing the trail. Mayor Cook presented the Letters of Recognition to both Scouts and congratulated them on their Projects.

Mayor Cook reported to the public that the Township Committee has worked over the last few years with the Department of Transportation. He reported the Township is trying to have the Route 130 Circle addressed as well as a reclassification of Route 130 to allow for additional businesses that have

approved for that corridor. In addition, Mayor Cook reported the Township is submitting for RFPs for monies that will be made available by the DOT through a grant program (a disbursement of the \$0.23/gallon gas tax monies). The first grant is for \$30 million, and Cranbury Township is submitting an RFP for funds to repair Brickyard Road, a "freight zone" and warehouse area, which is what the grant addresses. The RFPs must be submitted by December 17th. Mayor Cook reported a meeting was held with the Township's consultants and engineer to discuss the grant. He reported a meeting with the DOT was also held earlier today to discuss the Route 130 Circle and the reclassification of Route 130. Mayor Cook stated Cranbury is on DOT's radar for projects.

Mr. Taylor – Mr. Taylor reported he had no updates this evening.

Ms. Goetz – Ms. Goetz reported she also had no updates.

Mr. Johnson – Mr. Johnson reported he attended Candidates' Night, which was sponsored by the Cranbury Woman's Club. He stated the forum was held in the School's Large Group Room, instead of the School Cafeteria, which was much more comfortable. He stated the turnout was much larger than it had been in recent years and he hopes that trend continues.

Mr. Michael Kervan, Chief of the Cranbury Volunteer Fire Company, gave his report, as follows: 342 total calls for the year and 2,438.5 volunteer hours. Since the end of July, Chief Kervan reported there were two (2) structure fires in East Windsor; one (1) in Plainsboro; one (1) in Hightstown; four (4) vehicle fires and one (1) elevator rescue. Chief Kervan reported the Fire Company held an Open House, which was very well attended. He reported they did fire prevention for both the Cranbury Presbyterian Nursery School and the Cranbury Elementary School. He reported this week their annual fund drive will begin. As compared to last year, the number of calls has decreased and will probably be less than last year due to a reduction in the mutual aid responses. Chief Kervan reported there was a call at Applewood Court earlier in the day. Ms. Goetz inquired if there was a problem accessing the site. Chief Kervan stated initially there was a problem due to an island being placed in the middle of the entrance, making it impossible for the fire trucks to make the turn. He stated he had not been back out to the site; however, he understands the island has been made "mountable" so the trucks can drive over it. Ms. Marabello confirmed that the paving will need to be raised up even more to make the island mountable. She advised in the future that more detailed site plans with dimensions be obtained to be sure the trucks have access to a site. Chief Kervan stated the Fire Company gives the sizes of their trucks and relies on feedback from the engineer that the trucks can access the site. Chief Kervan stated center islands will either need to be painted or flush with the roadway. Chief Kervan stated the Fire Company has worked with the Planning Board and Shade Tree concerning construction and trees allowing truck access to a site. Chief Kervan stated he believes in the future the Fire Company will be recommending islands not be included in site plans.

WHEREAS, the legislation would expand the Open Public Meeting Act to create impractical and burdensome requirements with respect to subcommittees and working groups established by the entire governing body, which would effectively limit the ability of small groups of local officials discussing issues of public concern for the purposes of informing the governing body; and

WHEREAS, under the bills, the responsibilities of municipal clerks, who the Legislature has already loaded with responsibilities beyond the scope of their office, would be stretched even further than current law requires without a single dollar of additional resources provided to, or authorized to be collected by, municipalities; and

WHEREAS, the bills would impose a financial burden on municipalities that would not be offset by a revenue source other than the property tax, making the bills unfunded mandates prohibited by the New Jersey Constitution; and

WHEREAS, some municipalities are more equipped than others to meet the burdens that would be imposed by Senate Bill Nos. 1045 and 1046, however, without assistance of any kind from the States or the courts, every municipality would be on its own to meet the myriad new requirements of the law;

WHEREAS, Cranbury Township supports this financing for capital projects at public libraries around the State of New Jersey,

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Township Committee of Cranbury that it does express and hereby affirm its support of Public Question 1 and urges its passage.

a) Discussion of Proposed Noise Ordinance Amendment

Township Committeeman Glenn Johnson led a discussion on proposed amendments to the Township's current Noise Ordinance. He reported the current Noise Ordinance does not provide a means to file a complaint about a noise that originates from a residential property, only from commercial properties. There was discussion about the Model Noise Ordinance, issued by Rutgers and the DEP, which has pre-approved language for the State of New Jersey. Mr. Herbert further explained the Township's Code Chapter 110: "Peace and Good Order," and Chapter 160: "Noise Control" and described the noises prohibited between restricted hours. He reported there are exemptions for farm equipment. He stated the current Noise Ordinance would be replaced with the Model Ordinance and the positions of a Noise Control Officer (NCO) and Noise Control Investigator would have to be created. The new Ordinance would not only apply to industrial and commercial properties, it would also apply to residential properties and multiuse buildings. The Enforcement Officer would have the authority to measure noise by the use of an instrument that the Township would have to purchase. Mr. Herbert stated there is currently the ability to file an action in Municipal Court to enforce what is on the books now. He stated the action typically goes to mediation where the two (2) parties can come to an agreement to abate

a) Discussion of Proposed Noise Ordinance Amendment (cont'd) the nuisance. Mr. Herbert stated the Model Ordinance gives the Judge more science to work with. There was additional discussion about decibel levels and noise nuisances. Mr. Herbert stress the NCO would have to be trained on the equipment. Mr. Herbert stated it is an "all or nothing Ordinance" which would have to be adopted as written. If parts are taken from the Model Ordinance and inserted into the Cranbury Ordinance, the new modified Ordinance would have to get DEP approval before being adopted by the Township. Currently the Health Officer is the Enforcing Officer in Cranbury; however, Ms. Marabello stated the Health Officer is from the County, is not trained on the equipment and is not always available to the Township. Mayor Cook suggested looking at other municipalities to determine how their noise ordinances are worded. Ms. Marabello stated there is perhaps one (1) noise complaint a year in the Township. Ms. Goetz inquired if Cranbury can amend its Ordinance, and Mr. Herbert stated the Township would have to get it approved by the DEP. The item will be revisited as a follow up item.

Public Comment

Mayor Cook opened the meeting to public comment.

Mr. and Mrs. Zuczek, Wyckoffs Mills Road, addressed the problems they are still having with the Rodeo. Mr. Herbert explained the "Right to Farm Act" which was passed several years ago stated certain farm activities, such as a rodeo, are exempt from local regulations. Mr. Herbert explained a rodeo is a way to show off cattle, horses, etc., or a way to sell equipment. Mrs. Zuczek stated there are no horses on the farm and the rodeo is just a series of concerts, which does not relate at all to agriculture. The Zuczek's sent an email to the Township about Sunday's rodeo, which had close to 1,000 people with cars parking all over the roads. Ms. Marabello stated Cranbury Police ticketed and towed cars. She stated as far as safety is concerned, there were no fights or altercations. Mr. Herbert stated Mr. Steve Goodell is an expert and he will discuss the rodeo with him. Mrs. Zuczek stated there were cars parked on both sides of a narrow street and families were walking down the middle of the street in the dark. Mayor Cook stated the Township will have to look into the "grey areas" of the Ordinance as it applies to the rodeo. He stated before next year's rodeos start, conversations will be held with the Police concerning safety. Mr. Herbert explained the website states the farm rescues horses and the rodeo is an event to raise money for the rescue. Mrs. Zuczek stated they do not rescue horses. Mayor Cook stated the issue will be revisited before next year. Ms. Zuczek stated some of the information on the application is incorrect, such as number of people attending. There was additional discussion about the rodeo not needing a permit from the Township, and that the ABC issued the permit for liquor to be served at a social affairs event. Ms. Cunningham stated the Zoning Officer, Jeff Graydon, approved the rodeo as a valid use at the farm. Mr. Zuczek stated the gentleman who runs the horse auction stopped at their home and confirmed he no longer conducts the horse auction at the farm and is not part of the rodeo. Mayor Cook stated the issue will be revisited

Mr. Scott Collins, Plainsboro Road, requested assistance from the Township Committee concerning noise from the neighbor's house. He stated he and his family are submitted to a noise from a radon fan, which is above 60 decibels. He stated his family can hear the noise, which is multiple pitches, from inside their home as well as from every part of their property. He stated he first tried to work with the neighbor in 2014 and

also offered to pay for the repair. The neighbor stated it is a design fault in the system which causes it to be loud. Mr. Collins stated he had a company come out to do a study. He stated the noise never stops and he stated he does not need an Ordinance to know it is rude to have that noise. Mr. Herbert asked if he had considered filing a nuisance complaint in Court, and Mr. Collins replied he had not. Mr. Herbert recommended going to Court so the matter can be remediated. Mr. Collins stated he would be amenable to it. He stated he came to the meeting because he saw Noise Ordinance was on the Agenda to be discussed. Mr. Herbert stated the current Noise Ordinance would not help Mr. Collins and the quicker route would be to go to Court.

Ms. Elizabeth Silverman & Mr. Steve Silverman, North Main Street, discussed with the Township Committee the "Christmas Spectacular" already being set up on Main Street. Ms. Silverman stated she finds it hard to believe that the Township cannot address the light show and the crowds it brings to the Township. She stated all of North Main Street looks trashy with cones, fencing, tarp-covered bales of hay and people walking on the lawns for a two-month period. Ms. Silverman passed around photos of North Main Street that were taken last November 2nd and how the area looks for over two (2) months. She stated today there was a cherry picker parked on the sidewalk and the strobe lights and lights on the roof are already installed. Ms. Marabello stated we cannot stop when the resident installs the lights as it is private property. There was discussion about how restrictions could be placed on the amount of time fencing can be left up. Mr. Taylor stated fencing for construction sometimes must be left up for a long period of time for safety reasons. Ms. Silverman stated the lights have to stop at 10 p.m.; however, it is what the neighborhood looks like even before the show starts. She stated there are parking issues, and while the neighborhood is grateful to Cranbury Police for putting up "no parking" signs and the cones, the area looks awful. Mr. Taylor stated the scale of the show has also grown significantly since the light show went before the Zoning Board.

Mr. Silverman stated he likes the lights; however, he feels it is not a very neighborly thing to do. He stated they live down the street, and people cannot park in front of their home because of the cones. However, the flashing light show directly impacts the neighbors directly across the street. He stated if the purpose of the display is to bring joy to people and raise money for charity, it is at the same time ruining the neighbors' lives for a few months. Mr. Reinhardt, a life-long resident, offered his farm for the light show, and Mr. Shaw declined. Mr. Silverman made the offer that if the show is moved to the farm; he will match whatever monies Mr. Shaw collects, up to \$15,000, with the monies going to the Trenton Soup Kitchen or Cranbury Food Pantry. He stated this is an opportunity for Mr. Shaw to double his donations. Mayor Cook stated he would have the Zoning Officer, Jeff Graydon, go back out to look at the scale of the light show, and if too big, look at reducing the size of it. Ms. Silverman inquired about the definition of "temporary." Mr. Silverman stated Cranbury is a neighborly town where people treat each other right. He requested that something be done to help the neighbors. Mayor Cook stated it really does impact more than the neighbors.

Mr. Richard Kallan, Wynnewood Drive, stated the Township has an Ordinance for noise pollution and inquired about something for light pollution. Mr. Herbert stated there regulations about light leaving a property and that it should be contained, which is something addressed in Planning Board applications.

The Silverman's thanked the Township Committee for their attention to the matter.

There being no further comments, Mayor Cook closed the public comment portion of the meeting.
